DEFECT MEASURES OF EIGENFUNCTIONS WITH MAXIMAL L^{∞} GROWTH

ABSTRACT. — We characterize the defect measures of sequences of Laplace eigenfunctions with maximal L^{∞} growth. As a consequence, we obtain new proofs of results on the geometry of manifolds with maximal eigenfunction growth obtained by Sogge–Toth–Zelditch, and generalize those of Sogge–Zelditch to the smooth setting. We also obtain explicit geometric dependence on the constant in Hörmander's L^{∞} bound for high energy eigenfunctions, improving on estimates of Donnelly.

RÉSUMÉ. — Nous caractérisons les mesures de défauts de séquences de fonctions propres de Laplace avec croissance L^{∞} maximale. En conséquence, nous obtenons des nouvelles preuves de résultats sur la géométrie des variétés avec une croissance des fonctions propres maximale obtenus par Sogge–Toth–Zelditch, et nous généralisons ceux de Sogge–Zelditch au cas lisse. Nous obtenons également une dépendance géométrique explicite de la constante de Hörmander L^{∞} liée aux functions propres de haute énergie, améliorant les estimations de Donnelly.

1. Introduction

Let (M, g) be a C^{∞} compact manifold of dimension n without boundary. Consider the solutions to

(1.1)
$$(-\Delta_g - \lambda_j^2) u_{\lambda_j} = 0, \qquad \|u_{\lambda_j}\|_{L^2} = 1$$

as $\lambda_j \to \infty$. It is well known [1, 11, 14] (see also [25, Chapter 7]) that solutions to (1.1) satisfy

(1.2)
$$\|u_{\lambda_j}\|_{L^{\infty}(M)} \leqslant C \lambda_j^{\frac{n-1}{2}}$$

Keywords: eigenfunctions, defect measures, sup-norms.

and that this bound is saturated e.g. on the sphere. Estimates for L^p norms of eigenfunctions improving on those given by interpolation between (1.2) and $||u_{\lambda_j}||_{L^2} = 1$ have been available since the seminal work of Sogge [16]. Since there are examples where these estimates are sharp, it is natural to consider situations which produce sharp examples for (1.2). Previous works [2, 12, 19, 20, 21, 22, 23, 24] have studied the connections between growth of L^{∞} norms of eigenfunctions and the global geometry of the manifold M. The works of Sogge [18] and Blair–Sogge [4, 5] study similar questions for low L^p norms.

In this article, we study the relationship between L^{∞} growth and L^2 concentration of eigenfunctions (this direction of inquiry was initiated in [9]). We measure L^2 concentration of eigenfunctions using defect measures, a sequence $\{u_{h_j}\}$ has defect measure μ if for any $a \in C_c^{\infty}(T^*M)$,

(1.3)
$$\langle a(x,h_jD)u_{h_j},u_{h_j}\rangle \to \int_{T^*M} a(x,\xi)\mathrm{d}\mu$$

We write a(x, hD) for a semiclassical pseudodifferential operator given by the quantization of the symbol $a(x,\xi)$ (see [25, Chapters 4, 14]) and let $h_j = \lambda_i^{-1}$ when considering the solutions to (1.1).

By an elementary compactness/diagonalization argument it follows that any L^2 bounded sequence u_h possesses a further subsequence that has a defect measure in the sense of (1.3) [25, Theorem 5.2]. Moreover, a standard commutator argument shows that if

$$p(x,hD)u = o_{L^2}(h),$$

for $p \in S^k(T^*M)$ real valued with

$$|p| \ge c \langle \xi \rangle^k$$
 on $|\xi| \ge R$,

then μ is supported on $\Sigma := \{p = 0\}$ and is invariant under the bicharacteristic flow of p; that is, if $G_t = \exp(tH_p) : \Sigma \to \Sigma$ is the bicharacteristic flow, $(G_t)_*\mu = \mu, \forall t \in \mathbb{R}$ [25, Theorems 5.3, 5.4].

Remark 1.1. — We will usually write $G_t(q)$ for the bicharacteristic flow applied to a point $q \in T^*M$. However, it will sometimes be useful distinguish between the position and momentum of q and in these cases we will write $q = (x, \xi)$ and write $G_t(x, \xi)$ for the bicharacteristic flow applied to $(x, \xi) \in T^*M$.

Rather than studying only eigenfunctions of the Laplacian, we replace $-\Delta_g - \lambda_i^2$ by a general semiclassical pseudodifferential operator and replace

eigenfunctions with quasimodes. To this end, we say that u is compactly microlocalized if there exists $\chi \in C_c^{\infty}(\mathbb{R})$ with

$$Op_h(1 - \chi(|\xi|))u = O_{\mathcal{S}}(h^{\infty} ||u||_{L^2(M)})$$

where Op_h is a quantization procedure giving pseudoifferential operators on M (see e.g. [8, Appendix E], see also Appendix A). For $P \in \Psi^m(M)$ i.e. an *h*-pseudodifferential operator of order m, we say that u is a quasimode for P if

$$Pu = o_{L^2}(h), \qquad ||u||_{L^2} = 1.$$

Remark 1.2. — Although u implicitly depends on h, we suppress this in our notation to avoid overburdening the writing.

For $x_0 \in M$, let $\Sigma_{x_0} := \Sigma \cap T^*_{x_0}M$ and define respectively the flow out of Σ_{x_0} and time T flowout of Σ_{x_0} by

$$\Lambda_{x_0} := \bigcup_{T=0}^{\infty} \Lambda_{x_0,T}, \qquad \Lambda_{x_0,T} := \bigcup_{t=-T}^{T} G_t(\Sigma_{x_0}).$$

Remark 1.3. — Note that in the case that $P = -h^2 \Delta_g - 1$, $\Sigma = S^*M$ and $\Sigma_{x_0} = S^*_{x_0}M$.

Let \mathcal{H}^r denote the Hausdorff-r measure with respect to the Sasaki metric on T^*M or more precisely the metric induced on T^*M by pulling back the Sasaki metric on TM (see for example [3, Chapter 9] for a treatment of the Sasaki metric). Note that we choose to use the Sasaki metric on T^*M induced by the metric on M for concreteness, but any other metric on T^*M will work equally well for our purposes. For a Borel measure ρ on T^*M , let $\rho_{x_0} := \rho|_{\Lambda_{x_0}}$ i.e. $\rho_{x_0}(A) := \rho(A \cap \Lambda_{x_0})$. Recall that two Borel measures on a set Ω , μ and ρ , are mutually singular (written $\mu \perp \rho$) if there exist disjoint sets $N, P \subset \Omega$ so that $\Omega = N \cup P$ and $\mu(N) = \rho(P) = 0$.

The main theorem characterizes the defect measures of quasimodes with maximal growth.

THEOREM 1.4. — Let $P \in \Psi^m(M)$ be an *h*-pseudodifferential operator with real principal symbol *p* satisfying

(1.4)
$$\partial_{\xi} p \neq 0 \text{ on } \{p=0\}.$$

Suppose u is a compactly microlocalized quasimode for P with

(1.5)
$$\limsup_{h \to 0} h^{\frac{n-1}{2}} \|u\|_{L^{\infty}} > 0$$

and defect measure μ . Then there exists $x_0 \in M$ and $x(h) \to x_0$ so that

(1.6)
$$\limsup_{h \to 0} h^{\frac{n-1}{2}} |u(x(h))| > 0, \qquad \mu_{x_0} = \rho_{x_0} + f \mathrm{d} \mathcal{H}_{x_0}^n.$$

where $0 \neq f \in L^1(\Lambda_{x_0}, \mathcal{H}_{x_0}^n)$, $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$, and both $f d\mathcal{H}_{x_0}^n$, and ρ_{x_0} are invariant under G_t .

One way of interpreting Theorem 1.4 is that a quasimode with maximal L^{∞} growth near x_0 must have energy on a positive measure set of directions entering $T^*_{x_0}M$. That is, it must have concentration comparable to that of the zonal harmonic. (See [9, Section 4] for a description of the defect measure of the zonal harmonic.)

Theorem 1.4 is an easy consequence of the following theorem (see section 2 for the proof that Theorem 1.5 implies Theorem 1.4).

THEOREM 1.5. — Let $x_0 \in M$ and $P \in \Psi^m(M)$ be an h-pseudodifferential operator with real principal symbol p satisfying

$$\partial_{\xi} p \neq 0 \text{ on } \{p=0\}.$$

There exists a constant C_n depending only on n with the following property: Suppose that u is compactly microlocalized quasimode for P and has defect measure μ . Define $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$ and $f \in L^1(\Lambda_{x_0}; \mathcal{H}_{x_0}^n)$ by

$$\mu_{x_0} =: \rho_{x_0} + f \mathrm{d} \mathcal{H}_{x_0}^n.$$

Then for all r(h) = o(1),

$$\limsup_{h \to 0} h^{\frac{n-1}{2}} \|u\|_{L^{\infty}(B(x_0, r(h)))} \leqslant C_n \int_{\Sigma_{x_0}} \sqrt{f} \sqrt{\frac{|\nu(H_p)|}{|\partial_{\xi} p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}$$

where ν is a unit (with respect to the Sasaki metric) conormal to Σ_{x_0} in Λ_{x_0} , $\operatorname{vol}_{\Sigma_{x_0}}$ is the measure induced by the Sasaki metric on T^*M , and $|\partial_{\xi}p|_g = |\partial_{\xi}p \cdot \partial_x|_g$. Furthermore, $f d\mathcal{H}_{x_0}^n$ is G_t invariant.

In particular, if $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$, then

$$||u||_{L^{\infty}(B(x_0,r(h)))} = o(h^{\frac{1-n}{2}}).$$

Remark 1.6.

(1) We may assume without loss of generality that Σ is compact. This follows from the fact that u is compactly microlocalized. In particular, let $\chi \in C_c^{\infty}(\mathbb{R})$ have $Op_h(1 - \chi(|\xi|))u = O_S(h^{\infty})$. Then u is a quasimode for $\tilde{P} = P + NOp_h(\langle \xi \rangle^m)Op_h(1 - \chi(|\xi|))$ and for Nlarge enough, { $\tilde{p} = 0$ } is compact. Therefore, we may work with \tilde{p} rather than p. This furthermore implies that we may assume Σ_{x_0} is a manifold since $\partial_{\xi}p \neq 0$ on Σ .

- (2) Note that ∂_ξp · ∂_x = dπH_p where π : T*M → M is the natural projection map. Therefore, ∂_ξp · ∂_x is a well defined invariant vector field. The appearance of this factor in Theorem 1.5 quantifies the fact that bicharacteristics of H_p are not tangent to vertical fibers. It is precisely the tangency of these bicharacteristics which causes a change of behavior when ∂_ξp = 0.
- (3) Finally, observe that if one fixes geodesic normal coordinates at x_0 , then the Sasaki metric on $T^*_{x_0}M$ is equal to the Euclidean metric and hence, in these coordinates, $d \operatorname{vol}_{\Sigma_{x_0}}$ is the volume induced by the Euclidean metric.

To see that Theorem 1.5 applies to solutions of (1.1), let $h_j = \lambda_j^{-1}$. Writing $u = u_{\lambda_j}$ and $h = h_j$,

$$(-h^2\Delta_g - 1)u = 0.$$

Then, $(-h^2\Delta_g - 1) = p(x, hD)$ with $p = |\xi|_g^2 - 1 + hr$ and therefore, the elliptic parametrix construction shows that u is compactly microlocalized. Since $\partial_{\xi_j} p = 2g^{ij}\xi_i, \partial_{\xi}p \neq 0$ on p = 0 and Theorem 1.5 applies. In Section 2, we use Theorem 1.5 with $P = -h^2\Delta_g - 1$ to give explicit bounds on the constant C in (1.2) in terms of the *injectivity radius of* M, inj(M), thereby improving on the bounds of [7] at high energies.

COROLLARY 1.7. — There exists $\widetilde{C}_n > 0$ depending only on n so that for all (M,g) compact, boundaryless Riemannian manifolds of dimension n and all $\varepsilon > 0$, there exists $\lambda_0 = \lambda_0(\varepsilon, M, g) > 0$ so that for $\lambda_j > \lambda_0$ and u_{λ_j} solving (1.1)

$$\|u_{\lambda_j}\|_{L^{\infty}} \leqslant \left(\frac{\widetilde{C}_n}{\operatorname{inj}(M)^{1/2}} + \varepsilon\right) \lambda_j^{\frac{n-1}{2}}.$$

Theorem 1.5 is sharp in the following sense. Let $P = -h^2 \Delta_g - 1$ and G_t as above.

THEOREM 1.8. — Suppose there exists $z_0 \in M$, T > 0 so that $G_T(z_0,\xi) = (z_0,\xi)$ for all $(z_0,\xi) \in S_{z_0}^*M$. Let $\rho_{z_0} \perp \mathcal{H}_{z_0}^n$ be a Radon measure on Λ_{z_0} invariant under G_t and $0 \leq f \in L^1(\Lambda_{z_0}, \mathcal{H}_{z_0}^n)$ be invariant under G_t so that

$$\|f\|_{L^1(\Lambda_{z_0},\mathcal{H}^n_{z_0})} + \rho_{z_0}(\Lambda_{z_0}) = 1.$$

Then there exist $h_j \to 0$ and $\{u_{h_j}\}_{j=1}^{\infty}$ solving

$$(-h_j^2 \Delta_g - 1) u_{h_j} = o(h_j), \qquad \|u_{h_j}\|_{L^2} = 1,$$
$$\limsup_{j \to \infty} h_j^{\frac{n-1}{2}} \|u_{h_j}\|_{L^{\infty}} \ge (2\pi)^{\frac{1-n}{2}} \int_{\Sigma_{z_0}} \sqrt{f} \mathrm{d} \operatorname{Vol}_{\Sigma_{z_0}}$$

and having defect measure $\mu = \rho_{z_0} + f \mathrm{d} \operatorname{vol}_{\Lambda_{z_0}}$.

Notice that we do not claim the existence of exact eigenfunctions having prescribed defect measures in Theorem 1.8, instead constructing only quasimodes.

1.1. Relation with previous results

As far as the author is aware, the only previous work giving conditions on the defect measures of eigenfunctions with maximal L^{∞} growth is [9]. Theorem 1.5 improves on the conditions given in [9, Theorem 3]; replacing $\mathcal{H}_{x_0}^n(\operatorname{supp} \mu_{x_0}) = 0$ with the sharp condition $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$. To see an example of how these conditions differ, fix $x_0 \in M$ such that every geodesic through x_0 is closed and let $\{\xi_k\}_{k=1}^{\infty} \subset S_{x_0}^*M$ be a countable dense subset. Suppose that the defect measure of $\{u_{\lambda_j}\}$ is given by

$$\mu = \sum_{k} a_k \delta_{\gamma_k}, \qquad a_k > 0$$

where γ_k is the geodesic emanating from (x_0, ξ_k) . Then $\operatorname{supp} \mu_{x_0} = \Lambda_{x_0}$, but $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$, so Theorem 1.5 applies to this sequence but the results of [9] do not. Furthermore, Theorem 1.5 gives quantitative estimates on the growth rates of quasimodes in terms of their defect measures.

We are able to draw substantial conclusions about the global geometry of a manifold M having quasimodes with maximal L^{∞} growth from Theorem 1.5. The results of Sogge–Toth–Zelditch [19, Theorems 1(1), 2] and hence also Sogge–Zelditch [20, Theorem 1.1] are corollaries of Thoerem 1.5. For $x_0 \in M$, define the map $T_{x_0} : \Sigma_{x_0} \to \mathbb{R} \sqcup \{\infty\}$ by

(1.7)
$$T_{x_0}(\xi) := \inf\{t > 0 \mid G_t(x_0,\xi) \in \Sigma_{x_0}\}.$$

Then, define the loop set by

$$\mathcal{L}_{x_0} := \{ \xi \in \Sigma_{x_0} \mid T_{x_0}(\xi) < \infty \},\$$

and the first return map $\eta_{x_0} : \mathcal{L}_{x_0} \to \Sigma_{x_0}$ by

$$G_{T_{x_0}(\xi)}(x_0,\xi) = (x_0,\eta_{x_0}(\xi))$$

Finally, define the set of recurrent points by

(1.8)
$$\mathcal{R}_{x_0} := \left\{ \xi \in \Sigma_{x_0} \middle| \begin{array}{c} \xi \in \left(\bigcap_{T>0} \overline{\bigcup_{t>T} G_t(x_0,\xi) \cap \Sigma_{x_0}}\right) \\ \cap \left(\bigcap_{T>0} \overline{\bigcup_{t>T} G_{-t}(x_0,\xi) \cap \Sigma_{x_0}}\right) \end{array} \right\},$$

where the closure is with respect to the subspace topology on Σ_{x_0} .

COROLLARY 1.9. — Let (M, g) be a compact boundaryless Riemannian manifold and P satisfy (1.4). Suppose that $\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0}) = 0$. Then for any r(h) = o(1) and u a compactly microlocalized quasimode for P,

$$||u||_{L^{\infty}(B(x_0,r(h)))} = o(h^{\frac{1-n}{2}}).$$

Moreover, the forward direction of [21, Theorem 1.1] with the analyticity assumption removed is an easy corollary of Theorem 1.5. To state the theorem recall that $d\operatorname{vol}_{\Sigma_{x_0}}$ denote the measure induced on Σ_{x_0} from the Sasaki metric on T^*M . We define the unitary Perron–Frobenius operator $U_{x_0}: L^2(\mathcal{R}_{x_0}, d\operatorname{vol}_{\Sigma_{x_0}}) \to L^2(\mathcal{R}_{x_0}, d\operatorname{vol}_{\Sigma_{x_0}})$ by

(1.9)
$$U_{x_0}(f)(\xi) := \sqrt{J_{x_0}(\xi)} f(\eta_{x_0}(\xi)),$$

where, writing

$$G_t(x_0,\xi) = (x_t(x_0,\xi), \eta_t(x_0,\xi)),$$

we have that

(1.10)
$$J_{x_0}(\xi) = \left|\det D_{\xi} \eta_t \right|_{t=T_{x_0}(\xi)} \left|$$

is the Jacobian factor so that for $f \in L^1(\Sigma_{x_0})$ supported on \mathcal{L}_{x_0} ,

$$\int \eta_{x_0}^* f J_{x_0}(\xi) \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} = \int f(\xi) \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \,.$$

See [15, Section 4] for a more detailed discussion of U_{x_0} . We say that x_0 is dissipative if

(1.11)
$$\left\{ f \in L^2(\mathcal{R}_{x_0}, \operatorname{d} \operatorname{vol}_{\Sigma_{x_0}}) \, \middle| \, U_{x_0}(f) = f \right\} = \{0\}.$$

COROLLARY 1.10. — Let (M, g) be a compact boundaryless Riemannian manifold and P satisfy (1.4). Suppose that x_0 is dissipative. Then for r(h) = o(1) and u a compactly microlocalized quasimode for P,

$$||u||_{L^{\infty}(B(x_0,r(h)))} = o(h^{\frac{1-n}{2}}).$$

The dynamical arguments in [22] show that if (M, g) is a real analytic surface and $P = -h^2 \Delta_g - 1$, then x_0 being non-dissipative implies that x_0 is a periodic point for the geodesic flow, i.e. a point so that there is a T > 0 so that every geodesic starting from $(x_0, \xi) \in S_{x_0}^* M$ smoothly closes at time T.

1.2. Comments on the proof

While the assumption $Pu = o_{L^2}(h)$ implies a global assumption on u, similar to that in [9], the analysis here is entirely local. The global consequences in Corollaries 1.9 and 1.10 follow from dynamical arguments using invariance of defect measures.

We take a different approach from that in [9] choosing to base our method on the Koch–Tataru–Zworski method [13] rather than explicit knowledge of the spectral projector. This approach gives a more explicit explanation for the L^{∞} improvements from defect measures. In Section 4 we sketch the proof of Theorem 1.5 in the case that $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$ using the spectral projector.

The idea behind our proof is to estimate the absolute value of u at x_0 in terms of the degree to which energy concentrates along each bicharacteristic passing through Σ_{x_0} . Either too much localization or too little localization will yield an improvement over the naive bound. By covering Λ_{x_0} with appropriate cutoffs to tubes around bicharacteristics we are then able to give $o(h^{\frac{1-n}{2}})$ bounds whenever $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$. The proof relies, roughly, on the fact that if a compactly microlocalized function u on \mathbb{R}^m has defect measure supported at (y_0, η_0) , then $\|u\|_{L^{\infty}} = o(h^{-m/2})$ rather than the standard estimate $O(h^{-m/2})$.

2. Consequences of Theorem 1.5

We first formulate a local result matching those in [19, 20] more closely.

COROLLARY 2.1. — Let $x_0 \in M$ and $P \in \Psi^m(M)$ satisfying the assumption of Theorem 1.5. Then there exists a constant C_n depending only on n with the following property. Suppose that u is a compactly microlocalized quasimode for P, and has defect measure μ . Define $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$ and $f \in L^1(\Lambda_{x_0}; \mathcal{H}_{x_0}^n)$ by

$$\mu_{x_0} =: \rho_{x_0} + f \mathrm{d} \mathcal{H}_{x_0}^n.$$

Then for all $\varepsilon > 0$, there exists a neighborhood $\mathcal{N}(\varepsilon)$ of x_0 and $h_0(\varepsilon)$ such that for $0 < h < h_0(\varepsilon)$,

$$\|u\|_{L^{\infty}(\mathcal{N}(\varepsilon))} \leqslant h^{-\frac{n-1}{2}} \left(C_n \int_{\Sigma_{x_0}} \sqrt{f} \sqrt{\frac{|\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} + \varepsilon \right).$$

Proof that Theorem 1.5 implies Corollary 2.1. — Let

$$\widetilde{A}_{x_0} := C_n \int_{\Sigma_{x_0}} \sqrt{f} \sqrt{\frac{\nu(H_p)}{|\partial_{\xi} p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}$$

and suppose that there exists $\varepsilon > 0$ such that for all r > 0,

(2.1)
$$\limsup_{h \to 0} h^{\frac{1-n}{2}} \|u_h\|_{L^{\infty}(B(x_0,r))} > \widetilde{A}_{x_0} + \varepsilon.$$

Fix $r_0 > 0$. Then by (2.1) there exists $x \in B(x_0, r_0)$, $h_0 > 0$ so that

$$|u_{h_0}(x)|h_0^{\frac{n-1}{2}} \ge \widetilde{A}_{x_0} + \frac{\varepsilon}{2}.$$

Assume that there exist $\{h_j\}_{j=0}^N$ and $\{x_j\}_{j=0}^N$ so that

$$h_j \leqslant \frac{h_{j-1}}{2}, \qquad x_j \in B(x_0, r_0 2^{-j}), \qquad h_j^{\frac{n-1}{2}} |u(x_j)| \ge \widetilde{A}_{x_0} + \frac{\varepsilon}{2}.$$

By (2.1), there exists $h_k \downarrow 0$ and $x_k \in B(x_0, r_0 2^{-N-1})$ such that

$$h_k^{\frac{1-n}{2}}|u_{h_k}(x_k)| \ge \widetilde{A}_{x_0} + \frac{\varepsilon}{2}.$$

Therefore, we can choose k_0 large enough so that $h_{k_0} \leq \frac{h_N}{2}$ and let $(h_{N+1}, x_{N+1}) = (h_{k_0}, x_{k_0})$, Hence, by induction, there exists $h_j \downarrow 0, x_j \rightarrow x_0$ such that

$$h_j^{\frac{n-1}{2}}|u_{h_j}(x_j)| \ge \widetilde{A}_{x_0} + \frac{\varepsilon}{2},$$

contradicting Theorem 1.5.

Proof that Theorem 1.5 implies Theorem 1.4. — Compactness of M together with Corollary 2.1 with $f \equiv 0$ implies the contrapositive of Theorem 1.4, in particular, if $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$ for all x_0 , then $\|u\|_{L^{\infty}} = o(h^{\frac{1-n}{2}})$.

2.1. Proof of Corollaries 1.9 and 1.10 from Theorem 1.5

LEMMA 2.2. — Fix $x_0 \in M$ and suppose that u is compactly microlocalized with $Pu = o_{L^2}(h)$. Define $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$ and $f \in L^1(\Lambda_{x_0}; \mathcal{H}_{x_0}^n)$ by

 $\mu_{x_0} = \rho_{x_0} + f \mathrm{d}\mathcal{H}_{x_0}^n.$

Then $f|_{\Sigma_{x_0}} \in L^1(\operatorname{vol}_{\Sigma_{x_0}})$ and $f|_{\Sigma_{x_0}}(1-1_{\mathcal{R}_{x_0}})=0$ almost everywhere.

Proof. — For $\xi_0 \in \Sigma_{x_0}$ and $\varepsilon > 0$ let $B(\xi_0, \varepsilon) \subset \Sigma_{x_0}$ be the open ball of radius ε and

$$V := \bigcup_{-2\delta < t < 2\delta} G_t(B(\xi_0, \varepsilon)).$$

Observe that by Theorem 1.5 the triple $(\Lambda_{x_0}, f d\mathcal{H}_{x_0}^n, G_t)$ forms a measure preserving dynamical system. The Poincaré recurrence theorem [6, Propositions 4.2.1, 4.2.2] implies that for $f d\mathcal{H}_{x_0}^n$ a.e. $(x,\xi) \in V$ there exists $t_n^{\pm} \to \pm \infty$ so that $G_{t_n^{\pm}}(x,\xi) \in V$. By the definition of V, there exists s_n^{\pm} with $|s_n^{\pm} - t_n^{\pm}| < 2\delta$ such that $G_{s_n^{\pm}}(x,\xi) \in B(\xi_0,\varepsilon)$. In particular, for $f d\mathcal{H}_{x_0}^n$ a.e. $(x,\xi) \in V$,

(2.2)
$$\bigcap_{T>0} \overline{\bigcup_{t \ge T} G_t(x,\xi) \cap B(\xi_0,\varepsilon)} \neq \emptyset, \quad \bigcap_{T>0} \overline{\bigcup_{t \ge T} G_{-t}(x,\xi) \cap B(\xi_0,\varepsilon)} \neq \emptyset.$$

Let

 $\mu_{\Sigma_{x_0}} := f|_{\Sigma_{x_0}} |\nu(H_p)||_{\Sigma_{x_0}} \operatorname{d} \operatorname{vol}_{\Sigma_{x_0}}.$

We next show that (2.2) holds for $\mu_{\Sigma_{x_0}}$ a.e. point in $B(\xi_0, \varepsilon)$. To do so, suppose the opposite. Then there exists $A \subset B(\xi_0, \varepsilon)$ with $\mu_{\Sigma_{x_0}}(A) > 0$ so that for each $(x, \xi) \in A$, there exists T > 0 with

(2.3)
$$\left(\left\lfloor\bigcup_{t\geqslant T}G_t(x,\xi)\right\rfloor\bigcup\left[\bigcup_{t\geqslant T}G_{-t}(x,\xi)\right]\right)\cap B(\xi_0,\varepsilon)=\emptyset.$$

Let

$$A_{\delta} := \bigcup_{t=-\delta}^{\delta} G_t(A).$$

Then $A_{\delta} \subset V$ and for all $(x, \xi) \in A_{\delta}$, there exists T > 0 so that (2.3) holds. Moreover, invariance of $f d\mathcal{H}_{x_0}^n$ under G_t together with Lemma 3.4 implies that

$$(f d\mathcal{H}_{x_0}^n)(A_\delta) = 2\delta\mu_{\Sigma_{x_0}}(A) > 0$$

which contradicts (2.2). Thus (2.2) holds for $\mu_{\Sigma_{x_0}}$ a.e. point in $B(\xi_0, \varepsilon)$.

Let $\{B(\xi_i, \varepsilon_i)\}$ be a countable basis for the topology on Σ_{x_0} . Then for each *i*, there is a subset of full measure, $\widetilde{B}_i \subset B(\xi_i, \varepsilon_i)$ so that for every point of \widetilde{B}_i (2.2) holds with $\xi_0 = \xi_i, \varepsilon = \varepsilon_i$. Noting that $X_i = \widetilde{B}_i \cup (\Sigma_{x_0} \setminus B(\xi_i, \varepsilon_i))$ has full measure, we conclude that $\widetilde{\Sigma}_{x_0} = \bigcap_i X_i \subset \mathcal{R}_{x_0}$ has full measure and thus, $\mu_{\Sigma_{x_0}}(\mathcal{R}_{x_0}) = \mu_{\Sigma_{x_0}}(\Sigma_{x_0})$, finishing the proof of the lemma.

Proof of Corollary 1.9. — Let u solve $Pu = o_{L^2}(h)$. Then we can extract a subsequence with a defect measure μ . By Lemma 2.2, $\mu_{x_0} = \rho_{x_0} + f d\mathcal{H}_{x_0}^n$ with $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$ and $\operatorname{supp} f|_{\Sigma_{x_0}} \subset \mathcal{R}_{x_0}$. Now, if $\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0}) = 0$,

$$\int_{\Sigma_{x_0}} \sqrt{f} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} = 0.$$

Plugging this into Theorem 1.5 proves the corollary.

Proof of Corollary 1.10. — Let u solve $Pu = o_{L^2}(h)$. Then we can extract a subsequence with a defect measure μ . By Lemma 2.2 and Theorem 1.5, $\mu_{x_0} = \rho_{x_0} + f d\mathcal{H}_{x_0}^n$ where $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$, $\operatorname{supp} f|_{\Sigma_{x_0}} \subset \mathcal{R}_{x_0}$, and $f d\mathcal{H}_{x_0}^n$ is G_t invariant.

Let T_{x_0} be as in (1.7). Fix $T < \infty$ and suppose

$$A \subset \Omega_T := \{ \eta \in \Sigma_{x_0} \mid T_{x_0}(\eta) \leqslant T \}.$$

Write $(0,T] = \bigsqcup_{i=1}^{N(\varepsilon)} (T_i - \varepsilon, T_i + \varepsilon]$ and

$$\Omega_T = \bigsqcup_{i=1}^{N(\varepsilon)} \Omega_i^{\varepsilon}, \qquad \Omega_i^{\varepsilon} := T_{x_0}^{-1}((T_i - \varepsilon, T_i + \varepsilon]).$$

Then, by Lemma 3.4 (using that in the case of $-h^2\Delta_g - 1$, $|\nu(H_p)| \equiv 2$) for any $0 < \delta$ small enough

$$\int 2\mathbf{1}_A f \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} = \frac{1}{2\delta} \int \mathbf{1}_{\bigcup_{-\delta}^{\delta} G_t(A)} f \mathrm{d} \mathcal{H}_{x_0}^n = \frac{1}{2\delta} \sum_i \int \mathbf{1}_{\bigcup_{-\delta}^{\delta} G_t(A \cap \Omega_i^{\varepsilon})} f \mathrm{d} \mathcal{H}_{x_0}^n.$$

Next, using invariance of $f d\mathcal{H}_{x_0}^n$ under G_t , we have

$$\frac{1}{2\delta} \sum_{i} \int 1_{\bigcup_{-\delta}^{\delta} G_{t}(A \cap \Omega_{i}^{\varepsilon})} f \mathrm{d}\mathcal{H}_{x_{0}}^{n} = \sum_{i} \frac{1}{2\delta} \int 1_{\bigcup_{T_{i}-\delta}^{T_{i}+\delta} G_{t}(A \cap \Omega_{i}^{\varepsilon})} f \mathrm{d}\mathcal{H}_{x_{0}}^{n}$$

Then, by the definition of Ω_i^{ε} , for $q \in \Omega_i^{\varepsilon}$, $|T_{x_0}(q) - T_i| < \varepsilon$ and

$$\sum_{i} 1_{\bigcup_{T_i - \delta}^{T_i + \delta} G_t(A \cap \Omega_i^{\varepsilon})} \underset{\varepsilon \to 0}{\longrightarrow} 1_{\bigcup_{-\delta}^{\delta} G_t(\eta_x(A))} \qquad f \mathrm{d}\mathcal{H}_{x_0}^n \text{ a.e.}$$

In particular, by the dominated convergence theorem

$$\lim_{\varepsilon \to 0} \sum_{i} \frac{1}{2\delta} \int 1_{\bigcup_{T_i - \delta}^{T_i + \delta} G_t(A \cap \Omega_i^{\varepsilon})} f \mathrm{d}\mathcal{H}_{x_0}^n = \frac{1}{2\delta} \int 1_{\bigcup_{-\delta}^{\delta} G_t(\eta_x(A))} f \mathrm{d}\mathcal{H}_{x_0}^n$$

So, sending $\delta \to 0$ gives

$$2\int \mathbf{1}_A f \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} = 2\int \mathbf{1}_{\eta_x(A)} f \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}$$

for all $A \subset \Omega_T$ measurable. Taking $T \to \infty$ then proves this for all $A \subset \mathcal{L}_{x_0}$ measurable. In particular, changing variables, using that supp $f \subset \mathcal{R}_{x_0} \subset \mathcal{L}_{x_0}$, and writing $J_{x_0}(\xi)$ as in (1.10)

$$f(\xi) \operatorname{d} \operatorname{vol}_{\Sigma_{x_0}}(\xi) = f(\eta_{x_0}(\xi)) \cdot J_{x_0}(\xi) \operatorname{d} \operatorname{vol}_{\Sigma_{x_0}}(\xi)$$

which implies $U_{x_0}\sqrt{f} = \sqrt{f}$ where U_{x_0} is defined in (1.9). Observe that since x_0 is dissipative and $\sqrt{f} \in L^2(\mathcal{R}_{x_0}, \operatorname{dvol}_{\Sigma_{x_0}})$, (1.11) implies $\sqrt{f} = 0$. Theorem 1.5 then completes the proof.

2.2. Spectral cluster estimates for $-\Delta_q$

Let (M, g) be a smooth, compact, boundaryless Riemannian manifold of dimension $n, p = |\xi|_g^2 - 1, G_t = \exp(tH_p)$ and

$$A_x := \frac{C_n}{2} \left(\frac{\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0})}{\inf_{\xi \in \mathcal{R}_{x_0}} T_{x_0}(\xi)} \right)^{1/2}$$

where T_{x_0} is as in (1.7) and C_n is the constant in Theorem 1.5. We consider an orthonormal basis $\{u_{\lambda_j}\}_{j=1}^{\infty}$ of eigenfunctions of $-\Delta_g$ (i.e. solving (1.1)) and let

$$\Pi_{[\lambda,\lambda+\delta]} := \mathbb{1}_{[\lambda,\lambda+\delta]}(\sqrt{-\Delta_g}).$$

COROLLARY 2.3. — For all $\varepsilon > 0$, $x_0 \in M$, there exists $\delta = \delta(x_0, \varepsilon) > 0$, a neighborhood $\mathcal{N}(x_0, \varepsilon)$ of x_0 , and $\lambda_0 = \lambda_0(x_0, \varepsilon) > 0$ so that for $\lambda > \lambda_0$,

(2.4)
$$\|\Pi_{[\lambda,\lambda+\delta]}\|_{L^{2}(M)\to L^{\infty}(\mathcal{N}(x_{0},\varepsilon))}^{2} = \sup_{y\in\mathcal{N}(x_{0},\varepsilon)}\sum_{\lambda_{j}\in[\lambda,\lambda+\delta]}|u_{\lambda_{j}}(y)|^{2} \leqslant (A_{x_{0}}^{2}+\varepsilon)\lambda^{n-1}.$$

Note that since $G_t|_{S^*M}$ parametrizes the speed 2 geodesic flow and therefore

$$\begin{split} \inf_{\xi \in \mathcal{R}_{x_0}} T_{x_0}(\xi) \geqslant \frac{1}{2} L(x_0, M) \geqslant \operatorname{inj}(M), \\ L(x_0, M) := \inf \left\{ t > 0 \, \middle| \begin{array}{c} \text{there exists a geodesic of length } t \\ \text{starting and ending at } x_0 \end{array} \right\}, \end{split}$$

and inj(M) denotes the injectivity radius of M. Therefore, we could replace A_{x_0} in (2.4) by either of

$$A'_{x_0} = C_n \left(\frac{\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0})}{2 \cdot L(x_0, M)} \right)^{1/2}, \qquad A''_{x_0} = C_n \left(\frac{\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0})}{4 \cdot \operatorname{inj}(M)} \right)^{1/2}$$

to obtain a weaker, but more easily understood statement. Corollary 2.3 is closely related to the work of Donnelly [7] and gives explicit dependence of the constant in the Hörmander bound in terms of geometric quantities.

Proof. — We start from the fact that for $U \subset M$

(2.5)
$$\|\Pi_{[\lambda,\lambda+\delta]}\|_{L^2(M)\to L^\infty(U)}^2 = \sup_{x\in U} \sum_{\lambda_j\in[\lambda,\lambda+\delta]} |u_{\lambda_j}(x)|^2.$$

For $w \in L^2(M)$,

(2.6)
$$\|(-\Delta_g - \lambda^2)\Pi_{[\lambda,\lambda+\delta]}w\|_{L^2} \leq 2\lambda\delta \|\Pi_{[\lambda,\lambda+\delta]}w\|_{L^2}.$$

Suppose that for some $\varepsilon > 0$ no δ , $\mathcal{N}(x_0)$, and λ_0 exist so that (2.4) holds. Then for all $\delta > 0$, r > 0,

$$\limsup_{\lambda \to \infty} \lambda^{\frac{1-n}{2}} \| \Pi_{[\lambda, \lambda+\delta]} \|_{L^2(M) \to L^\infty(B(x_0, r))} > A_{x_0} + \varepsilon.$$

Therefore, for all $0 < m \in \mathbb{Z}$, there exists $\lambda_{k,m} \uparrow \infty$ so that

(2.7)
$$\lambda_{k,m}^{\frac{1-n}{2}} \| \Pi_{[\lambda_{k,m},\lambda_{k,m}+m^{-1}]} \|_{L^2(M) \to L^{\infty}(B(x_0,r))} > A_{x_0} + \varepsilon_{x_0}^{1-n} \|_{L^2($$

Moreover, we may assume that for $m_1 < m_2$, $\lambda_{k,m_2} > \lambda_{k,m_1}$. Indeed, assume we have chosen such $\lambda_{k,m}$ for m < M. Then there exists $\lambda_{k,M} > \max(\lambda_{k,M-1}, \lambda_{k-1,M})$ so that (2.7) holds with m = M. By convention, we let $\lambda_{-1,m} = 0$. Now, for $m_1 \leq m_2$,

$$\|\Pi_{[\lambda,\lambda+m_2^{-1}]}\|_{L^2(M)\to L^{\infty}(B(x_0,r))} \leqslant \|\Pi_{[\lambda,\lambda+m_1^{-1}]}\|_{L^2(M)\to L^{\infty}(B(x_0,r))},$$

letting $\lambda_l = \lambda_{l,l}, \ \lambda_l \to \infty$ and

$$\lambda_l^{\frac{1-n}{2}} \| \Pi_{[\lambda_l, \lambda_l + l^{-1}]} \|_{L^2(M) \to L^{\infty}(B(x_0, r))} > A_{x_0} + \varepsilon$$

By (2.6) for $w \in L^2(M)$

$$\|(-\lambda_l^{-2}\Delta_g - 1)\Pi_{[\lambda_l,\lambda_l+l^{-1}]}w\|_{L^2 \to L^2} = o(\lambda_l^{-1})\|\Pi_{[\lambda_l,\lambda_l+l^{-1}]}w\|_{L^2 \to L^2}.$$

Fix $w_l \in L^2(M)$ with $||w_l||_{L^2} = 1$, so that

$$\lambda_l^{\frac{1-n}{2}} \|v_l\|_{L^{\infty}(B(x_0,r))} > A_{x_0} + \varepsilon, \qquad v_l := \prod_{[\lambda_l, \lambda_l + l^{-1}]} w_l.$$

Then extracting a further subsequence if necessary, we may assume that v_l has defect measure μ with $\mu_{x_0} = \rho_{x_0} + f d\mathcal{H}_{x_0}^n$ and hence that Corollary 2.1 applies to v_l . Furthermore, since $\|v_l\|_{L^2} \leq \|w_l\|_{L^2} = 1$,

(2.8)
$$\int_{\Lambda_{x_0}} f \mathrm{d}\mathcal{H}_{x_0}^n \leqslant 1.$$

By computing in normal geodesic coordinates at x_0 , observe that for $p = |\xi|_g^2 - 1$, $|\nu(H_p)| = |\partial_{\xi}p|_g = 2$. Thus, Corollary 2.1, implies the existence of r > 0 small enough so that

(2.9)
$$A_{x_0} + \varepsilon \leqslant \limsup_{l \to \infty} \lambda_l^{\frac{1-n}{2}} \|v_l\|_{L^{\infty}(B(x_0, r))} \leqslant C_n \int_{\Sigma_{x_0}} \sqrt{f} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}$$

Finally, by Lemma 2.2 and (2.8), supp $f \subset \mathcal{R}_{x_0}$ and $||f||_{L^1(\Lambda_{x_0},\mathcal{H}^n_{x_0})} \leq 1$. Therefore,

$$C_n \int_{\Sigma_{x_0}} \sqrt{f} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}$$

$$\leq C_n \left(\frac{1}{2} \int_{\Sigma_{x_0}} f |\nu(H_p)| \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \right)^{1/2} \left(\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0}) \right)^{1/2}$$

$$= C_n \left(\frac{1}{4 \cdot \inf_{\xi \in \mathcal{R}_{x_0}}(T_{x_0}(\xi))} \int_{\Lambda_{x_0, \inf_{\mathcal{R}_{x_0}}} T_{x_0}(\xi)} f \mathrm{d} \mathcal{H}_{x_0}^n \right)^{1/2} \left(\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0}) \right)^{1/2}$$

$$\leq \frac{C_n}{2} \left(\frac{\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0})}{\inf_{\xi \in \mathcal{R}_{x_0}}(T_{x_0}(\xi))} \right)^{1/2} = A_{x_0},$$

contradicting (2.9).

Compactness of M, the fact that $\operatorname{vol}_{\Sigma_{x_0}}(\mathcal{R}_{x_0}) \leq \operatorname{vol}(S^{n-1})$, and Corollary 2.3 imply Corollary 1.7.

3. Dynamical and measure theoretic preliminaries

3.1. Dynamical preliminaries

The following lemma gives an estimate on how much spreading the geodesic flow has near a point.

LEMMA 3.1. — Fix $x_0 \in M$. Then there exists $\delta_{M,p} > 0$ small enough and $C_1 > 0$ so that uniformly for $t \in [-\delta_{M,p}, \delta_{M,p}]$,

$$(3.1) \quad \frac{1}{2}d((x_0,\xi_1),(x_0,\xi_2)) - C_1d((x_0,\xi_1),(x_0,\xi_2))^2 \\ \leq d(G_t(x_0,\xi_2),G_t(x_0,\xi_1)) \\ \leq 2d((x_0,\xi_1),(x_0,\xi_2)) + C_1d((x_0,\xi_1),(x_0,\xi_2))^2$$

where d is the distance induced by the Sasaki metric. Furthermore if $G_t(x_0,\xi_i) = (x_i(t),\xi_i(t)),$

(3.2)
$$d_M(x_1(t), x_2(t)) \leqslant C_1 d\big((x_0, \xi_1), (x_0, \xi_2)\big) \delta_{M, p}$$

where d_M is the distance induce by the metric M.

Proof. — By Taylor's theorem

$$G_t(x_0,\xi_1) - G_t(x_0,\xi_2)$$

= $d_{\xi}G_t(x_0,\xi_2)(\xi_1 - \xi_2) + O_{C^{\infty}}\left(\sup_{q \in \Sigma} |d_{\xi}^2 G_t(q)|(\xi_1 - \xi_2)^2\right)$

Now,

$$G_t(x_0,\xi) = (x_0,\xi) + (\partial_{\xi} p(x_0,\xi)t, -\partial_x p(x_0,\xi)t) + O(t^2)$$

 \mathbf{SO}

$$d_{\xi}G_t(x_0,\xi) = (0,I) + t(\partial_{\xi}^2 p, -\partial_{\xi x}^2 p) + O(t^2)$$

In particular,

$$G_t(x_0,\xi_1) - G_t(x_0,\xi_2) = ((0,I) + O(t))(\xi_1 - \xi_2) + O((\xi_1 - \xi_2)^2)$$

and choosing $\delta_{M,p} > 0$ small enough gives the result.

3.2. Measure theoretic preliminaries

We will need a few measure theoretic lemmas to prove our main theorem.

LEMMA 3.2. — Suppose that $\mu_{x_0} = \rho_{x_0} + f d\mathcal{H}_{x_0}^n$ is a finite Borel measure invariant under G_t and $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$. Then ρ_{x_0} and $f d\mathcal{H}_{x_0}^n$ are invariant under G_t .

Proof. — Since $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$, there exist disjoint N, P such that $\rho_{x_0}(P) = \mathcal{H}_{x_0}^n(N) = 0$ and $\Lambda_{x_0} = N \cup P$. Suppose A is Borel. Then the invariance of μ_{x_0} implies

(3.3)
$$\int (1_A \circ G_{-t} - 1_A) \mathrm{d}\rho_{x_0} = \int (1_A - 1_A \circ G_{-t}) f \mathrm{d}\mathcal{H}_{x_0}^n.$$

Now, if $A \subset N$ then the fact that G_t is a diffeomorphism implies that it maps 0 Hausdorff measure sets to 0 Hausdorff measure sets and hence $\mathcal{H}_{x_0}^n(A) = \mathcal{H}_{x_0}^n(G_t(A)) = 0$. Therefore,

(3.4)
$$\rho_{x_0}(A) = \rho_{x_0}(G_t(A)), \qquad A \subset N$$

In particular,

$$\rho_{x_0}(N) = \rho_{x_0}(G_t(N)) = \rho_{x_0}(\Lambda_{x_0}).$$

Using again that for $t \in \mathbb{R}$, $G_t : \Sigma \to \Sigma$ is a diffeomorphism, we have

$$\rho_{x_0}(G_t(P)) = \rho_{x_0}(\Lambda_{x_0} \setminus G_t(N)) = \rho_{x_0}(\Lambda_{x_0}) - \rho_{x_0}(G_t(N)) = 0.$$

So, in particular,

(3.5)
$$\rho_{x_0}(G_t(A)) = 0, \qquad A \subset P_t$$

Combining (3.4) with (3.5) proves that ρ_{x_0} is G_t invariant and hence (3.3) proves the lemma.

Let $B(\xi, r) \subset \Sigma_{x_0}$ be the ball of radius r around ξ for the distance induced by the Sasaki metric on Σ_{x_0} and define

(3.6)
$$T_{\delta}(\xi, r) := \bigcup_{t=-\delta}^{\delta} G_t(\{(x_0, \xi_0) \mid \xi_0 \in B(\xi, r)\}).$$

LEMMA 3.3. — Suppose $\delta > 0$ and ρ_{x_0} is a finite measure invariant under G_t and $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$. Then for all $\varepsilon > 0$, there exist $\xi_j \in \Sigma_{x_0}$ and $r_j > 0, j = 1, \ldots$ so that

(3.7)
$$\sum r_j^{n-1} < \varepsilon, \qquad \rho_{x_0}\left(\bigcup_j T_{\delta}(\xi_j, r_j)\right) = \rho_{x_0}(\Lambda_{x_0, \delta}).$$

Proof. — Fix $\delta > 0$ so that

$$[-\delta,\delta] \times \Sigma_{x_0} \ni (t,q) \mapsto G_t(q) \in \Lambda_{x_0,\delta}$$

is a diffeomorphism and use (t, q) as coordinates on $\Lambda_{x_0,\delta}$.

We integrate ρ_{x_0} over $\Lambda_{x_0,\delta}$ to obtain a measure on Σ_{x_0} . In particular, for $A \subset \Sigma_{x_0}$ Borel, define the measure

(3.8)
$$\widetilde{\rho}_{x_0}(A) := \frac{1}{2\delta} \rho_{x_0} \left(\bigcup_{t=-\delta}^{\delta} G_t(A) \right).$$

Then, the invariance of ρ_{x_0} implies that $\partial_t^* \rho_{x_0} = 0$, where for $F \in C_c^{\infty}(-\delta, \delta) \times \Sigma_{x_0}$, $\partial_t^* \rho_{x_0}(F) = \rho_{x_0}(\partial_t F)$. In particular, for all $F \in C_c^{\infty}(-\delta, \delta) \times \Sigma_{x_0}$,

$$\int \partial_t F \mathrm{d}\rho_{x_0} = 0.$$

Now, fix $\chi \in C_c^{\infty}(-\delta, \delta)$ with $\int \chi dt = 1$. Let $f \in C_c^{\infty}((-\delta, \delta) \times \Sigma_{x_0})$ and define

$$\bar{f}(q) := \int f(t,q) \mathrm{d}t.$$

Then $f(t,q) - \chi(t)\overline{f}(q) = \partial_t F$ with

$$F(t,q) := \int_{-\infty}^{t} f(s,q) - \chi(s)\overline{f}(q) \mathrm{d}s \in C_{c}^{\infty}((-\delta,\delta) \times \Sigma_{x_{0}}).$$

Therefore, for all $f \in C_c^{\infty}((-\delta, \delta) \times \Sigma_{x_0})$ and $\chi \in C_c^{\infty}(-\delta, \delta)$ with $\int \chi dt = 1$,

$$\int f(t,q) \mathrm{d}\rho_{x_0}(t,q) = \int \chi(t)\bar{f}(q) \mathrm{d}\rho_{x_0}(t,q) = \iiint f(s,q) \mathrm{d}s\chi(t) \mathrm{d}\rho_{x_0}(t,q).$$

Now, let $B \subset \Sigma_{x_0}$ be Borel, $I \subset (-\delta, \delta)$ Borel, and $f_n(t,q) \uparrow 1_I(t) 1_B(q)$. Then by the dominated convergence theorem,

$$\rho_{x_0}(I \times B) = \iint |I| \mathbf{1}_B(q) \chi(t) \mathrm{d}\rho_x(t,q).$$

Next, let $\chi_n \uparrow \delta^{-1} \mathbb{1}_{[0,\delta]}$ with $\int \chi_n \equiv 1$. Then we obtain

$$\rho_{x_0}(I \times B) = \frac{|I|}{\delta} \rho_{x_0}([0, \delta] \times B).$$

So, letting $\tilde{\rho}_{x_0}(B) := \delta^{-1} \mu([0, \delta] \times B)$, we have that for rectangles $I \times B$, $\rho_{x_0}(I \times B) = \mathrm{d}t \times \mathrm{d}\tilde{\rho}_{x_0}(I \times B)$. But then, since these sets generate the Borel sigma algebra,

(3.9)
$$\rho_{x_0} = \mathrm{d}t \times \widetilde{\rho}_{x_0}.$$

Now, notice that $\mathcal{H}_{x_0}^n = g(t,q) dt \times d \operatorname{vol}_{\Sigma_{x_0}}$ where $0 < c < g \in C^{\infty}$. In particular, since

$$\mathrm{d}t \times \widetilde{\rho}_{x_0} \perp \mathrm{d}t \times \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}}$$

we have that $\widetilde{\rho}_{x_0} \perp \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}$.

Thus, there exists $N, P \subset \Sigma_{x_0}$ so that $\tilde{\rho}_{x_0}(P) = \operatorname{vol}_{\Sigma_{x_0}}(N) = 0$ and $\Sigma_{x_0} = N \sqcup P$. Hence for any $\varepsilon > 0$, there exist $\xi_j \in \Sigma_{x_0}$ and $r_j > 0$ so that

$$\sum_{j} r_{j}^{n-1} < \varepsilon, \quad \widetilde{\rho}_{x_{0}} \left(\bigcup_{j} B(\xi_{j}, r_{j}) \right) = \widetilde{\rho}_{x_{0}}(\Sigma_{x_{0}}).$$

The lemma then follows from (3.9) and invariance of ρ_{x_0} .

LEMMA 3.4. — Suppose that $0 \leq f \in L^1(\Lambda_{x_0}, \mathcal{H}^n_{x_0})$ with $f d\mathcal{H}^n_{x_0}$ invariant under G_t . Then for $\delta_0 > 0$ small enough, write

$$[-\delta_0, \delta_0] \times \Sigma_{x_0} \ni (t, q) \mapsto G_t(q) \in \Lambda_{x_0}$$

for coordinates on Λ_{x_0,δ_0} . We have

$$f1_{\Lambda_{x_0,\delta_0}} \mathrm{d}\mathcal{H}^n_{x_0} = f(q)1_{[-\delta_0,\delta_0]}(t)\mathrm{d}t \times \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}}$$

where

$$\widetilde{f}(q) = f(0,q)|\nu(H_p)|(0,q)$$

and ν is a unit normal to $\Sigma_{x_0} \in \Lambda_{x_0,\delta_0}$ with respect to the Sasaki metric.

Proof. — Observe that $1_{\Lambda_{x_0,\delta_0}} d\mathcal{H}_{x_0}^n$ is the volume measure on Λ_{x_0,δ_0} . Therefore, $1_{\Lambda_{x_0,\delta_0}} d\mathcal{H}_{x_0}^n \ll 1_{[-\delta_0,\delta_0]}(t) dt \times d \operatorname{vol}_{\Sigma_{x_0}}$ and in particular,

$$f1_{\Lambda_{x_0,\delta_0}} \mathrm{d}\mathcal{H}_{x_0}^n = f(t,q) \frac{\mathrm{d}\mathcal{H}_{x_0}^n}{\mathrm{d}t \times \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}}}(t,q)1_{[-\delta_0,\delta_0]}(t) \mathrm{d}t \times \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}}.$$

Since $f d\mathcal{H}_{x_0}^n$ is invariant under G_t , it is invariant under translation in t and we have

$$f(t,q)\frac{\mathrm{d}\mathcal{H}_{x_0}^n}{\mathrm{d}t\times\mathrm{d}\operatorname{vol}_{\Sigma_{x_0}}}(t,q) = \widetilde{f}(q)$$

is constant in time.

To compute $\tilde{f}(q)$, we need only compute

$$\frac{\mathrm{d}\mathcal{H}_{x_0}^n}{\mathrm{d}t \times \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}}}(0,q)$$

For this, observe that $1_{\Lambda_{x_0,\delta}} \mathcal{H}_{x_0}^n$ is the volume measure on $\Lambda_{x_0,\delta}$ with respect to the Sasaki metric. Therefore, we have $d \operatorname{vol}_{\Sigma_{x_0}} = N \lrcorner d \operatorname{vol}_{\Lambda_{x_0,\delta_0}}$ where Nis a unit normal to Σ_{x_0} . More precisely, if $r \in C^{\infty}(\Lambda_{x_0,\delta_0})$ has $dr|_{\Sigma_{x_0}}(V) = \langle N, V \rangle_{g_s}$ where g_s denotes the Sasaki metric and $V \in T_{\Sigma_{x_0}} \Lambda_{x_0,\delta_0}$, then $\nu = dr|_{\Sigma_{x_0}}$ is a unit conormal to Σ_{x_0} and

$$\frac{\mathrm{d}\mathcal{H}_{x_0}^n}{\mathrm{d}t \times \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}}}(0,q) = |\partial_t(r \circ G_t)|_{t=0}|(q) = |\nu(H_p)|(q). \qquad \Box$$

4. A proof of Theorem 1.5 for the Laplacian

One can use a strategy similar to that in [9] to prove Theorem 1.5 for eigenfunctions of the Laplacian. We sketch the proof in the case $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$ for the convenience of the reader. Following the arguments in Section 6.2, replacing Lemma 6.2 with (4.10) it is possible to give a proof of the full theorem in this way. Note however, that much greater care would be needed to eliminate the dependence of the constant on M. We wish to stress that the analysis in the next sections gives an effective geometric explanation for the gains in L^{∞} norms that is not available through use of the spectral projector. Moreover, it shows that the structure of the L^{∞} gains depends only on quantitative control on the transversality of the flow to the fibers.

We start by constructing a convenient partition of unity. This partition will also be used in the proof of the general case, so we write a careful proof.

LEMMA 4.1. — Fix $(x_0, \xi_j) \in \Sigma_{x_0}$ and $r_j > 0$, $j = 1, \ldots K < \infty$, $\delta > 0$. Then there exist $\chi_j \in C_c^{\infty}(T^*M; [0, 1]), j = 1 \ldots K$ so that

(4.1)
$$\sup_{j} \chi_{j} \cap \Lambda_{x_{0}} \subset T_{4\delta}(\xi_{j}, 2r_{j}) \cap \Lambda_{x_{0}, 4\delta}, \qquad H_{p}\chi_{j} \equiv 0 \text{ on } \Lambda_{x_{0}, 3\delta}$$
$$\sum_{j} \chi_{j} \equiv 1 \text{ on } \bigcup_{j=1}^{K} T_{4\delta}(\xi_{j}, r_{j}) \cap \Lambda_{x_{0}, 3\delta}, \qquad 0 \leqslant \sum_{j} \chi_{j} \leqslant 1, \text{ on } \Lambda_{x_{0}}$$

Furthermore, if

(4.2)
$$\bigcup_{j=1}^{K} T_{4\delta}(\xi_j, 2r_j) \supset \Lambda_{x_0, 3\delta},$$

there exists χ_i satisfying (4.1) and

(4.3)
$$\sum_{j} \chi_{j} \equiv 1 \text{ on } \Lambda_{x_{0},3\delta}$$

Proof. — Let $\widetilde{\chi}_j \in C_c^{\infty}(\Sigma_{x_0}; [0, 1])$ satisfy

$$\sum_{j} \widetilde{\chi}_{j} \equiv 1 \text{ on } \bigcup_{j=1}^{K} B(\xi_{j}, r_{j}), \qquad \operatorname{supp} \widetilde{\chi}_{j} \subset B(\xi_{j}, 2r_{j}) \cap \Sigma_{x_{0}},$$
$$0 \leq \sum_{j} \widetilde{\chi}_{j} \leq 1.$$

Next, let $\psi \in C_c^{\infty}(\mathbb{R}; [0, 1])$ with $\psi \equiv 1$ on $[-3\delta, 3\delta]$ and $\operatorname{supp} \psi \subset (-4\delta, 4\delta)$. For $\delta > 0$ small enough, $G_t : [-4\delta, 4\delta] \times \Sigma_{x_0} \to \Lambda_{x_0, 4\delta}$ is a diffeomorphism and so we can define $\chi_j \in C_c^{\infty}(\Lambda_{x_0, 4\delta}; [0, 1])$ by

$$\chi_j(G_t(x_0,\xi)) = \psi(t)\widetilde{\chi}_j(x_0,\xi)$$

so that $H_p\chi_j \equiv 0$ on $\Lambda_{x_0,3\delta}$. Finally, extend χ_j from $\Lambda_{x_0,4\delta}$ to a compactly supported function on T^*M arbitrarily. Then $\chi_j \ j = 1, \ldots K$ satisfy (4.1).

If (4.2) holds, then we may take $\tilde{\chi}_j$ a partition of unity on Σ_{x_0} subordinate to $B(\xi_j, 2r_j)$ and hence obtain (4.3) by the same construction.

Sketch proof for Laplace eigenfunctions. — Fix $\delta > 0$ and let $\rho \in S(\mathbb{R})$ with $\rho(0) = 1$ and $\operatorname{supp} \hat{\rho} \subset [\delta, 2\delta]$. Let

$$S^*M(\gamma) := \{(x,\xi) \mid ||\xi|_x - 1| \leqslant \gamma\}$$

and $\chi(x,\xi) \in C_0^{\infty}(T^*M)$ be a cutoff near the cosphere S^*M with $\chi(x,\xi) = 1$ for $(x,\xi) \in S^*M(\gamma)$ and $\chi(x,\xi) = 0$ when $(x,\xi) \in T^*M \setminus S^*M(2\gamma)$.

Suppose that $(-h^2\Delta_g - 1)u_h = 0$, and u_h has defect measure μ with $\mu_{x_0} \perp \mathcal{H}_{x_0}^n$. Then

(4.4)
$$u_h = \rho \left(h^{-1} \left[\sqrt{-h^2 \Delta_g} - 1 \right] \right) u_h$$
$$= \int_{\mathbb{R}} \hat{\rho}(t) e^{it \left[\sqrt{-h^2 \Delta_g} - 1 \right]/h} \chi(x, hD) u_h \, \mathrm{d}t + O_{\gamma}(h^{\infty}).$$

Setting $V(t, x, y, h) := \left(\hat{\rho}(t)e^{it[\sqrt{-h^2\Delta_g}-1]/h}\chi(x, hD)\right)(t, x, y)$, by propagation of singularities,

$$WF'_{h}(V(t, \cdot, \cdot, h)) \\ \subset \{(x, \xi, y, \eta) \, | \, (x, \xi) = G_{t}(y, \eta), \, ||\xi|_{x} - 1| \leq 2\gamma, t \in [\delta, 2\delta] \}.$$

Let $b_{x_0,\gamma}(y,\eta) \in C_c^{\infty}(T^*M)$ have

$$\operatorname{supp} b_{x_0,\gamma} \subset \left\{ (y,\eta) \middle| \begin{array}{c} (y,\eta) = G_t(x,\xi) \text{ for some } (x,\xi) \in S^*M(3\gamma) \\ \text{ with } d_M(x,x_0) < 2\gamma, |t| \leqslant 4\delta \end{array} \right\}$$

with

$$b_{x_0,\gamma} \equiv 1 \text{ on } \left\{ (y,\eta) \middle| \begin{array}{c} (y,\eta) = G_t(x,\xi) \text{ for some } (x,\xi) \in S^*M(2\gamma) \\ \text{ with } d_M(x,x_0) < \gamma, |t| \leq 3\delta \end{array} \right\}.$$

Then, by wavefront calculus, it follows that

(4.5)
$$u_h(x_0) = \int_M \bar{V}(x_0, y, h) \, b_{x_0, \gamma}(y, hD_y) u_h(y) \mathrm{d}y + O_{\gamma}(h^{\infty}),$$

where,

$$\bar{V}(x,y,h) := \int_{\mathbb{R}} \hat{\rho}(t) \left(e^{it[\sqrt{-h^2 \Delta_g} - 1]/h} \chi(x,hD) \right)(t,x,y) \,\mathrm{d}t.$$

By a standard stationary phase argument [17, Chapter 5],

(4.6)
$$\bar{V}(x,y,h) = h^{\frac{1-n}{2}} \sum_{\pm} e^{\pm i d_M(x,y)/h} a_{\pm}(x,y,h) \,\hat{\rho}(d_M(x,y)) + O_{\gamma}(h^{\infty}),$$

where $a_{\pm}(x, y, h) \in S^0(1)$.

Then, in view of (4.6) and (4.5),

$$(4.7) \ u_h(x_0) = (2\pi h)^{\frac{1-n}{2}} \sum_{\pm} \int_{\delta < |y-x_0| < 2\delta} e^{\pm i d_M(x_0, y)/h} a_{\pm}(x_0, y, h) \hat{\rho}(d_M(x_0, y)) \\ b_{x,\gamma}(y, hD_y) u_h(y) \, \mathrm{d}y + O_{\gamma}(h^{\infty}).$$

Let χ_j , be as in (4.1) with $T_{4\delta}(\xi_j, r_j)$ satisfying (6.4) and $\sum r_j^{n-1} < \varepsilon$. Define $\psi = 1 - \sum_j \chi_j$. Then

$$u_h(x_0) = \sum_{\pm} I_{\pm} + II_{\pm} + O_{\gamma}(h^{\infty})$$

where

$$I_{\pm} = (2\pi h)^{\frac{1-n}{2}} \int_{\delta < |y-x_0| < 2\delta} e^{\pm i d_M(x_0, y)/h} a_{\pm}(x_0, y, h) \hat{\rho}(d_M(x_0, y))$$

(4.8)
$$II_{\pm} = \sum_j (2\pi h)^{\frac{1-n}{2}} \int_{\delta < |y-x_0| < 2\delta} e^{\pm i d_M(x_0, y)/h} a_{\pm}(x_0, y, h) \hat{\rho}(d_M(x_0, y))$$

$$\chi_j(y, hD_y) b_{x_0, \gamma}(y, hD_y) u_h(y) \, \mathrm{d}y.$$

An application of Cauchy–Schwarz to I_\pm gives

(4.9)
$$\limsup_{h \to 0} h^{\frac{n-1}{2}} |I_{\pm}| \leq C \limsup_{h \to 0} \|\psi(y, hD_y)b_{x_0, \gamma}(y, hD_y)u_h\|_{L^2}.$$

Next observe that

$$\begin{split} \limsup_{\gamma \to 0} \limsup_{h \to 0} \|\psi(y, hD_y)b_{x_0, \gamma}(y, hD_y)u\|_{L^2}^2 \\ &= \limsup_{\gamma \to 0} \int_{S^*M} |\psi|^2 |b_{x_0, \gamma}(y, \xi)|^2 \mathrm{d}\mu \\ &\leqslant C\mu(\mathrm{supp}\,\psi \cap \Lambda_{x_0, 4\delta}) \\ &\leqslant C\mu_{x_0}(\mathrm{supp}\,\psi) \leqslant C\varepsilon. \end{split}$$

Note that the first inequality follows from the fact that $\lim_{\gamma\to 0} b_{x_0,\gamma} \leq 1_{\Lambda_{x_0,4\delta}}$. On the other hand, by propagation of singularities, for each χ_j in II_{\pm} , we may insert $\varphi_j \in C_c^{\infty}(M)$ localized to

$$\pi(T_{4\delta}(\xi_j, r_j) \cap \{\delta < d_M(x, x_0) < 2\delta\}),\$$

where $\pi : T^*M \to M$ is projection to the base. In particular, replacing $\chi_j(y, hD_y)$ by $\varphi_j(y)\chi_j(y, hD_y)$ and applying Cauchy–Schwarz to each term of II, we have

(4.10)
$$\limsup_{h \to 0} h^{\frac{n-1}{2}} |I|_{\pm}| \leq C \sum_{j} \|\varphi_{j}\|_{L^{2}} \limsup_{h \to 0} \|\chi_{j}b_{x_{0},\gamma}(y,hD_{y})u_{h}\|_{L^{2}}.$$

Now, since φ_j is supported on a tube of radius r_j , $\|\varphi_j\|_{L^2} \leq Cr_j^{(n-1)/2}$. Furthermore,

$$\begin{split} \lim_{\gamma \to 0} \lim_{h \to 0} \|\chi_j(y, hD_y) b_{x_0, \gamma}(y, hD_y) u\|_{L^2}^2 \\ &= \lim_{\gamma \to 0} \int_{S^*M} \chi_j^2 |b_{x_0, \gamma}(y, \xi)|^2 \mathrm{d}\mu \leqslant \int_{\Lambda_{x_0}} \chi_j^2 \mathrm{d}\mu. \end{split}$$

Thus, applying Cauchy–Schwarz once again to the sum in (4.10),

$$\limsup_{h \to 0} h^{\frac{n-1}{2}} |II_{\pm}| \leqslant C \left(\sum_{j} r_{j}^{n-1}\right)^{1/2} \left(\int \sum_{j} \chi_{j}^{2} \mathrm{d}\mu\right)^{1/2} \leqslant C\varepsilon^{1/2}.$$

Sending $\varepsilon \to 0$ proves the theorem.

5. L^{∞} estimates microlocalized to Λ_{x_0}

For the next two sections, we assume that u is compactly microlocalized and $Pu = o_{L^2}(h)$ where P is as in Theorem 1.5.

LEMMA 5.1. — Suppose that P is as in Theorem 1.5, u is compactly microlocalized, and $Pu = o_{L^2}(h)$. Then for $q, a \in S^{\infty}(T^*M)$

$$\|a(x,hD)q(x,hD)u\|_{L^{2}}^{2} = \int |a|^{2}|q|^{2}d\mu + o(1),$$

$$\|a(x,hD)Pq(x,hD)u\|_{L^{2}}^{2} = h^{2} \int |a|^{2}|H_{p}q|^{2}d\mu + o(h^{2})$$

Proof. — First observe that since u is compactly microlocalized, there exists $\chi \in C_c^{\infty}(T^*M)$ so that

$$u = \chi(x, hD)u + O_{\mathcal{S}}(h^{\infty}).$$

Therefore, we may assume $q, a \in C_c^{\infty}(T^*M)$. The first equality then follows from the definition of the defect measure and the fact that $[a(x, hD)]^* = \bar{a}(x, hD) + O_{L^2 \to L^2}(h)$. For the second, note that

$$Pq(x,hD)u = q(x,hD)Pu + [P,q(x,hD)]u$$

= $q(x,hD)Pu + \frac{h}{i}\{p,q\}(x,hD)u + O_{L^2}(h^2).$

The lemma follows since $Pu = o_{L^2}(h)$.

At this point, following the argument in Koch–Tataru–Zworski [13], we work *h*-microlocally. The first step is to reduce the $L^2 \to L^{\infty}$ bounds to a neighbourhood of $\Sigma = \{p = 0\}$.

LEMMA 5.2. — Suppose that u is compactly microlocalized and $Pu = o_{L^2}(h)$. Then for $\chi_{\Sigma} \in C_c^{\infty}(T^*M)$ with $\chi_{\Sigma} \equiv 1$ in a neighborhood of $\Sigma = \{p = 0\},$

(5.1)
$$\|(1 - \chi_{\Sigma}(x, hD))u\|_{L^{\infty}} = o(h^{\frac{2-n}{2}}).$$

Proof. — Since u is compactly microlocalized, there exists $\chi \in C^\infty_c(T^*M)$ so that

$$u = \chi(x, hD)u + O_{\mathcal{S}}(h^{\infty} ||u||_{L^{2}(M)}).$$

For $\chi_{\Sigma} \in C_c^{\infty}(T^*M)$ with $\chi_{\Sigma} \equiv 1$ in a neighborhood of Σ , $|p| \ge c > 0$ on $\operatorname{supp}(1-\chi_{\Sigma})\chi$. Therefore, by the elliptic parametrix construction, for any $q \in S^{\infty}(T^*M)$, there exists $e \in C_c^{\infty}(T^*M)$ so that

$$e(x,hD)P = (1-\chi_{\Sigma})(x,hD)q(x,hD)\chi(x,hD) + O_{\mathcal{D}'\to\mathcal{S}}(h^{\infty})$$

and in particular,

(5.2)
$$(1 - \chi_{\Sigma})(x, hD)q(x, hD)u = o_{L^2}(h).$$

The compact microlocalization of u together with (5.2) (for $q \equiv 1$) and the Sobolev estimate [25, Lemma 7.10] implies

$$\|(1-\chi_{\Sigma}(x,hD))u\|_{L^{\infty}} \leqslant Ch^{-\frac{n}{2}} \|(1-\chi_{\Sigma}(x,hD))u\|_{L^{2}(M)} = o(h^{\frac{2-n}{2}}). \quad \Box$$

To simplify the writing somewhat, we introduce the notation $u_{\Sigma} := \chi_{\Sigma}(x, hD)u$.

5.1. Microlocal L^{∞} bounds near Σ

In view of (5.1), it suffices to consider points in an arbitrarily small tubular neighborhood of $\Sigma = \{p = 0\}$. More precisely, we cover $\sup \chi_{\Sigma}$ by a union $\bigcup_{j=0}^{N} B_j$ of open balls B_j centered at points $(x_j, \xi_j) \in \Sigma \subset \{p = 0\}$. We let $\chi_j \in C_0^{\infty}(B_j)$ be a corresponding partition of unity with

$$u_{\Sigma} = \sum_{j=0}^{N} \chi_j(x, hD) u_{\Sigma} + O_{\mathcal{S}}(h^{\infty})$$

By possible refinement, the supports of χ_i can be chosen arbitrarily small.

Since the argument here is entirely local, it suffices to *h*-microlocalize to supp $\chi_0 \subset B_0$ where B_0 has center $(x_0, \xi_0) \in \{p = 0\}$. Since we have assumed $\partial_{\xi}p \neq 0$ in $\{p = 0\}$, we may assume that $\partial_{\xi_1}p(x_0, \xi_0) \neq 0$ and $\partial_{\xi'}p(x_0, \xi_0) = 0$. Therefore, choosing supp χ supported sufficiently close to (x_0, ξ_0) , it follows from the implicit function theorem that

$$p\chi = e(x,\xi)(\xi_1 - a(x,\xi'))$$

with $e(x,\xi)$ elliptic on supp χ_0 provided the latter support is chosen small enough. Thus,

$$P\chi_0 = E(x, hD)(hD_{x_1} - a(x, hD_{x'}))\chi_0(x, hD) + hR\chi_0(x, hD).$$

Note that by adjusting R, we may assume that for each fixed x_1 , $a(x_1, y, hD_{y'})$ is self adjoint on $L^2_{y'}$. Therefore,

$$(hD_{x_1} - a(x_1, x', hD_{x'}))\chi_0 q(x, hD)u = E^{-1}(x, hD)P\chi_0 q(x, hD)u + hR_1\chi_0(x, hD)q(x, hD)u.$$

In particular, from the standard energy estimate (see for example [13, Lemma 3.1]) with $(x_1, x') \in \mathbb{R}^n$,

(5.3)
$$\begin{aligned} \|\chi_0 q(x,hD) u_{\Sigma}(x_1 = s, \cdot)\|_{L^2_{x'}(\mathbb{R}^{n-1})} \\ &\leqslant \|\chi_0 q(x,hD) u_{\Sigma}(x_1 = t, \cdot)\|_{L^2_{x'}(\mathbb{R}^{n-1})} \\ &+ Ch^{-1} |s - t|^{1/2} (\|P\chi_0 q(x,hD) u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)} \\ &+ h \|R_1 \chi_0 q(x,hD) u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)}). \end{aligned}$$

5.2. Microlocalization to the flowout

Our next goal will be to insert microlocal cutoffs restricting to a neighborhood of $\Lambda_{x_0,\delta}$ for some $\delta > 0$ into the right hand side of (5.3).

Let $\varepsilon \ll \delta$, $\chi_{\varepsilon,x_0} \in C_c^{\infty}(M; [0, 1]))$ with

$$\chi_{\varepsilon,x_0} \equiv 1 \text{ on } B(x_0,\varepsilon), \qquad \operatorname{supp} \chi_{\varepsilon,x_0} \subset B(x_0,2\varepsilon).$$

Let $b_{\varepsilon,x_0} \in C_c^{\infty}(T^*M; [0, 1])$ with

(5.4)
$$\sup b_{\varepsilon,x_0} \cap \{p=0\} \subset \bigcup_{x \in B(x_0,3\varepsilon)} \Lambda_{x,3\delta},$$
$$\sup b_{\varepsilon,x_0} \subset \{q \mid d(q,|p| \leqslant \varepsilon) < 2\varepsilon\},$$

(5.5)
$$b_{\varepsilon,x_0} \equiv 1$$
 on
 $\left\{ q \left| d\left(q, \bigcup_{t=-2\delta}^{2\delta} G_t\left\{(x,\xi) \mid |p(x,\xi)| \leqslant \varepsilon, d(x,x_0) < 2\varepsilon\right\} \right) < \varepsilon \right) \right\}.$

LEMMA 5.3. — There exists $C_0 > 0, \varepsilon_0 > 0$ and U a neighborhood of (x_0, ξ_0) so that for all $\chi_0 \in C_c^{\infty}(T^*M)$ supported in $U, 0 < \varepsilon \ll \delta < \varepsilon_0$, $\chi_{\varepsilon, x_0}, b_{\varepsilon, x_0}$ as above, $q \in S^{\infty}(T^*M)$, and $y_1 \in \mathbb{R}$

(5.6)
$$\| (q\chi_{\varepsilon,x_0}\chi_0)(x,hD)u_{\Sigma}\|_{x_1=y_1} \|_{L^2_{x'}(\mathbb{R}^{n-1})}$$

$$\leq 2\delta_0^{-1/2} \| b_{\varepsilon,x_0}(x,hD)q(x,hD)\chi_0(x,hD)u_{\Sigma} \|_{L^2_x(\mathbb{R}^n)}$$

$$+ C_0\delta_0^{\frac{1}{2}}h^{-1} \| b_{\varepsilon,x_0}(x,hD)Pq(x,hD)\chi_0(x,hD)u_{\Sigma} \|_{L^2_x(\mathbb{R}^n)} + o_{\varepsilon,\delta}(1)$$

where $\delta_0 := \delta |\partial_{\xi} p(x_0, \xi_0)|_g$ and $|\partial_{\xi} p|_g := |\partial_{\xi} p \cdot \partial_x|_g$.

Remark 5.4.

- In (5.6), the local defining functions x_1 depend on j, but we will abuse notation somewhat and suppress the dependence on the index.
- Note that the constant C_0 may depend on P and M in unspecified ways. In order to remove this dependence in Theorem 1.5, we choose δ sufficiently small when applying Lemma 5.3.

Proof. — Let

$$A(x_1, y_1, x', hD_{x'}) := -\int_{y_1}^{x_1} a(s, x', hD_{x'}) \mathrm{d}s$$

and $w = \chi_0 q(x, hD) u_{\Sigma}$. Then

$$w(y_1, x') = e^{-\frac{i}{h}A(t, y_1, x', hD_{x'})} w|_{x_1 = t} - \frac{i}{h} \int_{y_1}^t e^{-\frac{i}{h}A(s, y_1, x', hD_{x'})} f(s, x') \mathrm{d}s$$

where

(5.7)
$$f(x) := E^{-1}(x,hD)P\chi_0q(x,hD)u_{\Sigma} + hR_1\chi_0(x,hD)q(x,hD)u_{\Sigma}.$$

Moreover, since we have arranged that $a(s, x', hD_{x'})$ is self adjoint for each fixed $s, e^{-\frac{i}{h}A(s,y_1,x',hD_{x'})}$ is unitary.

Let $\delta_0 := \delta |\partial_{\xi} p(x_0, \xi_0)|_g$ and $\psi \in C_c^{\infty}(\mathbb{R}; [0, 1])$ with supp $\psi \subset [0, \delta_0]$ and $\int \psi = 1$. Then, integrating in t,

(5.8)
$$w(y_1, x') = \int \psi(t) e^{-\frac{i}{\hbar}A(t, y_1, x', hD_{x'})} w|_{x_1 = t} dt - \frac{i}{\hbar} \int \psi(t) \int_{y_1}^t e^{-\frac{i}{\hbar}A(s, y_1, x', hD_{x'})} f(s, x') ds dt$$

Now, let $\tilde{b}_{\varepsilon,x_0}$ satisfy

(5.9)
$$\widetilde{b}_{\varepsilon,x_0} \equiv 1$$
 on
 $\left\{ q \left| d\left(q, \bigcup_{t=-2\delta}^{2\delta} G_t\left\{(x,\xi) \mid |p(x,\xi)| \leq \varepsilon, d(x,x_0) < 2\varepsilon\right\} \right) < \varepsilon/2 \right) \right\}.$

and have $\operatorname{supp} \tilde{b}_{\varepsilon,x_0} \subset \{b_{\varepsilon,x_0} \equiv 1\}$. This is possible by (5.5). We next aim to prove

(5.10)
$$\begin{aligned} \chi_{\varepsilon,x_0} w(y_1, x') \\ &= \int \psi(t) \chi_{\varepsilon,x_0} e^{-\frac{i}{\hbar} A(t,y_1,x',hD_{x'})} (\widetilde{b}_{\varepsilon,x_0}(x,hD)w)|_{x_1=t} \mathrm{d}t \\ &- \frac{i}{\hbar} \chi_{\varepsilon,x_0} \int \psi(t) \int_{y_1}^t e^{-\frac{i}{\hbar} A(s,y_1,x',hD_{x'})} (\widetilde{b}_{\varepsilon,x_0}(x,hD)f)(s,x') \mathrm{d}s \mathrm{d}t \\ &+ o_{\varepsilon,\delta}(1)_{L^{\infty}_{y_1}L^2_{x'}} \end{aligned}$$

To do this, we show that for $q_1 \in S^0(T^*M), s \in [0, \delta_0]$

(5.11)
$$\chi_{\varepsilon,x_0}(y_1,x')e^{-\frac{i}{h}A(s,y_1,x',hD_{x'})}(I-\widetilde{b}_{\varepsilon,x_0}(x,hD))$$
$$\chi_0(x,hD)q_1(x,hD)u_{\Sigma} = o_{\varepsilon}(h)_{L^2_x}.$$

Let $\varphi \in C_c^{\infty}(\mathbb{R})$ with $\varphi \equiv 1$ on [-1, 1]. By (5.2)

$$\chi_{\varepsilon,x_0}(y_1,x')e^{-\frac{i}{h}A(x_1,x',hD_{x'})}(I-\widetilde{b}_{\varepsilon,x_0}(x,hD))$$

$$\chi_0(x,hD)q_1(x,hD)(I-\varphi(\varepsilon^{-2}p(x,hD)))u_{\Sigma}=o_{\varepsilon}(h)_{L^2_x}.$$

Therefore, we need only estimate

(5.12)
$$\chi_{\varepsilon,x_0}(y_1,x')e^{-\frac{i}{\hbar}A(s,y_1,x',hD_{x'})}(I-\widetilde{b}_{\varepsilon,x_0}(x,hD))$$
$$\chi_0(x,hD)q_1(x,hD)\varphi(\varepsilon^{-2}p(x,hD))u_{\Sigma}.$$

In order to estimate (5.12), we apply propagation of singularities for $e^{-\frac{i}{\hbar}A}$. Let \widetilde{G}_t denote the Hamiltonian flow of $\xi_1 - a(x,\xi')$. We show that for δ small enough and $|t| \leq \delta_0$,

(5.13)
$$\operatorname{supp} \chi_{\varepsilon, x_0} \cap \widetilde{G}_t(\operatorname{supp}(1 - \widetilde{b}_{\varepsilon, x_0})\varphi(\varepsilon^{-2}p)\chi_0) = \emptyset.$$

Since supp $\psi \subset [0, \delta_0]$ propagation of singularities then implies that

(5.14)
$$\psi(s)\chi_{\varepsilon,x_0}(y_1,x')e^{-\frac{i}{h}A(s,y_1,x',hD_{x'})}(I-\widetilde{b}_{\varepsilon,x_0}(x,hD))$$
$$q_1(x,hD)\varphi(\varepsilon^{-2}p(x,hD))u_{\Sigma} = O_{\varepsilon}(h^{\infty})_{L^2_x}.$$

We now prove (5.13). For $p(y_0, \eta_0) = 0$, if $G_t(y_0, \eta_0) = (x_1(t), x'(t), \xi(t))$, then $\widetilde{G}_{x_1(t)}(y_0, \eta_0) = (x_1(t), x'(t), \xi(t))$. Since we assume that $\partial_{\xi'} p(x_0, \xi_0) = 0$, $\partial_{\xi_1} p(x_0, \xi_0) \neq 0$ we may choose U small enough so that for $q \in U$

$$\frac{2}{3}|\partial_{\xi}p(x_0,\xi_0)|_g \leqslant |\partial_{\xi_1}p(q)| \leqslant \frac{3}{2}|\partial_{\xi}p(x_0,\xi_0)|_g.$$

Thus, for $q \in \operatorname{supp} \chi_0$,

$$\frac{2}{3}|\partial_{\xi}p(x_0,\xi_0)|_g t + O(t^2) \leq |x_1(G_t(q)) - x_1(q)| \leq \frac{3}{2}|\partial_{\xi}p(x_0,\xi_0)|_g t + O(t^2)$$

Now, suppose $q \in \{|p| \leq C\varepsilon^2\} \cap \operatorname{supp} \chi_0$ so that $\widetilde{G}_t(q) \in \operatorname{supp} \chi_{\varepsilon,x_0}$ for some $|t| \leq \delta_0$. Then, there exists $t \in [-2\delta, 2\delta]$ and C > 0 such that

$$d(x(G_t(q)), x_0) \leq \varepsilon + C\varepsilon^2.$$

In particular, by (5.9), $\tilde{b}_{\varepsilon,x_0} \equiv 1$ in a neighborhood of q and hence $q \notin \operatorname{supp}(1 - \tilde{b}_{\varepsilon,x_0})$. In particular, this proves (5.13) and hence (5.14).

Together (5.12) and (5.14) give (5.11) and in particular, applying (5.11) with $q_1 = 1$ for the first term in (5.8) and

$$q_1 = E^{-1}(x, hD) P\chi_0 q(x, hD) + hR_1 \chi_0(x, hD) q(x, hD).$$

for the second term in (5.8) gives (5.10). In turn, (5.10) implies

$$\begin{split} \|\chi_{\varepsilon,x_0}w(y_1,\cdot)\|_{L^2_{x'}(\mathbb{R}^{n-1})} \\ &\leqslant \delta_0^{-1/2} \|\widetilde{b}_{\varepsilon,x_0}(x,hD)w\|_{L^2_x(\mathbb{R}^n)} + C_0 \delta_0^{\frac{1}{2}} h^{-1} \|\widetilde{b}_{\varepsilon,x_0}(x,hD)f\|_{L^2_x(\mathbb{R}^n)} + o_{\varepsilon,\delta}(1). \\ &\text{Now,} \end{split}$$

$$\begin{aligned} q(x,hD)\chi_{\varepsilon,x_0}\chi_0(x,hD)u_{\Sigma} &= \chi_{\varepsilon,x_0}\chi_0(x,hD)q(x,hD)u_{\Sigma} \\ &+ [q(x,hD),\chi_{\varepsilon,x_0}\chi_0(x,hD)]u_{\Sigma}. \end{aligned}$$

Therefore, applying the Sobolev embedding [25, Lemma 7.10] in 1 dimension

$$\|[q(x,hD),\chi_{\varepsilon,x_0}\chi_0(x,hD)]u_{\Sigma}(x_1,\cdot)\|_{L^2_{x'}(\mathbb{R}^{n-1})} = O_{\varepsilon}(h^{1/2}),$$

we have the following L^2 bound along the section $x_1 = y_1$ of supp $\chi_0 \subset$ supp χ_{Σ} .

(5.15)
$$\|q(x,hD)\chi_{\varepsilon,x_0}\chi_0(x,hD)u_{\Sigma}(y_1,\cdot)\|_{L^2_{x'}(\mathbb{R}^{n-1})}$$
$$\leq \delta_0^{-1/2} \|\widetilde{b}_{\varepsilon,x_0}(x,hD)w\|_{L^2_x(\mathbb{R}^n)}$$
$$+ C_1 \delta_0^{1/2} h^{-1} \|\widetilde{b}_{\varepsilon,x_0}(x,hD)f\|_{L^2_x(\mathbb{R}^n)} + o_{\varepsilon,\delta}(1).$$

Observe that,

$$\begin{split} \|\widetilde{b}_{\varepsilon,x_{0}}(x,hD)f\| \\ &\leqslant \|\widetilde{b}_{\varepsilon,x_{0}}(x,hD)E^{-1}(x,hD)P\chi_{0}q(x,hD)u_{\Sigma}\| \\ &\quad + h\|\widetilde{b}_{\varepsilon,x_{0}}(x,hD)R_{1}\chi_{0}(x,hD)q(x,hD)u_{\Sigma}\| \\ &\leqslant C_{2}\|b_{\varepsilon,x_{0}}(x,hD)P\chi_{0}(x,hD)q(x,hD)u_{\Sigma}\| \\ &\quad + C_{2}h\|b_{\varepsilon,x_{0}}(x,hD)\chi_{0}(x,hD)q(x,hD)u_{\Sigma}\| + o_{\varepsilon,\delta}(h) \end{split}$$

and

$$\|\widetilde{b}_{\varepsilon,x_0}(x,hD)w\|_{L^2_x(\mathbb{R}^n)} \leqslant \|b_{\varepsilon,x_0}(x,hD)\chi_0(x,hD)q(x,hD)u_{\Sigma}\| + o_{\varepsilon,\delta}(1).$$

Taking $\varepsilon_0 > 0$ so small so that for $\delta < \varepsilon_0$, $C_1 C_2 \delta_0^{1/2} \leq \delta_0^{-1/2}$, and letting $C_0 = C_1 C_2$ we have

(5.16)
$$\|q(x,hD)\chi_{\varepsilon,x_0}\chi_0(x,hD)u_{\Sigma}(y_1,\cdot)\|_{L^2_{x'}(\mathbb{R}^{n-1})}$$

 $\leq 2\delta_0^{-1/2}\|b_{\varepsilon,x_0}(x,hD)\chi_0(x,hD)q(x,hD)u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)}$
 $+ C_0\delta_0^{1/2}h^{-1}\|b_{\varepsilon,x_0}(x,hD)P\chi_0(x,hD)q(x,hD)u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)}$
 $+ o_{\varepsilon,\delta}(1).$

LEMMA 5.5. — Suppose that for some $\delta > 0$, $q \in S^0(T^*M)$ has $q \equiv 0$ on $\Lambda_{x_0,3\delta}$. Then for r(h) = o(1).

$$\limsup_{h \to 0} h^{\frac{n-1}{2}} \|q(x,hD)u_{\Sigma}\|_{L^{\infty}(B(x_0,r(h)))} = 0.$$

Proof. — Observe that Lemma 5.3 gives for each j = 1, ..., N,

$$\begin{aligned} \|(q\chi_{\varepsilon,x_0}\chi_j)(x,hD)u_{\Sigma}\|_{x_1=y_1}\|_{L^2_{x'}(\mathbb{R}^{n-1})} \\ &\leqslant 2\delta_0^{-1/2}\|b_{\varepsilon,x_0}(x,hD)q(x,hD)\chi_j(x,hD)u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)} \\ &+ C_0\delta_0^{\frac{1}{2}}h^{-1}\|b_{\varepsilon,x_0}(x,hD)Pq(x,hD)\chi_j(x,hD)u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)} + o_{\varepsilon,\delta}(1). \end{aligned}$$

Observe that since r(h) = o(1), for h small enough, $\chi_{\varepsilon,x_0} \equiv 1$ on $B(x_0, r(h))$. Hence, applying the Sobolev estimate [25, Lemma 7.10] and Lemma 5.1 gives

$$\begin{split} \limsup_{h \to 0} h^{n-1} \| (q\chi_j)(x,hD) u_{\Sigma} \|_{L^{\infty}(B(x_0,r(h)))}^2 \\ &\leqslant 2\delta_0^{-1} \int b_{\varepsilon,x_0}^2(x,hD) q^2(x,hD) \chi_j^2 \mathrm{d}\mu \\ &+ C_0 \delta_0 \int b_{\varepsilon,x_0}^2(x,hD) |H_p(q(x,hD)\chi_j)|^2 \mathrm{d}\mu. \end{split}$$

Sending $\varepsilon \to 0$ and using the dominated convergence theorem proves the lemma since $\mu(T^*M) = 1 < \infty$, $\lim_{\varepsilon \to 0} b_{\varepsilon,x_0}^2 \leq 1_{\Lambda_{x_0,3\delta}}$, H_p is tangent to Λ_{x_0} , and so the fact that q vanishes identically on $\Lambda_{x_0,3\delta}$ implies the same for H_pq .

6. Decomposition into wave packets

We now choose a convenient partition χ_j and functions $q_{j,i}$, i = 2, ..., n to prove the main theorem. The χ_j localize to individual bicharacteristics, and $\sum_i q_{j,i}$ will measure concentration in neighborhoods of each bicharacteristic. We then show that understanding the mass localization to finer and finer neighborhoods of geodesics yields the structure of the defect measure.

6.1. L^{∞} contributions near bicharacteristics

We need the following version of the L^{∞} Sobolev embedding.

LEMMA 6.1. — There exists $C_{n,l} > 0$ depending only on n and l so that for all $v \in H^{l}(\mathbb{R}^{n-1})$ with l > (n-1)/2 and all $\varepsilon > 0$

$$\|v\|_{L^{\infty}}^{2} \leqslant C_{n,l}h^{-n+1}\left(\varepsilon^{n-1}\|v\|_{L^{2}}^{2} + \varepsilon^{n-2l-1}\sum_{i=1}^{n-1}\|(hD_{x_{i}})^{l}v\|_{L^{2}}^{2}\right).$$

In particular this holds if v is compactly microlocalized.

Proof. — Let $\zeta \in C_c^{\infty}([-2, 2])$ with $\zeta \equiv 1$ on [-1, 1] and $\zeta_{\varepsilon}(x) = \zeta(\varepsilon^{-1}x)$. Then

$$v(x) = (2\pi h)^{-n+1} \int e^{i\langle x,\xi\rangle/h} [\zeta_{\varepsilon}(|\xi|) + (1 - \zeta_{\varepsilon}(|\xi|))] \mathcal{F}_{h}(v)(\xi) \mathrm{d}\xi$$

Applying the triangle inequality and Cauchy–Schwarz, and letting $w_l(\xi) = \sqrt{\sum_{i=1}^{n-1} \xi_i^{2l}}$

(6.1)

$$\|v\|_{L^{\infty}}^{2} \leqslant h^{-2(n-1)}(\varepsilon^{n-1}\|\zeta\|_{L^{2}}^{2}\|\mathcal{F}_{h}v\|_{L^{2}}^{2} + \|(1-\zeta_{\varepsilon})w_{l}^{-1}\|_{L^{2}}^{2}\|w_{l}\mathcal{F}_{h}v\|_{L^{2}}^{2})$$

Now,

$$\|(1-\zeta_{\varepsilon})w_{l}^{-1}\|_{L^{2}}^{2} = \varepsilon^{n-2l-1}\|(1-\zeta)w_{l}^{-1}\|_{L^{2}}^{2}$$
$$\|w_{l}\mathcal{F}_{h}v\|_{L^{2}}^{2} = \int \sum_{i=1}^{n-1} \xi_{i}^{2l}|\mathcal{F}_{h}v(\xi)|^{2}\mathrm{d}\xi = \sum_{i=1}^{n-1} \|\mathcal{F}_{h}(hD_{x_{i}}^{l}v)\|_{L^{2}}^{2}.$$

Using this in (6.1) together with the fact that by Parseval's theorem for $u \in L^2$, $\|\mathcal{F}_h u\|_{L^2} = (2\pi h)^{\frac{n-1}{2}} \|u\|_{L^2}$ proves the Lemma.

LEMMA 6.2. — There exists $C_n > 0$ depending only on $n, \delta_1 > 0$ and $r_0 > 0$ so that for $0 < \delta < \delta_1$ if $(x_0, \xi_j) \in \Sigma_{x_0}, 0 < r < r_0$ and $\chi_j \in C_c^{\infty}(T^*M)$ with

$$\operatorname{supp} \chi_j \cap \Lambda_{x_0} \subset T_{4\delta}(\xi_j, r), \qquad H_p \chi_j \equiv 0, \text{ on } \Lambda_{x_0, 3\delta}$$

where $T_{4\delta}(\xi_j, r)$ is as in (3.6). Then

(6.2)
$$\lim_{h \to 0} \sup h^{n-1} \|\chi_j u_{\Sigma}\|_{L^{\infty}(B(x_0, r(h)))}^2 \leq C_n \delta^{-1} |\partial_{\xi} p(x_0, \xi_j)|_g^{-1} r^{n-1} \int_{\Lambda_{x_0, 3\delta}} \chi_j^2 \mathrm{d}\mu.$$

Proof. — Let $a_{j,i}(x_1)$, i = 2, ..., n so that $\xi_i - a_{j,i}(x_1)$ vanishes on the bicharacteristic emanating from (x_0, ξ_j) . This is possible since we have chosen coordinates so that $\partial_{\xi_1} p(x_0, \xi_j) \neq 0$ and hence a bicharacteristic may be written locally as

$$\gamma = \{ (x,\xi) \mid x_1 \in (-3\delta, 3\delta), \, x' = x'(x_1), \, \xi = a(x_1) \}.$$

Let 2l > n-1 and $q_{j,i} = (\xi_i - a_i(x_1))^l$. Then, using $q = q_{j,i}$ in (5.6) gives

$$\begin{aligned} \|(hD_{x_{i}} - a_{i}(x_{1}))^{l}\chi_{\varepsilon,x_{0}}\chi_{j}(x,hD)u_{\Sigma}(x_{1},\cdot)\|_{L^{2}_{x'}(\mathbb{R}^{n-1})} \\ &\leq 2\delta_{0}^{-1/2}\|b_{\varepsilon,x_{0}}(x,hD)q_{j,i}(x,hD)\chi_{j}(x,hD)u_{\Sigma}\|_{L^{2}_{x}(\mathbb{R}^{n})} \\ &+ C_{0}\delta_{0}^{1/2}h^{-1}\|b_{\varepsilon,x_{0}}(x,hD)Pq_{j,i}(x,hD)\chi_{j}(x,hD)u_{\Sigma}\|_{L^{2}_{x}(\mathbb{R}^{n})} + o_{\varepsilon,\delta}(1) \end{aligned}$$

where $|\partial_{\xi}p|_g = |\partial_{\xi}p \cdot \partial_x|_g$. Next, q = 1 in (5.6) gives

$$\begin{aligned} \|\chi_{\varepsilon,x_0}\chi_j u_{\Sigma}\|_{L^2_{x'}} &\leqslant 2\delta_0^{-1/2} \|b_{\varepsilon,x_0}(x,hD)\chi_j(x,hD)u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)} \\ &+ C_0\delta_0^{1/2}h^{-1}\|b_{\varepsilon,x_0}(x,hD)P\chi_j u_{\Sigma}\|_{L^2_x(\mathbb{R}^n)} + o_{\varepsilon,\delta}(1). \end{aligned}$$

Therefore, letting $w = e^{-i\langle x', a_j(x_1)\rangle/h} \chi_{\varepsilon, x_0} \chi_j u$ with $a_j(x_1) = (a_{j,2}(x_1), \ldots, a_{j,n}(x_1))$ we see that

$$\begin{aligned} \|(hD_{x_{i}})^{l}w\|_{L^{2}_{x'}} &\leq 2\delta_{0}^{-1/2} \|b_{\varepsilon,x_{0}}q_{j,i}\chi_{j}u_{\Sigma}\|_{L^{2}_{x}(\mathbb{R}^{n})} \\ &+ C_{0}\delta_{0}^{1/2}h^{-1}\|b_{\varepsilon,x_{0}}Pq_{j,i}\chi_{j}u_{\Sigma}\|_{L^{2}_{x}(\mathbb{R}^{n})} + o_{\varepsilon,\delta}(1) \end{aligned}$$

and

$$||w||_{L^{2}_{x'}} \leq 2\delta_{0}^{-1/2} ||b_{\varepsilon,x_{0}}\chi_{j}u_{\Sigma}||_{L^{2}_{x}(\mathbb{R}^{n})} + C_{0}\delta_{0}^{1/2}h^{-1} ||b_{\varepsilon,x_{0}}P\chi_{j}u_{\Sigma}||_{L^{2}_{x}(\mathbb{R}^{n})} + o_{\varepsilon,\delta}(1).$$

Applying Lemma 6.1 to w (with $\varepsilon = \alpha$) and using the fact that $||w||_{L^{\infty}} = ||\chi_{\varepsilon,x_0}\chi_j u_{\Sigma}||_{L^{\infty}}$ gives for any $\alpha > 0$ and r(h) = o(1)

$$\begin{split} \limsup_{h \to 0} h^{n-1} \|\chi_{j} u_{\Sigma}\|_{L^{\infty}(B(x_{0}, r(h)))}^{2} \\ \leqslant C_{n,l} \alpha^{n-1} \left(\limsup_{h \to 0} \left[4\delta_{0}^{-1} \|b_{\varepsilon, x_{0}} \chi_{j} u_{\Sigma}\|_{L^{2}_{x}}^{2} + C_{0}^{2} \delta_{0} h^{-2} \|b_{\varepsilon, x_{0}} P\chi_{j} u_{\Sigma}\|_{L^{2}_{x}}^{2} \right] \right) \\ + C_{n,l} \alpha^{n-2l-1} \left(\sum_{i=2}^{n} \limsup_{h \to 0} \left[4\delta_{0}^{-1} \|b_{\varepsilon, x_{0}} q_{j,i} \chi_{j} u_{\Sigma}\|_{L^{2}_{x}}^{2} \right. \\ \left. + C_{0}^{2} \delta_{0} h^{-2} \|b_{\varepsilon, x_{0}} Pq_{j,i} \chi_{j} u_{\Sigma}\|_{L^{2}_{x}}^{2} \right] \right) \end{split}$$

In particular, applying Lemma 5.1,

$$\begin{split} \limsup_{h \to 0} h^{n-1} \|\chi_j u_{\Sigma}\|_{L^{\infty}(B(x_0, r(h)))}^2 \\ &\leqslant C_{n,l} \alpha^{n-1} \int b_{\varepsilon, x_0}^2 (4\delta_0^{-1}\chi_j^2 + C_0^2 \delta_0 |H_p \chi_j|^2) \mathrm{d}\mu \\ &+ C_{n,l} \alpha^{n-2l-1} \sum_{i=2}^n \int b_{\varepsilon, x_0}^2 (4\delta_0^{-1}\chi_j^2 q_{j,i}^2 + C_0^2 \delta_0 |H_p \chi_j q_{i,j}|^2) \mathrm{d}\mu. \end{split}$$

Observe that by (5.4) together with $0 \leq b_{\varepsilon,x_0}^2 \leq 1$, we have

$$\lim_{\varepsilon \to 0} b_{\varepsilon, x_0}^2 \leqslant 1_{\Lambda_{x_0, 3\delta}}.$$

Sending $\varepsilon \to 0$ and using $H_p \chi_j = 0$ on $\Lambda_{x_0,3\delta}$ (together with $\mu(T^*M) = 1$ to apply the dominated convergence theorem) we have

(6.3)
$$\limsup_{h \to 0} h^{n-1} \|\chi_j u_{\Sigma}\|_{L^{\infty}(B(x_0, r(h)))}^2 \leq C_{n,l} 4\delta_0^{-1} \alpha^{n-1} \int_{\Lambda_{x_0,3\delta}} \chi_j^2 d\mu + C_{n,l} \alpha^{n-2l-1} \sum_{i=2}^n \int_{\Lambda_{x_0,3\delta}} \chi_j^2 (4\delta_0^{-1} q_{j,i}^2 + C_0^2 \delta_0 |H_p q_{i,j}|^2) d\mu$$

Now, χ_j is supported on $T_{4\delta}(\xi, r)$ (see (3.6)). Letting γ be the bicharacteristic through (x, ξ) , we have by (3.1) that for $\delta < \frac{\delta_{M,p}}{3}$ and $r < C_1^{-1}$ small enough

$$\sup\{d((x,\xi_1),\gamma) \mid (x,\xi_1) \in T_{4\delta}(\xi,r) \cap \Lambda_{x_0,3\delta}\} \leqslant 3r.$$

Hence, since $H_p(\xi_i - a_i(x_1)) \equiv 0$ on γ , $H_pq_{j,i} = l(\xi_i - a_i(x_1))^{l-1}H_p(\xi_i - a_i(x_1))$ vanishes to order l on γ and there exists $C_2 > 0$ so that

$$\sup_{T_{4\delta}(\xi,r)\cap\Lambda_{x_0,3\delta}}|H_pq_{j,i}|\leqslant C_2r^l.$$

Furthermore, by (3.1) for $\eta \in B(\xi, r)$, and (3.2)

$$\begin{aligned} |\xi_i(G_t(x_0,\eta)) - \xi_i(G_t(x_0,\xi))| &\leq 2r + C_1 r^2, \\ a_i(x_1(G_t(x_0,\eta))) - a_i(x_1(G_t(x_0,\xi)))| &\leq C_3 C_1 \delta r. \end{aligned}$$

Therefore,

$$\sup_{T_{4\delta}(\xi,r)\cap\Lambda_{x_0,3\delta}}|q_{j,i}|\leqslant r^l(2+C_1C_3\delta+C_1r)^{\delta}$$

In particular,

$$\chi_j^2 (4\delta_0^{-1}q_{j,i}^2 + C_0^2\delta_0 |H_p q_{i,j}|^2) \leqslant r^{2l} \Big[4\delta_0^{-1} \big(2 + C_1 C_3 \delta + C_1 r\big)^{2l} + \delta_0 C_0^2 C_2^2 \Big] \chi_j^2$$

Thus, letting $\delta_1 < \min(C_1^{-1}C_3^{-1}, (C_0C_2 \sup |\partial_{\xi}p|_q)^{-1}, \widetilde{\delta})$ and $r_0 < C_1^{-1}$ we obtain

$$\chi_j^2(4\delta_0^{-1}q_{j,i}^2 + C_0^2\delta_0 |H_p q_{i,j}|^2) \leqslant \delta_0^{-1} r^{2l} \left(1 + 4^{2l+1}\right) \chi_j^2.$$

Using this in (6.3) that

$$\begin{split} \limsup_{h \to 0} h^{n-1} \|\chi_j u_{\Sigma}\|_{L^{\infty}(B(x_0, r(h)))}^2 \\ \leqslant C_{n,l} \delta_0^{-1} \int_{\Lambda_{x_0, 3\delta}} \chi_j^2 (4\alpha^{n-1} + \alpha^{n-2l-1}(n-1)(4^{2l+1} + 1)r^{2l}) \mathrm{d}\mu. \end{split}$$

Choosing $\alpha = r$ and fixing l = n gives (6.2).

We now find an appropriate cover of Λ_{x_0} that is adapted to μ_{x_0} .

6.2. Decomposition of Λ_{x_0}

Proof of Theorem 1.5. — Recall that

$$\mu_{x_0} = \rho_{x_0} + f \mathrm{d}\mathcal{H}^n_{x_0}$$

where $\rho_{x_0} \perp \mathcal{H}_{x_0}^n$ and μ_{x_0} is invariant under G_t . Therefore, by Lemma 3.2, ρ_{x_0} and $f d\mathcal{H}_{x_0}^n$ are invariant under G_t .

Fix $0 < \varepsilon \ll \delta$ arbitrary. By Lemma 3.3, with δ replaced by 4δ there exist $((x_0,\xi_i),r_i) \in \Sigma_{x_0} \times \mathbb{R}_+$ satisfying (3.7). Let K be large enough so that

(6.4)
$$\rho_{x_0}\left(\Lambda_{x_0,4\delta}\setminus \bigcup_{j=1}^K T_{4\delta}(\xi_j,r_j)\right) < \varepsilon.$$

Let $\chi_j \in C_c^{\infty}(T^*M; [0, 1])$ satisfy (4.1) for $((x_0, \xi_j), r_j)$ j = 1, ... K.

Define $\psi = 1 - \sum \chi_j$. Applying Lemma 6.2 (with $\xi = \xi_j$, $r = r_j$, $\chi = \chi_j$), summing and using the triangle inequality, we have

(6.5)
$$\limsup_{h \to 0} h^{\frac{n-1}{2}} \| (1 - \psi(x, hD)) u_{\Sigma} \|_{L^{\infty}(B(x_0, r(h)))}$$
$$\leqslant C_{n,\delta} \sum_{j=1}^{K} r_j^{(n-1)/2} \left(\int_{\Lambda_{x_0}} \chi_j^2 \mathrm{d}\mu \right)^{1/2}$$
$$\leqslant C_{n,\delta} \left(\sum_j r_j^{n-1} \right)^{1/2} \left(\int_{\Lambda_{x_0}} \sum_j \chi_j^2 \mathrm{d}\mu \right)^{1/2}$$
$$\leqslant C_{n,\delta} \varepsilon^{1/2} \mu(\Lambda_{x_0, 4\delta})$$

where in the last line we use $0 \leq \chi_j \leq 1$ and $0 \leq \sum \chi_j \leq 1$.

Next we estimate $\psi(x, hD)u_{\Sigma}$. By the Besicovitch–Federer Covering Lemma [10, Theorem 1.14, Example (c)], there exists a constant C_n depending only on n and $\gamma_0 = \gamma_0(\Sigma_{x_0})$ so that for all $0 < \gamma < \gamma_0$, there exists $\xi_1, \ldots, \xi_{N(\gamma)}$ with $N(\gamma) \leq C \gamma^{1-n}$ so that

$$\Sigma_{x_0} \subset \bigcup_{j=1}^{N(\gamma)} B(\xi_k, \gamma)$$

and each point in Σ_{x_0} lies in at most C_n balls $B(\xi_k, \gamma)$. Let ψ_k , $k = 1, \ldots N(\gamma)$ satisfy (4.1), (4.3) (with $\xi_j = \xi_k$, $2r_j = \gamma$, and $K = N(\gamma)$). Observe that applying Lemma 6.2 (with $\xi = \xi_k$, $r = \gamma$, and $\chi_j = \psi_k \psi$),

$$\begin{split} \limsup_{h \to 0} h^{n-1} \| \psi(x, hD) \psi_k(x, hD) u_{\Sigma} \|_{L^{\infty}(B(x_0, r(h)))}^2 \\ &\leqslant C_n \delta^{-1} |\partial_{\xi} p(x_0, \xi_k)|_g^{-1} \int_{\Lambda_{x_0, 3\delta}} \psi_k^2 \psi^2 \gamma^{n-1} \mathrm{d} \mu \end{split}$$

Notice that

$$\sum_{k} \psi \psi_k \equiv 1 \text{ on } \Lambda_{x_0, 3\delta}$$

and therefore Lemma 5.5 implies

$$\limsup_{h \to 0} h^{\frac{n-1}{2}} \left\| \psi(x, hD) \left[1 - \sum_{k} \psi_k(x, hD) \right] u_{\Sigma} \right\|_{L^{\infty}(B(x_0, r(h)))} = 0.$$

So, applying the triangle inequality,

$$\begin{split} \limsup_{h \to 0} h^{\frac{n-1}{2}} \left\| \psi(x, hD) u_{\Sigma} \right\|_{L^{\infty}(B(x_0, r(h)))} \\ &\leqslant C_{n,\delta} \sum_k \left(\int_{\Lambda_{x_0,3\delta}} \psi_k^2 \psi^2 \gamma^{n-1} \mathrm{d}\rho_{x_0} \right)^{1/2} \\ &+ C_n \delta^{-1/2} \sum_k \left(\int_{\Lambda_{x_0,3\delta}} |\partial_{\xi} p(x_0, \xi_k)|_g^{-1} \psi_k^2 \psi^2 \gamma^{n-1} f \mathrm{d}\mathcal{H}_{x_0}^n \right)^{1/2} \\ &=: C_{n,\delta} I + II \end{split}$$

Use (6.4) to estimate

$$I \leqslant C\gamma^{\frac{n-1}{2}} N(\gamma)^{1/2} \left(\int_{\Lambda_{x_0,3\delta}} \sum_k \psi_k^2 \psi^2 \mathrm{d}\rho_{x_0} \right)^{1/2}$$
$$\leqslant C\rho_{x_0} \left(\Lambda_{x_0,3\delta} \setminus \bigcup_{j=1}^K T_{4\delta}(\xi_j, r_j) \right)^{1/2} \leqslant C\varepsilon^{1/2}.$$

Now, using that $f d\mathcal{H}_{x_0}^n$ is G_t invariant and applying Lemma 3.4

$$II \leq C_n \sum_k \left(\int_{\Sigma_{x_0}} |\partial_{\xi} p(x_0, \xi_k)|_g^{-1} \psi_k^2 \psi^2 \gamma^{n-1} f(0, q) |\nu(H_p)|(0, q) \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \right)^{1/2} .$$

Define for $0 \leq \theta \in L^1(\operatorname{vol}_{\Sigma_{x_0}})$

$$T_{\gamma}\theta := C_n \sum_k \left(\int_{\Lambda_{x_0,3\delta}} |\partial_{\xi} p(x_0,\xi_k)|_g^{-1} \psi_k^2 \psi^2 \gamma^{n-1} \\ \theta(0,q) |\nu(H_p)|(0,q) \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}} \right)^{1/2}.$$

Then,

$$T_{\gamma}\theta \leqslant C_{n}N(\gamma)^{\frac{1}{2}}\gamma^{\frac{n-1}{2}} \\ \left(\int \sum_{k} |\partial_{\xi}p(x_{0},\xi_{k})|_{g}^{-1}\psi_{k}^{2}\psi^{2}\theta(0,q)|\nu(H_{p})|(0,q)\mathrm{d}\operatorname{vol}_{\Sigma_{x_{0}}}\right)^{1/2} \\ \leqslant C\|\theta\|_{L^{1}}^{1/2}$$

where C is independent of γ .

Now, suppose that $\theta \ge 0$ is continuous. For γ small enough, $C_n^{-1}\gamma^{n-1} \le \operatorname{vol}_{\Sigma_{x_0}}(B(\xi_k,\gamma)) \le C_n\gamma^{n-1}$, where C_n depends only on n. To see this, recall that on any compact Riemannian manifold \widetilde{M} of dimension n-1, there is C_n depending only on n and C > 0 depending on \widetilde{M} so that for all $q \in \widetilde{M}$

$$|\operatorname{vol}_{\widetilde{M}}(B(q,\gamma)) - C_n \gamma^{n-1}| \leq C \gamma^n.$$

This follows from computing in geodesic normal coordinates. In fact, C depends only on bounds on the curvature of \widetilde{M} .

Using this, we have

$$\begin{split} T_{\gamma}\theta \leqslant C_n \int_{\Sigma_{x_0}} \sum_k \mathbf{1}_{B(\xi_k,\gamma)} \Biggl(\frac{1}{|\partial_{\xi} p(x_0,\xi_k)|_g \operatorname{vol}_{\Sigma_{x_0}}(B(\xi_k,\gamma))} \\ \int_{B(\xi_k,\gamma)} \theta(0,q) |\nu(H_p)|(0,q) \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \Biggr)^{1/2} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \end{split}$$

Now, as discussed in Remark 1.6, we may assume Σ_{x_0} is compact. Then, since θ , the metric, g, and p are continuous, they are uniformly continuous. In particular, for any $\varepsilon_0 > 0$ there exists γ small enough so that for all

$$\begin{split} \left(\frac{1}{|\partial_{\xi}p(x_0,\xi)|_g \operatorname{vol}_{\Sigma_{x_0}}(B(\xi,\gamma))} \int_{B(\xi,\gamma)} \theta(0,q) |\nu(H_p)|(0,q) \operatorname{dvol}_{\Sigma_{x_0}}\right)^{1/2} \\ &\leqslant \sqrt{\frac{\theta|\nu(H_p)|}{|\partial_{\xi}p|_g}}(q_0) + \frac{\varepsilon_0}{\operatorname{vol}_{\Sigma_{x_0}}}. \end{split}$$

Thus,

$$T_{\gamma}\theta \leqslant C_n \int \sqrt{\frac{\theta|\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}} + C_n \varepsilon_0.$$

Next, let $\theta_m \ge 0$ continuous with $\theta_m \to f$ in L^1 . We may assume by taking a subsequence that $\theta_m \to f$ a.e. Fix $\varepsilon_0 > 0$. Then since $\sqrt{a+b} \le \sqrt{a} + \sqrt{b}$,

$$|T_{\gamma}f| \leq T_{\gamma}|f - \theta_m| + T_{\gamma}\theta_m \leq C||f - \theta_m||_{L^1}^{1/2} + T_{\gamma}\theta_m.$$

For $m \ge M$, $C \| f - \theta_m \|_{L^1}^{1/2} \le \varepsilon_0$ and hence

$$|T_{\gamma}f| \leqslant \varepsilon_0 + T_{\gamma}\theta_m.$$

Now,

$$\begin{split} \int \sqrt{\frac{\theta_m |\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \\ &= \int \left[\sqrt{\frac{\max(\theta_m, 1) |\nu(H_p)|}{|\partial_{\xi}p|_g}} \right] \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \\ &+ \int \mathbf{1}_{\theta_m \geqslant 1} \left[\sqrt{\frac{\theta_m |\nu(H_p)|}{|\partial_{\xi}p|_g}} - \sqrt{\frac{|\nu(H_p)|}{|\partial_{\xi}p|_g}} \right] \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \,. \end{split}$$

Observe next that $\max(\theta_m,1) \to \max(f,1)$ a.e. and by the dominated convergence theorem,

$$\int \left[\sqrt{\frac{\max(\theta_m, 1)|\nu(H_p)|}{|\partial_{\xi}p|_g}} \right] \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \to \int \left[\sqrt{\frac{\max(f, 1)|\nu(H_p)|}{|\partial_{\xi}p|_g}} \right] \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}.$$

Next,

$$\begin{split} \left| \int \mathbf{1}_{\theta_m \geqslant 1} \left[\sqrt{\frac{\theta_m |\nu(H_p)|}{|\partial_{\xi}p|_g}} - \sqrt{\frac{f |\nu(H_p)|}{|\partial_{\xi}p|_g}} \right] \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \right| \\ &= \left| \int \mathbf{1}_{\theta_m \geqslant 1} \frac{(\theta_m - f) \sqrt{|\nu(H_p)|}}{\sqrt{|\partial_{\xi}p|_g} (\sqrt{\theta_m} + \sqrt{f})} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \right| \\ &\leq C \|\theta_m - f\|_{L^1}. \end{split}$$

In particular, this proves that

$$\int \sqrt{\frac{\theta_m |\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d}\,\mathrm{vol}_{\Sigma_{x_0}} \to \int \sqrt{\frac{f |\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d}\,\mathrm{vol}_{\Sigma_{x_0}} \,.$$

Therefore, for $m \ge M_1$,

$$\int \sqrt{\frac{\theta_m |\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} \leqslant \int \sqrt{\frac{f |\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} + \varepsilon_0.$$

Let $m \ge \max(M, M_1)$ and choose γ small enough so that

$$T_{\gamma}\theta_m \leqslant C_n \int \sqrt{\frac{\theta_m |\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}} + \varepsilon_0.$$

Then,

$$T_{\gamma}f \leqslant \varepsilon_0 + T_{\gamma}\theta_m \leqslant 2\varepsilon_0 + C_n \int \sqrt{\frac{f|\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d}\operatorname{vol}_{\Sigma_{x_0}} + C_n\varepsilon_0.$$

In particular,

$$\limsup_{\gamma \to 0} II = \limsup_{\gamma \to 0} T_{\gamma} f \leqslant C_n \int \sqrt{\frac{f|\nu(H_p)|}{|\partial_{\xi}p|_g}} \mathrm{d} \operatorname{vol}_{\Sigma_{x_0}}$$

Therefore, sending $h \to 0$ then $\gamma \to 0$ and finally $\varepsilon \to 0$ proves the theorem.

7. Construction of Modes - Proof of Theorem 1.8

Proof of Theorem 1.8. — We apply the construction in [19, Lemma 7]. Let $p = \frac{1}{2}(|\xi|_g^2 - 1)$ and $G_t = \exp(tH_p)$ so that $G_t|_{S^*M}$ is the unit speed geodesic flow. Let $g_1 \in L^2(S^*_{z_0}M)$ have $|g_1|^2 = f|_{S^*_{z_0}M}$ and $g_{1,\varepsilon} \in C^{\infty}(S^*_{z_0}M)$ have $|g_{1,\varepsilon} - g_1||_{L^2(S^*_{z_0}M)} < \varepsilon$. For $A \subset S^*_{z_0}M$ Borel, define the measure

$$\widetilde{\rho}_{z_0}(A) = \frac{1}{2\delta} \rho_{z_0} \left(\bigcup_{t=-\delta}^{\delta} G_t(A) \right).$$

Let $g_{2,\varepsilon} \in C^{\infty}(S^*_{z_0}M)$ have $|g_{2,\varepsilon}|^2 dS_{\phi} \xrightarrow[\varepsilon \to 0]{} \widetilde{\rho}_{z_0}$ as a measure where S_{ϕ} is the surface measure on S^{n-1} . Finally, define $g_{\varepsilon} = g_{1,\varepsilon} + g_{2,\varepsilon}$.

We apply the arguments [19, Section 2.3.1] to see that there exists $\Phi_{\varepsilon,j}$ such that

$$\|(-h_j^2\Delta_g - 1)\Phi_{\varepsilon,j}\|_{L^2} = O_{\varepsilon}(h_j^2), \quad C + O_{\varepsilon}(h_j) \ge \|\Phi_{\varepsilon,j}\|_{L^2} \ge c + O_{\varepsilon}(h_j).$$

and, in normal geodesic coordinates at z_0 , we have

$$\Phi_{\varepsilon,j}(x) = (2\pi h_j)^{\frac{1-n}{2}} \int e^{i\left\langle x, \frac{\theta}{|\theta|} \right\rangle / h_j} g_{\varepsilon} \left(\frac{\theta}{|\theta|}\right) \chi_R(|\theta|) \mathrm{d}\theta$$

where $\chi_R \in C_c^{\infty}((0,\infty);[0,1])$ with $\chi_R \equiv 1$ on [1,R], supp $\chi_R \subset (0,2R)$ and

(7.1)
$$\int \chi_R(\alpha) \alpha^{n-1} \mathrm{d}\alpha = 1.$$

The remainder of the proof consists of analyzing this oscillatory integral.

Choose $\varepsilon_i \to 0$ so slowly that

$$\begin{split} &\lim_{j\to\infty} \|(-h_j^2\Delta_g-1^2)\Phi_{\varepsilon_j,j}\|_{L^2}h_j^{-1}\to 0,\\ &2C\geqslant\limsup_{j\to\infty} \|\Phi_{\varepsilon_j,j}\|_{L^2}\geqslant\liminf_{j\to\infty} \|\Phi_{\varepsilon_j,j}\|_{L^2}>c/2. \end{split}$$

Then,

$$\|(-h_j^2 \Delta_g - 1) \Phi_{\varepsilon_j, j}\|_{L^2} = o(h_j \|\Phi_{\varepsilon_j, j}\|_{L^2}).$$

Fix N > 0 to be chosen large and $\varepsilon_i \to 0$ slowly enough so that

(7.2)
$$\sup_{|\alpha| \leq N} \sup_{\substack{S_{z_0}^*M}} |\partial^{|\alpha|} g_{\varepsilon_j}| h_j \to 0.$$

Under this condition, we compute the defect measure of $\Phi_{\varepsilon_j,j}$. Note that since $\|\Phi_{\varepsilon_j,j}\|$ is uniformly bounded, we may assume by taking subsequences that the defect measure exists. Let $b \in C_c^{\infty}(T^*M)$ supported in

$$A_{\delta} := \{ x \mid \delta \leqslant |d_M(z_0, x)| \leqslant 2\delta \}$$

where d_M is the distance on M. Then, letting $\psi \in C_c^{\infty}(\mathbb{R} \setminus \{0\})$ have $\psi \equiv 1$ on $[\delta, 2\delta]$,

$$\begin{split} b(x,h_jD)\Phi_{\varepsilon_j,j} \\ &= (2\pi h_j)^{\frac{1-3n}{2}} \int e^{i\left(\langle x-y,\xi\rangle + \left\langle y,\frac{\theta}{|\theta|}\right\rangle\right)/h_j} b(x,\xi)\psi(|y|)g_{\varepsilon_j} \\ &\qquad \left(\frac{\theta}{|\theta|}\right)\chi_R(|\theta|)\mathrm{d}\theta\mathrm{d}y\mathrm{d}\xi + O_{L^2}(h_j^\infty). \end{split}$$

Performing stationary phase in the (y, ξ) variables gives

$$b(x,h_jD)\Phi_{\varepsilon_j,j} = (2\pi h_j)^{\frac{1-n}{2}} \int e^{i\left\langle x,\frac{\theta}{|\theta|}\right\rangle/h_j} \left[b\left(x,\frac{\theta}{|\theta|}\right) + h_j e(x,\theta) \right] g_{\varepsilon_j} \\ \left(\frac{\theta}{|\theta|}\right) \chi_R(|\theta|) \mathrm{d}\theta + O_{L^2}(h_j^\infty)$$

where $e \in C^{\infty}(\mathbb{R}^{2n})$ has supp $r \subset \text{supp } b$ and is independent of ε .

$$\begin{split} \langle b(x,h_jD)\Phi_{\varepsilon_j,j},\Phi_{\varepsilon_j,j}\rangle \\ &= (2\pi h_j)^{1-n}\int_{A_{\delta}}\int e^{i\frac{|x|}{h_j}\left\langle\frac{x}{|x|},\frac{\theta}{|\theta|}-\frac{\omega}{|\omega|}\right\rangle}g_{\varepsilon_j}\left(\frac{\theta}{|\theta|}\right)\\ &\left[b\left(x,\frac{\theta}{|\theta|}\right)+h_je(x,\theta)\right]\overline{g_{\varepsilon_j}\left(\frac{\omega}{|\omega|}\right)}\chi_R(|\theta|)\chi_R(|\omega|)\mathrm{d}\theta\mathrm{d}\omega\mathrm{d}x\\ &+O(h_j^{\infty}). \end{split}$$

We write the integral in polar coordinates $x = r\phi$, $\theta = \alpha\Theta$, and $\omega = \beta\Omega$. Since $|r| > \delta$ on A_{δ} , we may perform stationary phase in Ω and Θ . Using (7.2) with N > n + 2 together with the remainder estimate [25, Theorem 3.16] to control the error uniformly as $j \to \infty$, gives

Integration by parts in r then shows that the second two terms are lower order and yields

$$\int_{S^{n-1}} \int_{\mathbb{R}^3_+} [|g_{\varepsilon_j}(\phi)|^2 b(r\phi,\phi) + |g_{\varepsilon_j}(-\phi)|^2 b(r\phi,-\phi)] \\ \alpha^{n-1} \beta^{n-1} \chi_R(\alpha) \chi_R(\beta) \mathrm{d}\alpha \mathrm{d}\beta \mathrm{d}r \mathrm{d}S_\phi + o(1)$$

Sending $j \to \infty$ gives

$$\left(\int_0^\infty \chi_R(\alpha) \alpha^{n-1} \mathrm{d}\alpha \right)^2 \int_{\mathbb{R}} \int_{S^{n-1}} b(r\phi, \phi) (\mathrm{d}\tilde{\rho}_{z_0}(\phi) + |g_1|^2 \mathrm{d}S_{\phi}) \mathrm{d}r$$
$$= \int_{\Lambda_{z_0}} b(x, \xi) (\mathrm{d}\rho_{z_0} + f\mathrm{d}\operatorname{Vol}_{\Lambda_{z_0}})$$

where we use (7.1).

Using that the defect measure of $\Phi_{\varepsilon_j,j}$ is invariant under G_t then shows that $\Phi_{\varepsilon_j,j}$ has defect measure

$$\mu = \mathrm{d}\rho_{z_0} + f\mathrm{d}\operatorname{vol}_{\Lambda_{z_0}}$$

This implies that for $\chi \in C_c^{\infty}(T^*M)$ with $\chi \equiv 1$ on $|\xi|_g \leq 2$,

$$\langle \chi(x, h_j D) \Phi_{\varepsilon_j, j}, \Phi_{\varepsilon_j, j} \rangle_{L^2(M)} \to 1.$$

Now, since $(-h_j^2 \Delta_g - 1) \Phi_{\varepsilon_j,j} = o_{L^2}(h_j)$, an elliptic parametrix construction as in (5.2) implies $(I - \chi(x, h_j D)) \Phi_{\varepsilon_j,j} = o_{L^2(M)}(h_j)$ and hence $\|\Phi_{\varepsilon_j,j}\|_{L^2} \to 1$.

Next observe that

$$\Phi_{\varepsilon_j,j}(z_0) = (2\pi h_j)^{\frac{1-n}{2}} \int_{\mathbb{R}^n} g_{\varepsilon_j}\left(\frac{\theta}{|\theta|}\right) \chi_R(|\theta|) \mathrm{d}\theta$$
$$= (2\pi h_j)^{\frac{1-n}{2}} \int_{S^{n-1}} (g_{1,\varepsilon_j}(\phi) + g_{2,\varepsilon_j}(\phi)) \mathrm{d}S_\phi.$$

Since $\tilde{\rho}_{z_0} \perp d \operatorname{vol}_{\Sigma_{z_0}}$ and $|g_{2,\varepsilon_j}|^2 dS_{\phi} \rightarrow \tilde{\rho}_{z_0}$ as a measure, for any $\delta > 0$, there exists $A \subset S^{n-1}$ so that

$$\int_{A^c} |g_{2,\varepsilon_j}|^2 \mathrm{d}S_\phi \to 0, \qquad \int_A \mathrm{d}S_\phi < \delta.$$

Therefore,

$$\left|\int_{S^{n-1}} g_{2,\varepsilon_j}(\phi) \mathrm{d}S_{\phi}\right| \leqslant C \left(\int_{A^c} |g_{2,\varepsilon_j}|^2 \mathrm{d}S_{\phi}\right)^{1/2} + \left(\int_{S^{n-1}} |g_{2,\varepsilon_j}|^2 \mathrm{d}S_{\phi}\right)^{1/2} \delta^{1/2}$$

so, for all $\delta > 0$,

$$\limsup_{j\to\infty} \left| \int_{S^{n-1}} g_{2,\varepsilon_j}(\phi) \mathrm{d}S_{\phi} \right| \leqslant C \delta^{1/2}.$$

In particular,

$$\lim_{j \to \infty} \int_{S^{n-1}} g_{2,\varepsilon_j}(\phi) \mathrm{d}S_{\phi} = 0.$$

Finally, using that $g_{1,\varepsilon_i} \to g_1$ in L^2 and hence also in L^1

$$\lim_{j \to \infty} u_j(z_0) h_j^{\frac{n-1}{2}} = (2\pi)^{\frac{1-n}{2}} \int_{S^{n-1}} g_1(\phi) \mathrm{d}S_\phi.$$

Letting $u_j = \Phi_{\varepsilon_j,j} / \|\Phi_{\varepsilon_j,j}\|_{L^2}$ then proves the lemma.

Appendix A. Semiclassical notation

We next review the notation used for semiclassical operators and symbols and some of the basic properties. Recall that for a compact manifold M of dimension n, we write

$$S^{m}(T^{*}M) := \{a(\cdot;h) \in C^{\infty}(T^{*}M) : |\partial_{x}^{\alpha}\partial_{\xi}^{\beta}a(x,\xi;h)| \leq C_{\alpha\beta}(1+|\xi|)^{m-|\beta|}\}$$

and $S^{\infty}(T^{*}M) = \bigcup_{m} S^{m}$. We write $\Psi^{m}(M)$ for the semiclassical pseudo-
differential operators of order m on M , $\Psi^{\infty}(M) = \bigcup_{m} \Psi^{m}(M)$ and

$$Op_h: S^m(T^*M) \to \Psi^m(M)$$

for a quantization procedure with $Op_h(1) = \operatorname{id} + O_{\mathcal{D}' \to C^{\infty}}(h^{\infty})$ and for u supported in a coordinate patch, $\varphi \in C_c^{\infty}(M)$ with $\varphi \equiv 1$ on $\operatorname{supp} u$ we have

$$Op_h(a)u(x) = \frac{1}{(2\pi h)^n} \iint e^{\frac{i}{h} \langle x - y, \xi \rangle} \varphi(x) a(x,\xi) u(y) \mathrm{d}\xi \mathrm{d}y + O_{\mathcal{D}' \to C^{\infty}}(h^{\infty}) u.$$

We will often write a(x, hD) for $Op_h(a)$.

There exists a principal symbol map

$$\sigma: \Psi^m(M) \to S^m(T^*M)/hS^{m-1}(T^*M)$$

so that

$$Op_h \circ \sigma(A) = A + O_{\Psi^{m-1}}(h), \quad A \in \Psi^m,$$

$$\sigma \circ Op_h = \pi : S^m \to S^m / h S^{m-1},$$

where π is the natural projection map. Moreover, for $A \in \Psi^{m_1}$, $B \in \Psi^{m_2}$,

- $\sigma(AB) = \sigma(A)\sigma(B) \in S^{m_1+m_2}/hS^{m_1+m_2-1},$
- $\sigma([A,B]) = \frac{h}{i} \{ \sigma(A), \sigma(B) \} \in hS^{m_1 + m_2 1} / h^2 S^{m_1 + m_2 2},$

where $\{\cdot, \cdot\}$ denotes the poisson bracket. For more details on the semiclassical calculus see e.g. [25, Chapters 4,14] [8, Appendix E].
