

Navigating the Web: A Qualitative Eye Tracking-based Study of Translators' Web Search Behaviour

Abstract:

This Element reports an investigation of translators' use of web-based resources and search engines. The study adopted a qualitative eye tracking-based methodology utilising a combination of gaze replay and retrospective think aloud (RTA) to elicit data. The main contribution of this Element lies in presenting not only an alternative eye tracking methodology for investigating translators' web search behaviour but also a systematic approach to gauging the reasoning behind translators' highly complex and context-dependent interaction with search engines and the Web.

Keywords: eye tracking, qualitative research, retrospective think aloud, information behaviour, search engine

Section 1. Introduction

Most people use the Web for all manners of information purposes at the present time. It is no coincidence that translators also rely heavily on the Web for information. A translator may choose not to use computer-aided translation (CAT) tools, but it is unlikely that s/he does not use the Web. In other words, web search is probably one of the most widespread and universal forms of Human Computer Interaction (HCI) for translators. Yet, unlike the use of CAT tools, translators' use of the Web is the least researched in translation studies so far.

The issue about the Web and search engines (presumably a gateway to the Web) is that they are not specifically designed for translators. It is not always straightforward for translators to find or locate what they intend to find. Frustrations of using the Web are not exclusive to translators though. In fact, it is found that roughly 'two-thirds to three-quarters of all internet users cite the inability to find the information they seek as one of their primary frustrations' of using the Web (Kobayashi and Takeda 2000). It is largely a mystery why sometimes it is easier for translators to find what they intend to find and yet at other times it is almost impossible to find the information they need. The situation is even more complex when taking into account that modern search engines tend to automatically customise search results based on a user's geographical location, previous search queries and browsing histories, etc (see <https://www.wordstream.com/serp>). As a result, even when different translators share the same aim of finding the same information and using the same search engine, they can retrieve different search results (Shih 2019). A wealth of studies can be found in information science with respect to how humans acquire information (see Case and Given 2016). Particularly, in search engine research many early attempts have been made on utilising search logs from search engine servers. For example, it is found that 'mean terms per query' (i.e. how many terms/words are used per query) can range from 2.35 to 2.92 (Spink and Jansen 2004: 82-83). It is also found that only one (search) results page is viewed in most search instances (ibid 108-109). Researchers also found that web users tend to follow an 'F shape reading pattern', i.e. from the left to the right and from the top to the bottom (see Nielsen 2006) when viewing webpages. Such analysis provides interesting insights into web search trends or tendency and indeed becomes very useful for search engine providers to improve their services. However, it falls short of distinguishing web search for specific contexts and purposes (Shih 2019: 911-912). This is why in recent years substantial research efforts are placed on examining web search behaviour of specific user groups for specific tasks. For instance, many studies focus on web search for health-related information, i.e. the 'Dr Google' phenomenon (See Beutelspacher 2019, Kessler and Zillich 2019, Lee et al 2015). Another popular theme is consumers' web search behaviour (See Hodgkinson et al 2000). A consensus stands out from many of these studies, that is, information behaviour is highly complex and task-dependent (see Marchionini 2006; Bystrom and Jarvelin 1995; Aula et al 2005; Granka, Feusner and Lorigo 2008). This warrants detailed investigation into (web-based) information behaviour in translation.

These are some of the reasons that motivate me to produce this Element. This Element can be seen as a follow-up work to my previous three publications on translators' web search process (Shih 2017, 2019, 2021). It seeks not only to consolidate and confirm findings of existing studies, but also add fresh empirical data so as to form a broader overview of the translators' web search phenomenon. In other words, my aim is to demystify translators' use of the Web with a special focus on search engines, including queries, browsing, and clicking behaviours, and potential interplay among them.

The aims of this Element can be summarised into the following three themes and corresponding questions (see Table 1).

Section 2. Existing Studies

Relevant literature and concepts in three research areas will be examined: Human Information Behaviour, Web Information Retrieval and Web Search in Translation Studies, as they will form a solid theoretical foundation in this Element. Section 2.1 Human Information Behaviour will explicate the most prominent concepts and models of human information behaviour and how they may be adopted in understanding translators' web search. Section 2.2 Web Information Retrieval will first focus on the basic mechanics behind search engines and then move on to important concepts and findings in this field. Section 3 Web Search in Translation Studies will present latest and existing studies on web search in translation studies so far.

2.1 (Human) Information Behaviour (HIB): Theoretical Consideration

Human Information Interaction (HII) is considered by many a sub-field of Human Computer Interaction (HCI) that has a stronger human and lesser computer emphasis (Jones et al 2006). The term, HII, was coined by Gershon (1995) to bring together all relevant studies dealing with how humans interact with information (disregarding which information systems are used) scattered around many adjacent disciplines and sub-disciplines, including Information Retrieval (IR), Human Factors (HF), Human Information Behaviour (HIB), etc. More recently, Fidel (2012) simply calls HII a meta-discipline that encompasses studies dealing with humans, information, and technology. While the boundary of HII may be fluid and subject to debates, given it is a relatively young (sub-)field, I consider that this Element largely falls into HII, and more specifically, Human Information Behaviour (HIB), the behavioural side of HII. This is because this Element depicts the behaviour of a specific type of information users, i.e. translators, in how and why they interact with web-based information and systems.

Several terms and concepts in HIB are often cited in translation studies and its adjacent disciplines. They will be explained briefly in the following. They are: Information Behaviour (IB), Information Seeking Behaviour and Information Search Behaviour. Incidentally, even though these three concepts stem from HIB, they have been embraced and researched extensively in Information and Library Studies (ILS). As a result, the most prominent IB models are developed within ILS. This is the reason why IB models from ILS will be featured in detail in this section later. According to Wilson (2000: 49), IB is an umbrella term referring to any occurring behaviours when humans encounter information sources and media. Such information sources do not have to be online. They can also include face-to-face interaction with another human being. In addition, HIB consists of both active information seeking and passive information reception (e.g. viewing advertisements online or on TV). In contrast to IB, Information Seeking Behaviour refers to purposeful information seeking. In other words, there must be a purpose or a need to search for information. Information need as a concept in Information Seeking Behaviour will be discussed later in this Section as it has direct implications for translation. Finally, Information Search Behaviour refers to human's micro-level behaviour with any information sources. These micro-levels include the physical level (such as moving the mouse to click on a link), the intellectual/strategic level (such as using Boolean symbols in search engines) and the mental level (such as judging which information sources are more relevant or reliable). To sum up, there is a hierarchy between these three concepts. IB is a wider and more generic concept sitting at the top of the hierarchy whereas Information Search Behaviour is at the lower end of the hierarchy, referring to lower-level details of the information behaviour. Most web search studies in translation adapt concepts from Information Seeking Behaviour, particularly the concept of "information need", probably because of its saliency and ease of application to translation. After all, the information need or the purpose of information seeking in translation is largely self-explanatory; it is to solve problems encountered in translation. This problem-solving aspect also ties in seamlessly with translation

process research (TPR). While it is important to recognise the theoretical and conceptual value of Information Seeking Behaviour in translation studies, this Element intends to go one step further in adopting the conceptualisation of Information Search Behaviour in addition to Information Seeking Behaviour. This is because Information Search Behaviour offers an ideal platform to dig deeper into the micro- or granulated level of translators' information behaviour, particularly in relation to their search engine behaviour involved in this process, such as clicking and browsing behaviour, strategic planning and judgement of relevance in information sources, etc. This is part of the reason why the term, 'web search', rather than 'information seeking' is used throughout this Element. In the following, several prominent IB models and theories will be presented, as they will help contextualise the phenomena of translators' web search and inform data analysis presented later in this Element.

Dervin's sense-making theory (1983) is probably one of the most cited concepts in ILS and its adjacent disciplines. Dervin describes her sense-making theory as not just a theory but also an approach or methodology for communication and information science. The three main components of sense-making theory are situations, gaps, and uses (Dervin 1983: 9). The situation is described as a context from which sense is constructed. The gap is a bridge that links the situation and the use. It is often referred to as the information need in Information Seeking literature. The use refers to the constructed sense or outcome (to be acted upon). Dervin believes that human reality is full of gaps (of information). When a human observes or identifies an information gap, s/he has an inherent urge to bridge the gap. Some scholars even call humans 'informavore' (Miller 1983). It is only when the gap has been filled new knowledge is formed. Sense-making theory is often used to explain the fluid transition between information and knowledge. In other words, information is a relatively neutral set of codes and data. It can only become sense or knowledge once links are established and the gap is filled. In other words, the process of sense making is the process of transforming data or information into knowledge (by an individual). Sense-making theory is no doubt a useful theory to conceptualise the process of translators' web search, as when translators resort to the Web for information, they are bombarded with huge amounts of information. It is vitally important for translators to 'sift out' relevant information and 'make sense' of it before they are able to adopt or use it in their translation. From this point of view, it can be said that this Element is partly aiming to portray the complexity of translators' sense-making process when faced with a magnitude of information on the Web. As mentioned before, Dervin considers sense-making not just a theory but also a methodology. In fact, to a certain extent, this Element also subscribes to the methodology of sense-making theory epistemologically. Dervin (1998) describes sense-making as a 'verb', not a 'noun', as it is a continuous process. She explains that an important part of her sense-making theory is to develop methodology to investigate what she calls 'Micro-Moment Time-Line Interview' (ibid). This is because as the knowledge forming process is continuous and ever-changing, partly due to its constantly shifting contexts/situations, it is essential to utilise the micro-moment timelines so that the knowledge forming process can actually be captured (in research). She proposes that in the data collection method (in her case, interview), it is important to capture at least two of the three components of sense-making, i.e. the situation, the gap and the use. Again, while this Element adopts different data collection methods than Dervin's study, its use of qualitative eye tracking-based research methodology is essentially utilising empirical data to re-construct the situation, the gap and the use of translators' web search process at a 'micro-moment' level.

In the field of HII, there are several theories that are widely cited and applied in search engine research, which is of particular interest in this Element. They will be examined below. One of the most renowned HII theories is Information Foraging Theory developed by Pirolli (2007). By drawing inspiration from Optimal Foraging Theory in biology and anthropology (Stephens & Krebs 1986, cf

Pirolli 2007), Pirolli cleverly uses several metaphors to explain how humans select and navigate the ‘information maze’ on the web. The first metaphor is that when an animal is foraging in a patch, over time the yield will gradually diminish. Eventually, it will be time for the animal to move on and look for a new patch. The tipping point of moving onto a new patch rests on the time-cost between the energy it takes to search for food and the amount of energy the food can provide to sustain the animal. In other words, the time-cost in the former must not surpass that of the latter for it to be worthwhile for the animal to stay in the same patch. This optimisation of cost and gain is readily applied in information studies. The patch is a website or webpage. A searcher will need to determine the balance between the cost (e.g. time and effort) it takes to find relevant information and the quality of the information gained (e.g. how relevant the information is). If the cost is much higher than the quality of information it provides, a searcher will move on to other information sources. The second metaphor is known as ‘information scent’. This metaphor is used to explicate the judgement of how relevant the information really is. ‘Information scent’ is basically ‘proximal cues’ of relevance a searcher picks up along the path of information seeking (Lewandowski & Kammerer 2021). In the case of search engines, the scent comes from URLs, titles, and snippets (a summary or short description of the web page content) attached to hyperlinks displayed in the search engine result page (SERP). The stronger the scent the stronger the clues so that a searcher is more likely to click on a hyperlink. This behaviour is often accompanied by ‘satisficing’ behaviour. The word, ‘satisficing’ merges two words, to ‘satisfy’ and to ‘suffice’. It means “to undertake a course of action that satisfies the minimum requirements necessary to achieve a particular goal”.

In other words, a searcher may not evaluate all the search results available (based on information scent) but only evaluate a limited number of them until ‘good enough’ information is found. Notably, the rule of ‘satisficing’ becomes the gold standard for search engine ranking algorithms where sponsored links or most relevant links are always placed at the top of the SERP, given it is proven in IR research that hyperlinks placed towards the bottom of a SERP are less likely to be browsed and clicked.

While Information Foraging Theory focuses more on the browsing behaviour in information seeking, a berrypicking model focuses more on query and its relationship with information need (Savolainen 2018). A berrypicking model is sometimes known as a type of exploratory or evolving search in IR research. Exploratory search is another important concept related to search engines, which will be discussed separately in Section 2.2.3. According to Bates (1989: 408), the classic IR model is not sufficient to explicate the complexity and dynamics of the information seeking process, as it assumes that the information seeking process starts from a single information need, resulting in a single query that matches a document representation and consequently a document is retrieved. Bates therefore proposes her berrypicking model, using the analogy of berrypicking in the woods to explicate the complexity of dynamics in the information seeking process. In this model, a searcher is like a berrypicker who has a general aim of picking berries in the woods. S/he has to pick one berry at a time and also find her/his way through the woods, as not all berries can be found in one single bush and berry bushes are scattered around in different parts of the woods. In other words, as the searches go on, even though the overall aim has not changed, individual mini-aims have to be established and fulfilled. The searcher has to adopt the pathway in order to successfully pick enough berries. In Bates’ own words (1989: 410),

at each stage, with each different conception of the query, the user may identify useful information and references. In other words, the query is not satisfied by single final retrieved set, but by a series of selections of individual references and bits of information at each stage of the ever-modifying search. A bit-at-a-time retrieval of this sort is here called *berrypicking*.

The berrypicking model will be useful in conceptualising and understanding longer and complex web search behaviour of translators in this Element, particularly in terms of the ever-changing dynamics of queries and query intents. Details and examples of these will be illustrated in Section 4.

In addition to the Information Foraging Theory and berrypicking model, the Prominence-Interpretation Theory (Fogg 2003) also explains factors involved in the evaluation or judgement of how relevant information is. This is often called, ‘credibility judgement’ (Kattenbeck and Elsweiler 2019) or ‘credibility assessment’ (Kammerer and Gerjets 2012). According to Fogg (2003), there are two components in this evaluation: prominence and interpretation. Prominence is defined as ‘the likelihood that a website element will be noticed or perceived’ (Fogg 2003: 722). Interpretation is understood as ‘a person’s own judgement about an element under examination’ (Fogg 2003: 723). Fogg’s theory is commonly used to explain how different elements or placements of information on websites may determine the information judgement. However, Kammerer and Gerjets (2014) adopt Fogg’s theory to the evaluation of SERP which is of particular relevance in this Element. According to Kammerer and Gerjets, prominence represents how salient the information clue is in SERP, and interpretation represents a searcher’s own idiosyncratic interpretation of this clue. In other words, the combination of how information is presented or formatted in SERP and how a searcher makes sense of the information (cf Dervin’s sense-making theory) ultimately determines how relevant or credible a SERP listing is. It is worth adding here that according to Fogg (2003), a searcher’s own past experiences, long-term memory, and even his or her knowledge about search engines may play an active role in contributing to a searcher’s individual judgement and interpretation.

Another influential scholar in the field of information seeking is Kuhlthau (1990, 1991). Her most important contribution to the field is largely characterised by the introduction of affect in the understanding of the information seeking process. This incidentally coincides with the call for more emphasis on research about affect in translation studies alongside cognition and behaviour (Shih in press). In many ways, Kuhlthau’s work can be considered to add to Dervin’s (1983) sense-making theory, in which sense-making is effectively a process of forming a personal view. This personal view an information seeker forms cannot escape from his or her own affective experiences of everyday life. In other words, interactions are always present between formalised information an information seeker seeks and informal information derived from the information seeker’s unique personal experience in life (Kuhlthau 1991: 361). After all, this is how an information seeker ‘make(s) sense’ of the world. Kuhlthau’s work is also partially based on Kelly’s (1963) personal construct theory which depicts how affective experiences contribute to the way individuals construct knowledge and meaning. Particularly relevant to this Element is that this theory also highlights the situation where confusion and anxiety arise when newly sought information contradicts existing knowledge. Sometimes such confusion and anxiety become so intense that an information seeker may choose to interrupt or even abandon the whole information seeking process. A more effective alternative to abandonment, however, is to form a hypothesis to be tested (with further information) so that new meaning/knowledge can be constructed. In this Element, it will be interesting to observe how and potentially why translators confront and resolve the situation when formalised information sought on the Web (or in search engines) appears to contradict their existing knowledge based on their life experiences.

2.2 (Web) Information Retrieval

In contrast to Information seeking behaviour, ‘information retrieval [commonly abbreviated as IR] is a discipline that deals with the representation, storage, organisation, and access to information items. The goal of information retrieval is to obtain information that might be useful or relevant to the user ...’ (Ceri et al 2013: 3). To a certain extent, IR studies are concerned with the technical side of

information seeking whereas information seeking behaviour is concerned with the human side of the same story. While a large part of IR research is beyond the scope of this Element, it is helpful to have a broad overview of the basic ‘mechanics’ behind search engines, given they will form parts of the discussion in Section 4.

2.2.1 Search Engine Mechanics

Ceri et al (2013: 74) illustrate the basic mechanics behind how a search engine is built in what they call, ‘the architecture of a web search engine’. According to them, there are two processes involved in search engines: a front-end process and a back-end process. The front-end process consists of two layers of processes: a user interface (UI) layer and a query layer. The query layer itself consists of three components: query parser, searcher and ranker. When a query is submitted in a search box in search engines, the front-end process begins. Initially, the query parser will be hard at work parsing and understanding the query. Then, the query parser sends its request to a searcher. The searcher will locate relevant information from its database. Once relevant information is located, it will be forwarded to a ranker so that information is ranked according to its degree of relevance and/or other pre-determined criteria. The ranked information can then be sent back to the UI for the end user. While the front-end process is initiated by an end-user, there is also another (parallel) process in search engines that is constantly at work but not directly initiated by the end-user. This parallel process is called a back-end process. The back-end process consists of two layers of processes: indexer and crawler. Crawler is essentially a computer programme that constantly collects, analyses and updates information from the Web; the indexer is a computer programme that processes and categorises information for optimal storage and retrieval once information is collected. It is vitally important for the back-end process to work behind the scenes parallel to the front-end process so that search engines can function effectively (providing up-to-date information) and efficiently (generating instantaneous search results).

2.2.2 The Concept of Relevance

Apart from the architecture of how search engines are built, another important concept in IR is the concept of relevance. In defining this concept, Ceri et al (2013: 4) point out a fundamental dilemma for all IR systems, that is, ‘the relevance of results is assessed relative to the information need, not the query.’ In other words, there is a gap between how well search results serve their purpose for an information seeker and information input obtained by the IR system (which is a query). Ceri et al (ibid) also highlight three unique properties for the concept of relevance, that is, relevance is subjective, dynamic, and multifaceted. This dilemma reflects a real challenge for computer engineers to improve or build a better search engine, given the complex nature of relevance itself and the fact that relevance is not determined by a query (i.e. input in IR systems) but a searcher’s information need, which exists outside the system and is largely out of the control of IR systems. Essentially, it is a guessing game for the IR system to work out how well a searcher’s information need is fulfilled.

2.2.3 Exploratory Search

As mentioned in the previous section, exploratory search is an important concept in search engine research. This is a phenomenon first proposed by Marchionini (2006). According to him, there are three types of search activities: look up, learn and investigate. Look up refers to the most basic search task that assumes a simple (fact-retrieval) query and a simple answer to the query. In other words, there is a highly specified question and a highly specific answer. The other two activities, however,

represent a more complex type of search. Marchionini refers to them as ‘exploratory search’. Exploratory search is ‘defined as the situation in which the user starts from a not-so-well-defined information need and progressively discovers more on his need and on the available information to address it, with a mix of lookup, browsing, analysis, and exploration’ (Bozzon et al 2013: 642). White et al (2008: 433) describe exploratory search as follows, ‘in exploratory search people usually submit a tentative query to get them near relevant documents then explore the environment to better understand how to exploit it, selectively seeking and passively obtaining cues about where their next steps lie’. In other words, exploratory search is a constantly evolving process between queries and browsing and clicking behaviour. This is probably why it is found to be a particularly suited web search strategy in discovering difficult-to-find medical concepts and terminology in translation (Shih 2019). The same study also reveals that translation web search activities can either be a simple look up, or an exploratory search or a combination of both, although the simple look up approach seems to dominate in students’ web search process. In the remainder of this Section, I will focus on existing literature about web search within translation studies.

2.3 Web Search in Translation Studies

Before diving into details of relevant literature, it is worth pointing out that currently in translation studies, there is no consensus with regard to uniform terminology to describe the phenomena this Element intends to investigate, i.e. the way in which translators look for and interact with information on the Web. While it is generally agreed that information literacy is an essential component of translators’ instrumental competence (see PACTE 2002, 2017, Shreve 2006; EMT 2017; Göpferich 2009), a myriad of terms are used to address translators’ online information behaviour, including the use of electronic resources (Olalla-Soler 2018), the use of digital resources (Hvelplund 2017, 2019), online consultation processes (Cui and Zheng 2021a, 2021b), information (seeking) behaviour of online resources (Sycz-Opon 2019, 2021), interaction between translators and online resources (Gough 2016), and web search process (Enrique Raido 2011, 2014; Shih 2017, 2019, 2021). Largely due to its link to the concept of ‘information search behaviour’ and proximity to search engine research (as pointed out in Section 2.1 and Section 2.2), the term, ‘web search’, will be used in this Element to address this unique information phenomenon as it pertains to translators.

The literature about web search in translation will be reviewed in two groups: studies adopting a qualitative approach and studies adopting a quantitative approach, as these have direct implications for the methodology adopted in this Element, which will be explained in detail in Section 3, Methodology.

2.3.1 Studies Adopting a Qualitative Approach

Web search in translation was first explored by Enrique Raido (2011, 2014) in a multi-case study of six subjects in a pedagogical setting. The subjects were four student translators and two professional translators. Two translation/web search tasks (from Spanish into English) were conducted a week apart. The second task was designed to be more complex than the first task. The study adopted a combination of screen recording, online search reports (a type of self-reflective reports), pre-task questionnaires, and post-task interviews as its methodology. Being a pioneering study, Enrique Raido’s work is significant in several ways. Firstly, she is one of the earliest scholars who draws on theories and concepts from Information Seeking Behaviour and Information Retrieval systematically in translation studies. For instance, she describes ‘information need’ as a recognition of a need for information motivated by a translation problem and ‘information goal’ as the type of information required to fulfil the information need (Enrique Raido 2014: 40). The link between the information

need, the information goal and problem solving leads to a general categorisation of the information goal as either ST comprehension related or TT production related. In addition to this, one of the other significant contributions of Enrique Raido's work is that it demonstrates a combination of different qualitative data collection methods as a valuable approach in investigating translators' web search process. In fact, many subsequent studies follow in her footsteps in adopting a qualitative approach and utilising screen recording as a main data collection method.

Gough's (2016) PhD project represents one of the studies that adopt screen recording as a data collection method. The screen recording is preceded by a larger-scale survey. Gough's work features extensive profiling of subjects' individual attributes and characteristics in terms of online tools and resources used, how frequently these resources are used and what procedures or strategies are adopted in web search, etc. In fact, Gough proposes two taxonomies in profiling translators' web search styles. One of them is called 'Resource Type User Typology' (Gough 2016: 193), which uses the categories, the Dictionary Enthusiast, the Mixed Type, the Parallel Text Fan and the MT Adopter. As the characterisations used in this typology suggests, some translators prefer to predominantly rely on web-based dictionaries, others on parallel texts and some even on MT. Gough's other taxonomy is called 'Typology of Translator Research Style', listing the Economical Translator, the Prolific Translator, the Understated Translator, the Explorative Translator, and the Moderate Translator (Gough 2016: 214). A particularly noteworthy finding from Gough's second taxonomy is that 'the most represented category, the Economic Translator (characterised by low research volume, high research speed), covered half of the sample' (ibid: 255). In other words, while different varieties and tendencies of web search styles exist among professional translators, around half of them tend to spend a minimal amount of time and efforts on web search. Gough cites effects of the 'Google Generation' (Rowlands et al 2008, cf Gough 2016: 33) as a possible reason behind this finding. In other words, translators tend to adopt a speedy and flickering information behaviour when searching information on the Web.

Focusing on cultural-specific translation problems, Olalla-Soler (2018) investigates how translators (working from German to Spanish) at various stages of their competence and development may use web-based resources differently. Her subject population include 1st, 2nd, 3rd, and 4th year undergraduate translation students and professional translators. Like many previous studies, her main data collection method is screen recording. The main findings show that student translators generally spend more time on web-based resources and pose more queries in search engines in order to solve their cultural-specific translation problems. Professional translators, however, are found to spend less time on the web and instead rely more on their own internalised knowledge in order to solve the problems (Olalla-Soler 2019). In addition, Olalla-Soler also points out that the whole student cohort behaves relatively similarly in their web search process. In other words, their levels and years of translation training appear to have no noticeable effects on their web search process. While it is understandable that professionals are likely to have more cultural knowledge to resort to when compared with student translators, it is interesting to find that years of training have no effects on the web search process in the student cohort. It may be an indication that web search skills represent an independent sub-skill that requires specific training, which current translation curricula may not have yet catered for.

Studies adopting to the qualitative approach also include my two previous studies (Shih 2017, 2019) where screen recording and think aloud protocols are used to elicit relevant data. The 2017 study is explorative in depicting what types of web-based resources are used by student translators (working from English into Chinese) and their idiosyncratic web search behaviour, particularly in terms of queries used in different search engines (i.e. Google and Baidu). In common with many previous studies, it confirms that online dictionaries and search engines are the web-based resources most used by Chinese student translators. The 2019 study adjusts its focuses to investigate optimised (i.e. effective and efficient) behaviour of student translators by adopting White's (2016: 21-37) concepts of

primary action and secondary actions. Primary action refers to query-related actions in search engines and secondary actions refer to the actions conducted as a result of search engines but largely occur outside search engines (e.g. how many hyperlinks are clicked and consequently how long translators spend on browsing external webpages, etc). The main findings indicate that ‘exploring and processing a search engine result page at a deeper level can be a [more] effective strategy to satisfy a rare information need[/goal], particularly in the context of harder-to-reach TL terms. There [is] little evidence, however, to suggest that extensive query re-formulation alone makes much impact to the success of web search’ (Shih 2019: 921). In other words, the key to successful and optimised web search (in search engines) lies in secondary actions (i.e. clicking and browsing behaviour beyond queries) and an exploratory search approach is more advantageous in helping student translators to solve their translation problems.

A latest study that largely adopts the qualitative approach is conducted by Sycz-Opon (2021). Worth noting here is that the methodology adopted in this particular study relies on direct observation and think-aloud protocols in addition to screen recording. Sycz-Opon’s student translators are instructed to work in pairs. One student acts as the recorder and the other student acts as the translator. The recording student is responsible for writing down details of the direct observation by using ‘the observation protocol’ consisting of a list of questions, e.g. what web-based resources are used, why they are used, what information is being sought and the end result of the search. The translator is responsible for translating a legal text from Polish into English while thinking aloud. Sycz-Opon (2021: 138-139) explains that the translator is instructed to explain her/his choices of information sources used, reasons for her/his decisions and quality of information sources used, etc. The whole data collection process (n=104; 52 pairs) takes place in one single sitting in a computer lab where students are briefed for 10 minutes and spend up to 1 hour and 20 minutes on the task itself. A taxonomy of six research styles is proposed based on the data: the Traditionalist, the Digital Native, the Minimalist, the Detective, the Habitual Doubter, and the Procrastinator. While Sycz-Opon’s study reveals some interesting varieties of student translators’ tendencies, her data collection procedures are not without potential flaws. Firstly, only 10 minutes are spent in briefing the whole cohort of 104 students. This shows that neither the recording students nor the student translators have much time to practice or rehearse what they are supposed to do. Given that think aloud does not come naturally for most people, particularly while performing a complex task, it is worrying that the student translators are not trained in how to think aloud well in advance. This is aggravated by the issue that the student translators are instructed ‘to explain their choices and decisions and comment on the quality of consulted sources when asked by the recorder’ (ibid: 138-139). In other words, the recording students are not only expected to write down many different types of information and behaviour, but also instructed to interrupt and pose questions to the student translators so that they can record the translator’s explanations and comments. Alarming, this reveals that differences between think-aloud protocols and descriptions or explanations of one’s thinking appear to be misunderstood (see Ericsson and Simon 1998). As a result, the findings of this study should be treated with extra caution.

2.3.2 Studies Adopting a Quantitative Approach

Web search related studies adopting a quantitative approach in translation all uniformly employ eye tracking as their main data collection method. Hvelplund, a veteran in eye tracking research in translation (See Hvelplund 2017: 248-264), is one of first scholars to investigate web search quantitatively (Hvelplund 2017, 2019). The 2017 study focuses on examining the types of digital resources being used by professional translators and the amount of time and cognitive load spent on drafting, revision and using digital resources respectively. The subject population consists of 18 professional translators working from English into Danish, translating two texts: a literary text and a Language-for-Specific Purposes (LSP) text. Keylogging, eye tracking and screen recording are used

as data collection methods. In terms of the types of web-based resources used, unsurprisingly, bilingual dictionaries and search engines are found to be the most frequently used. In terms of the time, using digital resources accounts for around 20% of the total translation process. In terms of the efforts (by analysing eye tracking metrics, i.e. fixation duration and pupil size), the study shows that using digital resources requires significantly higher processing and cognitive load than drafting and revision. All these findings suggest that using digital resources represents a significant part of the translation process that warrants further investigation. Hvelplund's 2019 article draws on the same data set as his 2017 publication. This time he focuses on transition patterns between the ST, TT and digital resources. He refers to them as 'processing flow[s]'. One thing worth pointing out here is that the reason Hvelplund is able to use eye tracking algorithms to study the transition patterns between ST, TT and digital resources is that in his experimental design, he artificially divides the screen into 3 parts, keylogging software (i.e. Translog II) is on the left, which consists of two panes, the ST pane on the top and the TT pane on the bottom. The right side of the screen is the web browser. As a result, the eye tracker is able to compute all screen-based activities that occur within the boundary of the top left pane as ST behaviour; those that occur within the boundary of the bottom left pane as TT behaviour; those that occur to the right side of the screen as digital resource behaviour. This exact experimental setup is taken up by Cui and Zheng (2021a, 2021b) whose study will be discussed later. Hvelplund shows that there are four different types of processing flows. Type 1 is source text to digital resources and back to source text, abbreviated as ST-DR-ST. Type 2 is source text to digital resources and then to target text (ST-DR-TT). Type 3 is target text to digital resources and to source text (TT-DR-ST). Finally, Type 4 is target text to digital resources and target text (TT-DR-TT). He indicates that Type 2 and Type 4 are not only the most frequently occurring but also the most (cognitively) intensive processing flows. He therefore concludes that the use of digital resources plays a substantial part in both initial drafting (Type 2 processing flow) and later revision (Type 4 processing flow) in the translation process.

Focusing on translation directionality (i.e. from L1 to L2 and L2 to L1), Whyatt, Witczak and Tomczak (2021) also adopt a largely quantitative approach to their study. Like Hvelplund, they also employ keylogging, screen recording and eye tracking as their data collection methods. Their main findings suggest that when compared with translation into L1, translation into L2 increases the intensity of temporal and cognitive loads in web search. In other words, translation into L2 takes longer and requires more efforts in the web search process. Nevertheless, there is very little evidence to suggest that translation directionality influences the way in which translators conduct web search. Similarly, the amount of time spent on web search does not seem to have much correlation to translation quality.

Cui and Zheng (2021a, 2021b) are the latest researchers taking up eye tracking in investigating web search in translation. As in previous studies, keylogging, eye tracking and interviews are also used as their main data collection methods. As mentioned briefly before, they largely follow Hvelplund's experimental setup in dividing the screen into three parts. Thirty-eight postgraduate student translators were asked to translate two texts, one being an easier and the other a more difficult text. As in most previous studies, they find that the most used web-based resources are bilingual dictionaries and search engines. Unsurprisingly, the more difficult the text is (as perceived by translators), the more time is spent on web search. Similarly, more frequent and intense transitions between the translation pane and the web search pane can be found in translating the more difficult text. However, statistically, cognitive efforts do not correlate with translators' perceived difficulty. It is conceded that cognitive efforts may be linked to the types of problems encountered by each individual translator rather than the general perception of text difficulty. For instance, it is found that searching for extra-linguistic information tends to require more cognitive efforts. In terms of the cognitive efforts involved in web search, Cui and Zheng (2021b: 68) suggest that a pedagogical implication can be drawn from their findings that student translators 'should be given designated training in improving their working memory capacity', as frequent transition between the translation and the web is a sign

that student translators are struggling to cope with information overload. Interestingly, this point is directly related to a finding of the present Element and will be raised again in Section 4.

Section 3. Methodology

This Section will first elucidate a qualitative approach to eye tracking and then explain the rationality and significance of this methodology outside translation studies, particularly in usability research. Finally, data collection procedures adopted for this Element will be illustrated.

3.1 A Qualitative Approach to Eye Tracking

Eye tracking is by no means new in translation studies. A quick search of ‘eye tracking’ as a keyword in the Translation Studies Bibliography, a specialist database for research publications in translation studies, generates hundreds of results. As a data collection method, eye tracking was first borrowed from cognitive psychology by O’Brien (2006) to investigate translators’ use of Computer-Assisted Translation (CAT) tools, i.e. Trados Translators Workbench, an earlier version of SDL Trados Studio. In fact, O’Brien herself calls TPR scholars ‘the borrowers’ (2013), as they have consistently stepped out of their comfort zone, looked further afield from the traditional boundary of translation studies, and cultivated new research methods from other disciplines. This is likely to be the reason why TPR remains one of the most interdisciplinary areas of translation studies to date.

Eye tracking is used to investigate many different aspects of translation. Since the late 90s to early 2000, researchers such as Carl, Schaeffer and Jakobsen based at the Center for Research and Innovation in Translation and Translation Technology (CRITT), Copenhagen Business School, pioneered the use of Translog, a keylogging software in combination with an eye tracker. This developed into a distinct methodology using inferential statistics in its analysis. Since then, there has been a steady stream of publications using the same CRITT methodologyⁱ (See Carl, Schaeffer & Bangalore 2016).

While it is common to supplement the use of eye tracking metrics with other qualitative data, such as screen recording, questionnaires, or retrospective interviews (Saldanha & O’Brien 2014: 109-110), epistemologically, eye tracking methodology has largely adopted a quantitative and deductive approach since it was first introduced to translation studies by O’Brien two decades ago (ibid 144). It is true that even outside translation studies, the gold standard for eye tracking data analysis seems to be primarily numerical and statistical. Some scholars even argue that visualised data, such as scan paths, heat maps, and gaze replays cannot be considered eye tracking data at all, only ‘rigorous statistical analysis should ... form the bedrock of [eye tracking] research’ (Conklin, Pellicer-Sanchez and Carrol 2018: 208). A positivist and quantitative approach to eye tracking has many merits and indeed made a significant contribution to translation studies and beyond. It is clearly advantageous in providing solid statistical evidence to advance the scientific investigation of translators’ and interpreters’ cognitive efforts in specific settings and conditions. Nonetheless, this approach also has its limitations. ‘..[Quantitative] procedures are deductive in nature, contributing to the scientific knowledge base by theory testing. This is the nature of quantitative methodology. Because true experimental designs require tightly controlled conditions, the richness and depth of meaning for participants may be sacrificed. As a validity concern, this may be a limitation of quantitative designs’ (Glenn 2010: 103). In translation studies, such controlled conditions can range from deliberate manipulation of source texts and their length, to how and where source texts are presented on the computer screen. All these controls and manipulations are designed to ensure the integrity of this type of research. Nevertheless, such control can also compromise ecological validity. In other words, the experimental setting and conditions can fall short of being realistic and naturalistic. In addition, findings generated from hypothesis-testing studies sometimes have limited direct applicability to translation practice. Typical hypotheses include whether variable A is linked to variable B, or whether

variable A is a (probable) cause of variable B. Moreover, researchers are often called on to design experiments and hypotheses around specific statistical methods so as to avoid subsequent difficulty in analysing non-standardised quantitative data in eye tracking (Holmqvist et al 2011: 108).

At this point, it may be useful to clarify what eye trackers can offer and perhaps more importantly what they cannot offer. Despite an abundance of measurements and promising results, eye trackers are fundamentally designed to collect two types of data: spatial data and temporal data of visual attention. In plainest terms, eye trackers track where the eyes look and for how long; nothing else. What eye trackers cannot offer, however, some may argue critically, is the very reasons why such visual attention occurs. This inherent delimitation is one of the most crucial considerations of using eye tracking as a (main) data collection method. If a researcher is more interested in (acute) reasons behind translators' real-time cognitive efforts and behaviours as in the case of this Element, eye tracking as a main data collection method is automatically discounted and should not be considered. Or so I was told... until I dived into usability studies, a sub-field of Human Computer Interaction (HCI) and its extensive use of qualitative eye tracking based methodology. I discovered that a qualitative approach to eye tracking is not only possible but also proven to be valuable in its own right. Usability will be discussed in detail in Section 3.2.

As shown in Section 2, research into translators' use of the Web in translation studies so far can be divided into two camps methodology-wise. The first one adopts screen recording as a main data collection method. In these studies, screen recording is often supplemented by translators' own retrospection, with the use of post-task questionnaires, interviews, and self-reflective web search reports (See Gough 2016, Enrique Raido 2014, Shih 2017, Olalla-Soler 2018). The methodology of these studies is purely qualitative in nature. More recently, however, a new type of web search studies has emerged. These studies enlist eye tracking as a main data collection method, subscribing to a quantitative and hypothesis-testing approach. Meanwhile, they are also supplemented by some forms of retrospective reports, including questionnaires and interviews, but often as secondary data to support the findings and hypotheses of the primary quantitative metrics produced by eye trackers (See Hvelplund 2017, 2019; Cui & Zheng 2021a, 2021b).

In distinction to other existing studies on translators' web search, the methodology adopted in this Element takes a qualitative eye tracking-based approach. It attempts to reconcile the methodology used by the aforementioned two camps of studies. On the one hand, eye tracking is employed as a means to record the real-time representation of translators' web search behaviour. On the other hand, the eye tracking recording is then used to prompt or cue translators to think aloud based on their real-time behaviour. In this way synchronous and asynchronous data are brought together. At an operational level, this methodology utilises gaze replay, a common function of visualisation in eye tracking software optimally. The gaze replay, as the name suggests, is a video recording of participants' real-time gaze or eye movements. In other words, while translators conduct their web search and translation task, their eye-movements are recorded on the screen in real time. This screen recording (with translators' eye movements being superimposed on the screen) is not only used as a type of raw qualitative data for detailed analysis but also as real-time and targeted cues to prompt translators to report on their web search behaviours immediately after they complete their translation and web search task. There are multiple advantages to this two-stage data collection method. Firstly, the gaze replay provides visualised data that are far richer and more precise than a traditional screen-recording of translators' web search behaviour. Secondly, the qualitative cue-based retrospective report (i.e. RTA) provides detailed inferences that greatly enhance our understanding of specific aspects of translators' real-time behaviour (i.e. query, browsing and clicking behaviours), which a quantitative approach simply cannot achieve. More importantly, a combination of these two datasets can offer a powerful insight into the interplay between different features of web search behaviour and translators' reasoning behind such behaviour, and potentially how emotive factors may play a role in web search. At this point, it is important to clarify that I am not claiming that cue-based retrospective

interviews have never been used in translation studies before. In fact, they have been used in previous studies for some time. For example, Ehrensberger-Dow and Perrin (2009) replayed screen-recording videos as cues to interview their student and professional translators. More recently, Guerberof, Moorkens and O'Brien (2021) also used cue-based retrospective interview to supplement their quantitative analysis to investigate cognitive loads of User Interface in Microsoft Word.

Here, I would like to reiterate the main reasons why in this Element I decided to go against the flow and challenge the mainstream eye tracking methodology regularly employed in translation studies. First of all, relatively little is known about translators' web search behaviour. It makes sense to employ a qualitative and grounded theory approach to generate hypotheses so that such hypotheses can be tested in future research. In addition, this Element aims to establish when, how and why translators navigate their way through the Web. In other words, uncovering and modelling naturalistic web search behaviour is a top priority. A further reason is that while maintaining maximum ecological validity, it is operationally challenging to generate quantitative eye tracking metrics. As mentioned before, previous eye tracking studies in translation impose strict experimental manipulation and control over their translation tasks. Their ecological validity can suffer as a result. Part of the reasons that these strict experimental controls are in place is linked to how quantitative metrics are generated in eye tracking research. The quantitative metrics in eye trackers are essentially computed from identical stimuli among different participants. Stimuli refer to what is presented on the computer screen that prompts participants to conduct or perform a task. In eye tracking experiments, stimuli act as crucial points of references. Without them, eye tracking metrics are pointless. In the case of translation, stimuli are normally a piece of source text, target text and its associated instruction presented on the computer screen. The source text is normally presented either on top of the screen or on the left of the screen, and the target text is presented either on the bottom or on the right of the screen. In other words, fixed contents are placed in fixed locations on the screen as stimuli. However, unlike previous eye tracking experiments, I am not interested in translators' visual attention on the source text nor its corresponding target text. Instead, I am interested in the dynamics and patterns of translators' visual attention on different varieties of web-based resources and search engines of their choice. In other words, it is imperative that each translator does not just have complete freedom to choose which web browsers or web-based resources to use and what to do with them, but also where to place their chosen web browser or web-based resources on the computer screen in relation to their source text and target text. As a result, there is little identical stimulus or meaningful part of the screen among different translators for eye trackers to generate aggregated metrics. To mitigate this operational dilemma, I have two options. One is to abandon the idea of maximum ecological validity and create an artificial WWW environment possibly with a staged search engine and several staged search engine result pages so that points of references can be established; this means changing my research design and research questions for the sake of generating quantitative data in eye trackers. Or alternatively, I retain my original research questions and design, and focus solely on rich qualitative data that eye trackers and RTA can offer. Clearly, I opt for the latter in this Element.

A final reason for choosing a qualitative approach is that as the aims of this Element are principally in line with usability in the field of Human Computer Interaction (HCI), i.e. translators' interaction with the web and search engines, it is legitimate and logical to adopt a 'tried and tested' data collection method routinely used in usability studies. More details about usability will be offered in the following section.

3.2 Usability in Human Computer Interaction (HCI)

Human Computer Interaction (HCI) is a multidisciplinary field that sits at the intersection between computer science, psychology, behavioural science, engineering, design, etc. As the term literally

suggests, HCI aims to study the interaction between human and computer. According to Hartson and Hix (1989: 8),

...the terms “human-computer dialogue” and “human-computer interface” (also called the “user interface”) are defined separately to denote, respectively, the communication between a human user and a computer system and the medium for that communication. Thus, a dialogue is the observable two-way exchange of symbols and actions between human and computer, whereas an interface is the supporting software and the hardware through which this exchange occurs.

It is worth pointing out here that the software and hardware referred to above is not just restricted to the supported computer applications, but also include any medium or techniques that enable the exchange to take place. Taking a simple action of typing on a keyboard as an example, according to Marsh (1990: 16-17), when a human types a lower-case ‘a’ on a keyboard, the letter ‘a’ is a code that human and computer use in their communication, whereas the finger pressing the letter ‘a’ onto the keyboard represents the medium to carry out this interaction. In other words, the letter ‘a’ represents the dialogue, and the finger along with the keyboard (i.e. ergonomic aspects) represent the interface. This definition has acute implications for this Element, as the two HCI components, dialogue and interface, provide a very useful theoretical framework to understand web search behaviour. In fact, these two components are found to somewhat overlap with White’s (2016) concept of primary action and secondary action regarding the use of a search engine as discussed in Section 2. Obviously, the concept of dialogue and interface in HCI is much broader in its scope than White’s primary and secondary action for search engines, given that the use of a search engine is only one type of human and computer interaction. As stated in Section 1, a detailed investigation of translators’ interaction with search engines is of paramount importance because search engines are among the most frequently used web-based computer applications by translators. When a translator types a query inside a search box in a search engine, this query is a code or ‘dialogue’ being initiated by a translator with a computer. The web browsers and search engines are the ‘interface(s)’ to facilitate this exchange. The search engine responds to the query or replies to the dialogue by retrieving a list of Search Engine Results Pages (SERP). In other words, both the query and the SERP are the observable two-way dialogues between human and computer. Translators’ subsequent mouse clicking actions in SERP represent the interface during this interaction. To a certain extent, the dialogue and interface tell the human side of the story of this human and computer interaction (Marsh 1990: 17). The computer side of the story, however, is related to underlying algorithms built for each search engine which is largely out of the scope of this Element (See Section 2.2). In other words, what this Element aims to do is to illustrate the translators’ side of the story when they interact with search engines and other web-based resources.

Of course, HCI is not a brand new concept in translation studies. In her paper, titled, ‘Translation as a human computer interaction’, O’Brien (2012) first introduces the following two concepts into translation studies: ‘human factors’ and ‘cognitive ergonomics’. According to her, the former refers to ‘how people interact with tools and technology’ and the latter is a more specific concept that is concerned with ‘cognitive demands placed on users by the design and complexity of computer programs (2012: 103). Interestingly, O’Brien’s brief explanation about human factors and ergonomics seems to reveal that she merges two types of perspectives on the term, human factors in HCI. On the one hand, human factors are considered to be a broad concept that is concerned with humans’ use of equipment (not necessarily computer equipment), limitation of equipment designs, functions and performance, and of course how equipment can be improved for optimised human usage, etc. In fact, in the field of HCI, human factors and ergonomics are considered to be the same discipline and are often used interchangeably (See <https://psychology.rice.edu/what-human-factorshci>). This is probably

why O'Brien calls for 'a more caring and inclusive approach towards the translators by developers of translation technology' (2012: 101), as based on her observation at the time, which probably still holds some truth to date, efforts to study and understand how translation technology assists or hinders translators' work largely come from the academia not developers. But, on the other hand, the human factor is also considered to be a broader component of HCI, less concerned with ergonomics, but more to do with understanding how humans interact with computer technology in general and drawing attention to how computer technology plays a role in human lives. This perspective is what I subscribe to in this Element. As mentioned in the previous paragraph, I am interested in understanding how and why translators use the Web and web-based resources and potentially what all this means to translators and their daily practice. Interestingly, roughly around the time when O'Brien introduced the abovementioned concepts of 'human factors' and 'cognitive ergonomics', there was a surge of research in translation studies into 'usability' (a burgeoning field in HCI) in CAT tools, machine translation, post-editing, etc (see O'Brien 2010; Doherty & O'Brien 2014; Cadwell et al 2016).

'Usability' is defined by Preece et al (1994: 722) as, 'a measure of the ease with which a system can be learned or used, its safety, effectiveness and efficiency, and the attitude of its users towards it'. The main goal of usability studies is to ensure that users can interact with a User Interface (UI) in quick, easy, successful and gratifying ways (Nielsen et al 2005). Worth noting here is that while Doherty and O'Brien (2014) prefer to cite ISO/TR16982's definition of usability as a trinity of components, i.e. efficiency, effectiveness and satisfaction, which is largely in line with Preece et al's definitions, contemporary usability studies tend to distinguish a few terms related to usability, such as User Experience (UX) and Usability Testing (UT). In contrast to Usability, User Experience is considered to be a broader concept as it is not just concerned with a UI's efficiency, effectiveness and satisfaction but places its emphasis heavily on users' emotional response and perception (da Costa et al 2019: 30-31). In other words, usability can be considered to be one of the components of the wider User Experience or UX. As for Usability Testing (UT), it often refers to commercial rather than academic studies of usability where there is a burgeoning industry specialising in testing usability of all manners of commercial UI, such as software, websites, smartphones, apps, gaming, sat nav, flight simulators, etc. UX's emphasis on users' emotional response and perception is known to be linked to UT, given that UX is at the heart of commercial interests for a UI. These days, UT is not just conducted after a (commercial) product is developed or deployed, but often as a part and parcel of UI product design and development. In other words, both summative and formative UT form an integral part of modern UI design. Retrospective think aloud (RTA) is a common eye tracking-based data collection method in both UX and UT. In the following, I will explain what retrospective think aloud (RTA) is and how it differs from a think aloud protocol (TAP).

3.3 Retrospective Think Aloud (RTA)

Many scholars in Translation Process Research (TPR) who adopt think aloud protocol (TAP) as a data collection method may initially find the term, retrospective think aloud (RTA), problematic. This is because in the development of verbal report methods in cognitive psychology where TAP originates, TAP is also known as concurrent verbal report, which is in direct contrast to retrospective and introspective verbal reports. The main difference between retrospective, introspective and concurrent verbal reports lies in the timing of conducting the verbal reports. A retrospective verbal report is conducted after a task is finished in its entirety, an introspective verbal report is conducted at intervals during a task, but a concurrent verbal report is conducted simultaneously while subjects are doing a task. In the 90s, TAP was considered to be an updated version of the verbal report method with the advantage of minimising common pitfalls in retrospective and introspective verbal reports where it might be difficult for subjects to remember and report on certain details of the process after a task ends entirely or at intervals during the task. Such difficulties are also linked to issues of subjects'

potential self-analysis as opposed to a more objective account of the process during a task. While controversies may exist around TAP itself as a research method both in TPR and in cognitive psychology, the consensus of early TAP adopters in translation studies seems to be that TAP remains a valuable and worthy data collection method, provided it is used in carefully controlled circumstances.

As mentioned before, in connection with the historical background of TAP as a data collection method in translation studies, RTA appears to be a contradictory concept since it combines the seemingly improbable use of synchronous (i.e. concurrent verbal reports) and asynchronous (i.e. retrospective verbal reports) methods at the same time. This was indeed unthinkable prior to new digital research instruments being developed. Nevertheless, as translation studies (and indeed TPR) began to embrace new digital research instruments, such as keylogging and eye trackers, it became possible to ‘have your cake and eat it’. As explained before, this is owing to the function of ‘gaze replay’ in eye tracking software, which enables translators to re-live their (real-time) translation process synchronously while verbalising their thoughts asynchronously. In other words, this approach commonly used in usability studies has the following dual advantages. It utilises the advantage of using eye trackers by tracking where and when translators’ eyes fixate and for how long. Meanwhile, it also utilises the advantage of TAP by eliciting the reasons why translators’ eyes fixate on certain passages of the texts or parts of the search engine. As a result, a more comprehensive and richer picture of when, how, where and why translators do what they do can be re-enacted and documented in fine-grained details.

Hansen (1991) at the University of Aarhus, Denmark, is probably one of the first scholars to adopt RTA in the field of usability studies. In his study, the use of a traditional video recording is compared with the use of ‘eye mark recording’, as a cue to support retrospective verbal reports in software testing. Hansen (ibid: 48) finds that there is a significant increase (approximately 50%) of problem-oriented verbal comments in the latter method in contrast to the former one. This is an early indication of RTA’s effectiveness as a data collection method. In the last twenty years, there have been many studies offering empirical evidence in support of the plausibility of RTA as a valid research method, not just in usability studies but in many other fields. For instance, Cho et al (2019) use eye tracking-based RTA to evaluate the usability of a (mobile phone) health app and conclude that it is highly effective in identifying critical usability issues in the field of medical informatics. In the field of marketing, Tanner et al (2020) investigate consumers’ engagement in food packaging using eye tracking-based RTA. They also conclude that the use of RTA data shows many promising results in capturing motivational factors that eye tracking alone simply cannot offer. Additionally, Tanner et al (ibid) also comment that the use of RTA may be useful to supplement conscious or semi-conscious (visual) attention captured in eye tracking.

The extensive adoption of eye tracking-based RTA both in and beyond usability studies explains why it is known under many different names, such as cued or (cued-based) retrospective reports, eye movements supported verbal retrospection, (eye tracking) stimulated retrospective think aloud, post experience eye-tracked protocols, etc (Holmqvist et al 2011: 104). It is worth pointing out that among studies adopting RTA as a research method, there are also variations of how eye tracking cues are used in RTA. In fact, Olsen et al’s (2010) study is designed to investigate four different methods of combining eye tracking and RTA data in usability testing. These four methods are: no cued RTA, video cued RTA, gaze plot cued RTA and gaze video cued RTA. Strictly speaking, it can be argued that the first two types of methods are not eye tracking based RTA at all, given that no cued RTA is simply a type of retrospection and video cued RTA is simply a screen-recording or video prompted retrospective report. What is more relevant for the purpose of the present Element is the comparison of the latter two types of RTA, gaze plot cued RTA and gaze video cued RTA. In eye tracking software, gaze plot is basically a 2D or static image of subjects’ cumulative visual attention, including fixation and tracks of eye movements. A fixation is normally represented in blue dots. The bigger the

dots the longer the fixation. Eye movements are normally shown in blue lines. In contrast, gaze replay or gaze video is a live recording with real-time eye movements superimposed on the screen. Unsurprisingly, the results demonstrate that no cued RTA shows the least amount of data while gaze video cued RTA shows the greatest amount of data both in terms of its quantity and variety. This is part of the reason why gaze video cued RTA is adopted in this Element.

As mentioned before, RTA is known under many different names. One of them is Post Experience Eye-tracked Protocols (PEEP). As early adopters of this method in usability studies, Ball et al (2006: 15) describe five stages or steps to conduct PEEP.

Stage 1: A user's eye movements are recorded using a non-intrusive eye-tracker while they undertake an interaction task.

Stage 2: The eye-movement trace is replayed to the user in real time as an overlay on the dynamic record of screen-based activity, so as to provide visual cues as to where they were looking during task performance.

Stage 3: The user is requested to use the dynamic replay of their eye-movement trace as a cue to encourage retrospective reporting of task-based activity.

Stage 4: The resulting retrospective verbal protocols are coded and analysed by trained evaluators to determine usability issues associated with the interface.

Stage 5: Recommendations for interface redesign and improvement are established and are referred back to clients.

Apart from RTA, it is important to clarify that it is possible to combine eye tracking and think aloud at the same time. This is known as (eye tracking-based) concurrent think aloud (or CTA) in usability studies. This means that a subject is asked to think aloud and conduct a given task at the same time as an eye tracker is tracking the subject's eye movements in the background. CTA is also used in eye tracking studies in adjacent disciplines outside translation studies. Many of them even compare and contrast the use of CTA vs RTA as data collection methods (See Bowers & Snyder 1990; Gero & Tang 2001; Van Den Haak et al 2003). The general consensus, however, is that collecting eye tracking data and think aloud data at the same time (i.e. CTA) is only recommended under very specific conditions, the reason being that think aloud is believed to 'mess up' eye tracking metrics due to the extra cognitive load it may impose. An accurate measurement of fixation durations (linked to cognitive load) is of paramount importance in eye tracking research. The only exception is in certain circumstances where a research question is related to the extra cognitive load imposed by certain visual stimuli (Holmqvist et al 2011: 103). For instance, in educational psychology, CTA is found to be useful in studying how certain reading materials or screen set-up (i.e. visual stimuli) may affect a learner's cognitive workload, which may hinder learning as a result.

3.4 Data Collection Procedures

In the study this Element focuses on, a group of twenty-one student and professional translators (students n=11, professionals n= 10) were recruited to translate a medical text from English into their mother tongues. The source text (136 words) was abstracted from a medical case report, titled 'Paraplegia follows epidural' from the website shown below.

The translators' language combinations include (in alphabetical orders) English-Arabic, English-Chinese, English-German, English-Japanese, English-Russian and English-Spanish. All participants

were recruited either via open call or snowballing method. Their participations were voluntary. The professional cohort had a wide range of professional backgrounds, including legal translation, medical translation, audio visual translation, literary translation, localisation, etc. The student cohort was all recruited from the postgraduate translation programmes (both MA and MSc) at my home academic institution, University College London, UK. Ethical approval was obtained and all necessary procedures were followed. A gift voucher was offered after each participant took part in the study.

The source text was presented in a Microsoft Word document, font size 18. The default web browser was Google Chrome zoomed at 150% for ease of tracking visual attention. Participants were given simple instructions to translate the source text into their mother tongue and use the Web whenever or wherever they deemed necessary. No time limit or any other restrictions were imposed. Immediately after translating, participants were cued to think aloud retrospectively while viewing the real-time gaze replay recording.

The data collection took place in an office with ample natural light at my home academic institution. The eye tracker used is a SMI 250 Mobile (with a sample rate of 250 Hz). Standard 6-point calibration was conducted using SMI iView software prior to the data collection. Calibration procedures were repeated if necessary. SMI's BeGaze software was used to play the gaze replay and record the retrospective think-aloud (RTA) simultaneously.

Section 4. Findings and Discussion

This section will seek to answer the questions posed in Table 1 (see Section 1), largely following the order of the three themes stated. They are: the use of online resources (Subsection 4.1), query-related behaviour in search engines (Subsection 4.2) and clicking and browsing-related behaviour in search engines (Subsection 4.3). Relevant information theories (as reviewed in Section 2) will be drawn on to frame discussion and support empirical findings throughout this Section.

4.1 The Use of Web-based Resources

This subsection will not just focus on what web-based resources are used, but perhaps more importantly on how and why translators use online resources the way they do. This is because the types of web-based resources used have been well documented in previous studies, as shown in Section 2. For instance, Massey & Ehrensberger-Dow (2011a) report that student translators tend to use online dictionaries whereas instructors tend to use parallel texts and search engines. Gough (2016: 131-173) also reports an extensive list of online resources and how frequently they are used by professional translators. Search engines are the top of the list as the most frequently used online resource. This is followed by bilingual dictionaries and online encyclopaedia (i.e. Wikipedia). Discussion forums, corpora, online glossaries and Google Translate (NMT) also feature in her list. Similar varieties of online resources are also found by Shih (2017: 53-54) and Cui & Zheng (2021b: 62-63) to be used by their postgraduate Chinese student translators. The fact that search engines are commonly found to be one of the most used online resources warrants some attention, not least because unlike the use of bilingual dictionaries, few details are known about this process. Therefore, the use of search engines will form a substantial part of the discussion in this Element. To sum up, previous studies have consistently shown that (bilingual) dictionaries and search engines are the two most frequently used online resources by translators, even though some variations in terms of their levels of experiences and language combinations inevitably play a role in their preference and idiosyncratic behaviour when using them. In the following, I will elaborate on further features of translators' use of online resources based on the empirical data elicited.

4.1.1 General and Idiosyncratic Use of Web-based Resources

In terms of the use of search engines, this Element shows that some translators prefer to stick to Google exclusively, while others prefer to use a more varied combination of web-based resources, such as Google, Baidu (a Chinese search engine), bilingual corpora (e.g. Linguee), and several different types of online dictionaries (e.g. monolingual, bilingual, specialised, and thesauruses), etc. In other words, in common with previous studies, this Element also confirms that most translators as a whole use overlapping types of web-based resources, although individual translators, be they trainees or professionals, have their own idiosyncratic preferences. Several factors are found to be at play here. Language combination is one of them. For instance, most translators invariably use Google as their sole search engine. This is probably owing to the fact that Google is not only one of the most popular search engines around the world, but also the search engine that supports multiple languages. In this Element, Arabic, Japanese, French, German, Russian, and Spanish translators all rely on Google as their sole search engine. In fact, Google is often their first port of call for any information seeking on the Web. However, interestingly, such phenomena do not apply to Chinese translators. Instead, Baidu alongside Google are the choices of search engines for them. This is partly because Google was pulled out of the Mainland Chinese market in 2010 due to censorship rows with the Chinese authority. As a

result, Google has not been available in China since. It has to be clarified though that this does not mean that Google no longer supports Chinese as a language. As a matter of fact, Google remains the most popular search engine in Hong Kong, Taiwan, Singapore, and other Chinese speaking regions and communities around the world (See <https://www.statista.com/statistics/1128881/taiwan-market-share-of-search-engine-websites/>). Given that the data collection was conducted in the UK for the present Element, the Chinese translators had access to both Google and Baidu. On the one hand, some deliberately forego Google and prefer Baidu, citing the reason that Baidu represents a more reliable and comprehensive source of information in Simplified Chinese. On the other hand, there are also individual Chinese translators choosing to use Google predominately rather than Baidu, citing the reason that it has gradually become a habit to use Google. For instance, Subject P20, a student translator, states in her RTA, 'Recently, I am finding myself relying on Google a lot more, probably because I am writing my dissertation at the moment and consult Google more'. Subject P20 reflects that she is largely using Google rather than Baidu as her search engine of choice. This change of preference is probably due to her recent practice of adopting Google for her dissertation writing in English. This demonstrates how a translator can gradually form a collection of web-based resources via their daily use of the Web, probably not from their translation experience exclusively. Such usages can easily be influenced by other external factors, be they academic, geographical, cultural, or even political. To a certain extent, this reveals the reality of translators' work, that is, they cannot be 'immune' to the wider digital landscape that they have little control of. The use of search engines very much typifies these ever-changing influences and dynamics, particularly because search engines are not just used exclusively for translation purposes, but also for other information purposes in translators' daily lives.

As mentioned earlier, search engines are among the most used web-based resources by translators. A question that arises here though is whether search engines should be considered a type of web-based resources at all, given that search engines represent a gateway to other information resources on the Web, rather than an information source per se. Empirical data in this Element reveals that search engines alone are indeed used by many translators as an independent source of information, rather than just a gateway to other information on the Web. In other words, it is not just a means to an end, but also an end in itself. For example, Shih (2021: 86) reports that one of her subjects is rarely found to click on any hyperlinks in SERPs. She suggests that there are no real incentives to click on any hyperlinks, given that snippets provide sufficient information to satisfy a subject's query intent. This subject is not the only translator who does this though. In fact, it is shown in this Element that not clicking on any hyperlinks is very much a routine behaviour shared by many translators, rather than an exception. It can be said that translators are effectively using the search engine as if it were a dictionary. Snippets in SERPs represent dictionary entries albeit at a much larger scale. Translators' decisions to click or not to click in SERPs is determined by a variety of different factors, not just by their query intent alone.

One possible reason for translators' non-clicking behaviour is probably because web search largely represents approximately a third of the whole translation process (see Cui & Zheng 2021a, 2021b; Gough 2016) and often occurs early in the process (see Hvelplund 2019). In other words, for most translators, web search is only an initial vehicle or a problem-solving tool for them to start or to continue to translate. It is an initial and necessary 'hoop to jump through' so to speak, so that they can get on with their real task, which is to translate. In addition, translators are often faced with a large list of queries triggered by the ST, particularly when the ST consists of specialised terminologies or contents. This is coupled with the fact that translators are likely to be acutely aware of the amount of time it could take to go through each of these queries. From this perspective, keeping an eye on the amount of time and efforts spent on web search and making sure that no more time than necessary is invested is very much a necessity. Therefore, it is perhaps no surprise that translators are inclined to save time by not clicking on hyperlinks at all in SERP. This is in spite of the fact that in the study reported in this Element and in many previous studies, no time limit was imposed on translators. In

fact, time-saving comments can be repeatedly found in the RTA data in this Element, such as, ‘instead of waiting for a webpage to load, I go back to read other snippets’, ‘at this point, I decide to just translate it roughly rather than spending more time searching. Will come back later for this problem’, ‘copy and paste will save me time from typing this word’, etc.

The other possible reason for not venturing out of search engines is probably related to the ‘satisficing strategy’ (see Section 2.1). As mentioned before, according to Pirolli’s information foraging theory (2007), an information user does not always exhaust all the information available but focuses on locating ‘good enough’ information before ending their search. From translators’ point of view, if the SERP itself provides sufficient information to solve their translation problems, it is naturally unnecessary to click on any hyperlinks at all. A third reason is likely to be the effect of ‘Google generation’ (i.e. shallow reading, power browsing and constant flickering between different web-based information) as pointed out by Gough (2016: 33). In other words, translators’ use of search engines may be a manifestation of the way humans process digital information on the Web where short bursts of information processing are much preferred over lengthy and laborious ones. Snippets being short bursts of information in SERP therefore represent more favoured information sources than those presented in external webpages outside search engines.

4.1.2 Ad-hoc and Evolving Use of Web-based Resources

In Subsection 4.1.1, the dynamics of how translators may gradually form and change their habits of accustomed collection of web-based resources is partially presented. Adding onto this, further empirical evidence will be presented in this section to show how this formation process may take place on an ad-hoc basis. The following two web search episodes capture this phenomenon.

As Table 2 shows, Subject P18, a student translator, started with the query, ‘medical dictionary English to Chinese’ in Google. She scrolled down the SERP and then selected one of the hyperlinks, which is Dr Dict (an online medical dictionary). At first, she used Dr Dict frequently and commented that she was trying to get used to this new online dictionary. Her (eye-tracked) visual attention largely confirms this, as she was scanning around various parts of this online dictionary. Then, when posing the query, ‘revision surgery 中文’ (back translation: revision surgery Chinese) in Google, she came across another specialised dictionary, Scidict. She expressed her preference for Scidict over Dr Dict saying, ‘[Scidict] is a better one with lots of sample sentences’. She also admitted that she did not normally do medical translation. Throughout her entire web search process, she was found to largely rely on these two dictionaries in addition to Google despite her brief encounters with the Cambridge dictionary and Google Translate. To sum up, the web search process of Subject P18 has shown that first of all the repeated use of web-based resources can be developed on an ad hoc basis. It shows the dynamics that search engines cannot only be used to locate web-based resources that are already known to translators, but also shift to locating new ones for specific translation tasks, particularly when a translator is unfamiliar with a ST domain. As mentioned before, the use of web-based resources is an ongoing, dynamic and a multi-layered process. In this case, it is also a learning process. While using these two ad hoc online dictionaries, Subject P18 is also learning how to use them better and to evaluate which one is better suited for the translation task at hand or even possibly for a future translation task in a similar domain.

While the fact that Subject P18 was a student translator might explain her ad-hoc learning and usage of web-based resources, it is worth noting that the same could also apply to professional translators. To take Subject P09 (a professional translator) as an example, she also began her web search by using Google. Initially all her queries in Google consistently included a ST term, a comma, 中文 (Back translation: Chinese), a comma and 医学 (Back translation: Medicine). For instance, her query for the ST term, ‘weaning’ looked like this, ‘weaning , 中文 , 医学’ (Back translation: weaning, Chinese, Medicine). She reported in her RTA that this query pattern had worked very well for her before. It therefore became something she used on a regular basis in Google. Nevertheless, she subsequently realised that while using this query pattern, her SERP consistently presented her with a hyperlink from one specific online dictionary, Scidict. As a result, in the second half of her web search process, she decided to go to Scidict.com directly for all her subsequent terminology-based queries. Just like Subject P18, Subject P09 also indicated that Scidict was not an online dictionary she had come across previously, but she learned that it seemed to be a useful online dictionary for this translation task. In other words, Subject P09, a professional translator, also learned and evaluated which (ad hoc) web-based resources were more helpful during the course of her web search process and then adapted her web search behaviour accordingly.

4.1.3 The Use of MT/NMT

The reason that the use of Machine Translation (MT) and Neural Machine Translation (NMT) is discussed here is because it is considered to be a feature and an integral part of translators’ web search process, as reported by previous studies (see Gough 2016, Shih 2017, 2019, 2021). For instance, Gough (2016: 163) found that approximately 75% of professional translators identify themselves as non-MT users in her large-scaled survey. That leaves roughly 25% of professional translators as MT users. Following van Der Meer & Ruopp’s findings (2014), Gough (ibid) divides these MT users into two groups: the search and discovery users, and post-editors. The former represents translators using MT as a web-based resource to find more information, and the latter represents translators using MT for post-editing purposes. She concludes that overall, the former is increasingly more common and further research is required to investigate how translators use MT as a resource of information. The present study can be seen to respond to this call.

Before going any further into the discussion, it is worth clarifying here that translators' use of MT/NMT will only be discussed within the aim of this Element, given that a wider discussion about MT/NMT is beyond its scope. Not too dissimilar to Gough's finding (as mentioned previously roughly a quarter), empirical data in this Element also showed that eight out of twenty-one translators (just over a third) have actively used NMT, such as Google Translate and Baidu Fanyi (i.e. the NMT associated with Baidu, the most popular Chinese search engine) during their web search process. Here, actively using NMT is defined as translators actively posting ST segments into NMT for a TL equivalent. However, the use of NMT is a lot more prevalent when taking into account passive usage of NMT. This is because Google Translate and Baidu Fanyi are both associated with their respective search engines. Modern search engines are AI supported and often offer suggested search results, including NMT results in SERP. The consequence of this is that even though translators are not actively pursuing NMT, NMT still plays a considerable role in translators' web search process. The following example captures this.

As seen in Fig 1, Subject P13 was using Baidu to query the ST term, 'wean'. The featured result (shown as the first hyperlink on the top of the SERP) was a result from the NMT, Baidu Fanyi (fanyi.baidu.com). This naturally grabbed Subject P13's visual attention. She then subsequently clicked on this featured hyperlink to investigate further.

Figure 1. Subject P13's web search for 'wean' in Baidu

Part of the reasons that Baidu Fanyi (NMT) is presented as the featured link in a prominent position in SERP is likely because Baidu is essentially a Chinese search engine that caters for the Chinese demographics. This search engine therefore considers Chinese queries as a norm in its search box. When Subject P13 posed an English term, 'wean' in its search box, its algorithm assumed that the searcher was looking for a Chinese translation or Chinese definition for this English word. Therefore, the link, fanyi.baidu.com (Baidu's NMT) is featured at the top of the page. In fact, the other link, www.iciba.com, one of the popular online dictionaries in China, is also ranked highly in the same SERP, right after the featured NMT result. In other words, the ranker, as mentioned in Subsection 2.2.1 Search Engine Mechanics, clearly plays a role here in prompting and pushing dictionaries or dictionary-like results to the top of the SERP. This consequently has an effect on how often Baidu Fanyi (or indeed other NMTs) is used by Chinese translators.

Apart from NMT in search engines, it is also found that NMT is frequently embedded in some online dictionaries. Lingoos, a multilingual online dictionary package, is one example, as indicated in Shih's (2017) study where NMT is routinely presented as one type of (dictionary) entries in Lingoos. In this Element, it is also found that ICIBA and Youdao represent the other two common use of NMT for Chinese translators. ICIBA and Youdao are two online dictionary packages that were originally developed as digitalised versions of multiple paper-based (English-Chinese) dictionaries. However, in recent years, they have been expanded not only to function as online dictionaries but also as NMTs. Just like NMTs associated with search engines, these NMTs can be used independently, but more often than not, they are simply embedded in ICIBA and Youdao as dictionary entries. Figure 2 shows an example of Subject P12's use of Youdao and its associated NMT.

Figure 2. Subject P12's web search for 'mid thoracic spine' in Youdao

In Figure 2, Subject P12 used Youdao online dictionary to search for the ST term, ‘mid thoracic spine’ (highlighted in blue). This term could not be found in any of the digitalised paper-based dictionaries in Youdao. However, an NMT solution was shown at the top as an entry, i.e. ‘中期胸椎’ (Back translation: middle position thoracic spine). Subject P12 reported in her RTA, ‘Youdao offers a NMT solution here. I can see that the sample sentence following the NMT is not quite right either. I don’t normally trust NMT solutions. I trust glossaries more’. She then moved on to use the same query in Baidu in her attempt to find out more about this ST term. Interestingly, when Subject P12 posed the same query in Baidu, Baidu Fanyi (Baidu’s NMT) was also featured in its SERP prominently. While Subject P12 expressed her reluctance to trust NMT solutions, many other translators in this Element simply accepted NMT results, particularly those embedded in online dictionaries, as if they were trusted dictionary entries.

To summarise, many multi-functional online dictionaries serve as a ‘one-stop shop’ for translators to solve their translation problems. In fact, this is largely what Shih (2017) finds in her study of student translators. Desktop or app versions of these online dictionary packages can also be downloaded and installed easily. As a result, translators have even easier and sometimes semi-automatic access to them. For instance, ICIBA’s desktop version enables translators to simply place a cursor on a ST term for it to activate searches of its multiple online dictionaries and NMTs. It will be interesting for future researchers to focus on how these semi-automatic functions of online dictionary packages may potentially affect translators’ web-based information behaviour and translation process with or without the use of CAT tools. Finally, it is important to iterate that the (passive) use of NMT for non-postediting purposes is increasingly common and frankly impossible to avoid by translators, given the ways NMT solutions are embedded in modern search engines and online dictionary packages.

4.1.4 The Use of Baidu as a Bilingual Dictionary

In terms of the salient characteristics of how web-based resources are used, this Element also illustrates an interesting phenomenon related to Chinese translators’ use of Baidu that is worth a closer investigation. Two scenarios are shown in Figure 3 and Figure 4 respectively below.

Figure 4. Subject P13’s web search for ‘coronary artery bypass graft’ in Baidu

Both Figure 3 and Figure 4 show Subject P13’s query for the ST term, ‘coronary artery bypass graft’. In Figure 3, this query is posed in Google and in Figure 4 the same query is posed in Baidu. Obviously, it is important to point out that SERP are tailored to individual searchers, as mentioned before, this is because modern search engines are AI supported and designed to learn to customise their SERP depending on each searcher’s search history, timing, geographical location, etc. On the surface at least, it may not always be useful to compare and contrast the use of the same query in different search engines, given that search engines each have their own algorithms. However, it is interesting to illustrate how the translator has deliberately chosen to use these two different search engines in quick succession for the same search query. As mentioned in Subsection 4.1.1, Baidu is a Chinese search engine. Unlike its counterpart, Google, Baidu’s algorithm is designed to predominately cater for the Chinese demographics. When an English term is posed inside the search box of Baidu, its algorithm clearly recognises that this is a non-Chinese query. As a result, Baidu prioritises hyperlinks that offer Chinese definitions for the English query/term in its SERP. As shown

in Figure 4, the first hyperlink in Baidu's SERP is a Wikipedia page with a first line of snippet stating, '查看此网页的中文翻译, 请点击[翻译此页](#)' (Back translation: For Chinese translation of this webpage, please click [here](#).) The second hyperlink is from Youdao dictionary. Its snippet offers several Chinese equivalents for the queried ST term. Similarly, the fourth link also offers a Chinese equivalent. This is in direct contrast to Figure 3 when the same ST term is used as a query in Google. Google also identifies this query as a term and presents its Knowledge Box on the right side of the SERP. Knowledge Box is a relatively recent addition to Google's algorithm, which automatically recognises certain queries as common terms and presents a short definition (and sometimes pictures) in SERP. Subject P13, who is translating from English into Chinese, recognises that it is more advantageous for her to use Baidu rather than Google, given that her primary query intent at the time is to locate TL terms. This is why after initially posing her queries in Google, she then decides to dedicate her time to Baidu exclusively throughout her whole web search process. To put it in a different way, she is aware of the different results obtained by posing ST terms in Google and Baidu, and strategically adapts her web search to use Baidu exclusively as if it were a bilingual dictionary.

4.2 Search Engine Behaviour and Cognition: Query-related

This subsection will be dedicated to the discussion of translators' use of search engines, particularly related to queries. As mentioned previously in Subsection 4.1, search engines have been repeatedly identified as among the most frequently used web-based resources in previous studies (see Shih 2017; Cui and Zheng 2021a, 2021b). Queries are important because they represent the first step of a translator's interaction with search engines. As mentioned in Section 2, there are two basic components of HCI: dialogue and interface. Search engines represent the interface that facilitates interaction between human and computer in this instance. When a translator posts a query into a search box, s/he essentially initiates a dialogue with the computer via this interface. The query represents a 'code' or 'language' used to communicate with search engines. Search engines respond by presenting hyperlinks in SERP. A translator can then decide how to respond or even whether s/he wants to continue this dialogue. S/he can choose to respond to this dialogue by clicking on a hyperlink. This then prompts a new dialogue on a webpage outside search engines. At any point of these interactions, a translator can decide to abandon this dialogue (known as query abandonment; see White 2016: 21-37) and/or initiate a new one. Translators' browsing and clicking in SERP will be discussed in detail in Subsection 4.3. In this subsection, I will focus on translators' initiation of the dialogue with search engines. It aims to answer the questions of salient characteristics of translators' use of queries in search engines, as seen below.

- What types of queries in search engines do translators tend to use?
- Which query type is more commonly used and why?
- What does query intent entail?
- How and in what circumstances do queries relate to query intent?

4.2.1 Types of Queries and Dominant Query Type

Previous studies (see Shih 2017; 2019; 2021) have identified various types and combinations of queries posed by translators. These include:

- a ST term[/segment]

- a TT term[/segment]
- a ST term[/segment] plus TT equivalent
- a ST or TT term[/segment] plus Boolean operators or other words to narrow down the search
- a ST term[/segment] plus a natural language question
- a natural language question (by itself)
- a ST term[/segment] plus the name of the TL
- a ST term[/segment] plus its collocating verb
- a provisionally translated TL term[/segment]

Examples of these query types have been shown and discussed in detail in previous studies (Shih 2017, 2021) and will not be repeated here. Here, I would like to address the ‘elephant in the room’, a predominant type of queries, i.e. ST term, in search engines. This is not only found in previous studies but also evident among all the twenty-one translators who took part in the study for this Element.

To understand this query type, it will be useful to first refer to the concept, ‘Rich Point’. According to PACTE (2011: 41), Rich Point refers to a ST segment that poses a problem and hence triggers problem solving behaviour in translation. In my previous study (Shih 2019: 7), the concept of Rich Point is used to investigate trainee translators’ optimisation of locating TL terms in their web search process. Interestingly, comparable definitions (to Rich Point) can be found in several web search studies with various names, including ‘information seeking trigger’ (Wang 2018), ‘information need’ and ‘information goal’ (Enrique Raido 2014: 112-146). All these studies have shown that ST terms represent one of the most important initial prompts for web search in translation. What this Element has added to this finding is that ST terms or segments are mostly used directly, intuitively, or even conveniently as initial queries in search engines without any alterations whatsoever by translators. In other words, the ‘code’ translators choose to put forward to search engines is a direct copy-and-paste of ST term(s). Directly copying and pasting ST terms in the search box has the advantage of least cognitive efforts at least initially, even though it may have the disadvantage of potentially generating less useful information in SERP and requiring more cognitive efforts subsequently in assessing and sieving through information provided by SERP. Maximising search results and minimising cognitive efforts and time spent on web search have proven to be important considerations for most translators. As mentioned in Section 4.1, translators often adopt the time-efficiency strategy to do so. But it is evident that most translators choose to adopt the approach of investing least cognitive efforts in the first instance for their interactions with search engines. This interesting query behaviour is likely to be a result of several external and internal factors. In terms of the external factors and particularly in a wider digital context, popular search engines, such as Google and Baidu, are keyword-based search engines. Those of us who are old enough to have witnessed the birth of the Internet might remember that first-generation search engines, such as Yahoo and Alta Vista, have an index-based ‘facade’ that offers a directory of many different websites that a searcher can click to browse. For a number of years, it was Yahoo rather than Google that dominated the scene of search engines worldwide. But, since its launch in the late 90s, Google gradually turned the tide to become ‘The Search Engine’ of the world. Unlike Yahoo, Google is a true keyword-based search engine that trawls the Web based on queries posed in its search box. After a query is posed, Google presents a series of search results in SERP. Naturally, translators, as users of Google, are more inclined to use ST terms as their keywords or queries. Apart from this, another possible reason is that to the best of my knowledge, in many of the studies conducted on translators’ web search process, including the study presented in this Element, the source texts tend to be semi-specialised texts in science, technology, and medicine. The

nature of these (semi-)LSP texts inherently consists of many ST terms that constitute overt problems for translators to solve. From this point of view, it is no surprise that translators tend to use ST terms as their queries at least initially in their web search process.

4.2.2 Types of Query Intent

Query intent is defined in my previous study (Shih 2021: 76-77) as translators' intention or reasons for posing their queries in search engines. It is important to point out that the concept of query intent differs from similar concepts in previous studies, such as 'information goals' being described as either ST or TT-oriented, or 'information needs' as being triggered by ST segments for problem solving (Enrique Raido 2014: 112-171), in the sense that it focuses on a more micro-level and momentary reasons why a particular query is posed in search engines. This is crucial for several reasons. Firstly, query intent is found well suited for depicting the dynamics of translators' web search behaviour, particularly behaviour revealed by the qualitative eye tracking methodology adopted in the study discussed in this Element. Essentially, the concept of query intent acknowledges that an identical query could be linked to multiple query intents. For example, the concept of query intent is particularly useful in analysing why different translators behave very differently on a granulated level, when they pose the same query using the same search engine. In addition, query intent should also be distinguished from 'search intent', which is commonly used in IR Studies as 'navigational, informational or transactional' (Broder 2002; cf Shih 2019), given that 'search intent' only offers generic categorisation of searchers' reasons for either navigating to another website (navigational), finding more information about a topic (informational) or carrying out an action (transactional), none of which provides much analytical value for the present Element.

Query intent is found to play a vital role in translators' decision making in their interaction with search engines. In my previous study (Shih 2021: 84), a list of seven query intents is found among ten professional translators. They are:

- 1) Locating a TL term.
- 2) Locating further background information.
- 3) Validating a TL term or expression.
- 4) Seeking inspiration for alternative terms or expressions.
- 5) Locating TL collocation.
- 6) Post-editing intent.
- 7) Language-specific intent.

Empirical data reported in this Element largely confirm these query intents. However, they also reveal that there are many other possible query intents in addition to this list. In fact, one of the most significant findings about query intent is that it is perhaps not possible to provide an exhaustive list, given that query intents are ever-changing, interacting with the information found in SERP, preceding queries and also with translators' own background knowledge or personal experiences. In other words, query intent is highly context-dependent and unique to each individual translator.

An example of a new query intent can be found in Subject P11's web search for 'cardiac surgery unit', as shown in Figure 5.

Figure 5. Subject P11's web search for 'cardiac surgery unit' in Google

Here, Subject P11, a student translator, was seen to pose the query, 'cardiac surgery unit'. In her RTA, she reported that at this point, she was trying to check whether 'cardiac surgery unit' was a proper noun or not. In other words, her query intent was neither locating any TL equivalents, nor searching for further background information about the ST term, but solely establishing whether 'cardiac surgery unit' was a proper noun or not; the answer would presumably determine whether she could translate it by herself or it required her to invest more time and efforts in searching for a suitable TL equivalent. According to Subject P11, her confirmation that 'cardiac surgery unit' was indeed a proper noun did not come from any hyperlinks nor snippets in the SERP. This was largely reflected in her visual attention captured in the gaze replay where she hardly scrolled down to read the snippets at all; instead, her confirmation came from her noticing a long list of suggested queries (on which her visual attention lingered) in the query box itself. As shown in Figure 5, the query box in Google offered a long list of ten query suggestions, including 'cardiac surgery unit **vgh**', 'cardiac surgery unit **nursing**', 'cardiac surgery unit', etc. Effectively, this list of suggested queries alone had already fulfilled her query intent and informed her that this ST segment was indeed a proper noun/term. The result of this query intent then led her to form another query intent. Meanwhile, it is worth pointing out that this is yet another prime example demonstrating that translators will always maximise their search results with minimal cognitive efforts. It also reveals that translators are using search engines creatively. Ultimately, Subject P11's query intent determines her non-clicking and browsing action. From the point of view of HCI, it shows that in search engines, from the very moment when a translator lifts her/his fingers to type a query, the dialog with the computer begins. In this example, Google's query suggestions represent a part of the responses from the search engine to the translator. This initial response alone proves to be sufficient to fulfil the translator's intent.

The following example in Table 3 shows complex dynamics of interwoven relationships between queries and query intents, as they evolve consequentially during the web search process.

In this web search episode (see Table 3), Subject P17 was focusing on the ST term, ‘consultant anaesthetist’. It took him nine queries associated with multiple query intents to resolve his problem and eventually end this entire web search episode. According to his RTA, initially he was not sure which grade or rank of doctor ‘consultant anaesthetist’ was. This was his overarching query intent. He started with his first query, ‘consultant anaesthetist’ in Youdao dictionary. But, this query intent was not considered fulfilled, because Youdao did not seem to be able to locate any TL equivalent, apart from a Youdao Fanyi (Youdao’s NMT) solution. Subject P17 then decided to try another NMT, Google Translate, which returned an identical solution, ‘顾问麻醉师’ (Back translation: consultant anaesthetist). He then decided to use this NMT solution as his new query in Baidu. The query intent at this point was to verify whether this NMT solution was a plausible term in the TL, even though he said that he knew it was not. He confirmed that the NMT solution was not a common term in TL, just as he suspected. Consequently, he decided to try Google again. With two successive queries, ‘consultant anaesthetist meaning’ and ‘consultant meaning’ in Google, he was still looking for clues for his original intent, i.e. which grade or rank of doctor consultant was. While browsing the SERP in Google, he found that a consultant was referred to as a senior doctor in the featured link at top of the page. Armed with this new piece of relevant information, he decided to go back to Baidu and pose the query, ‘高级麻醉师’ (back translation: senior anaesthetist), a literal translation in the TL, the query

intent here was then to find out whether this literal translation existed in the TL. He concluded that the answer was negative based on his browsing of SERP snippets in Baidu. While browsing the snippets, he decided to click on one of the hyperlinks. This took him to a TL webpage that explained different ranking of doctors in China. This newly found webpage gave him two relevant titles for doctors, 主治医师 and 主任医师; the latter being a more senior role. This prompted him to go back to Google to find out more about rankings of British doctors. The query this time was ‘consultant rank in hospital’. Again, he chose to click on a hyperlink. This took him to the British Medical Association (BMA) webpage confirming that consultant was the highest rank of doctors in the British medical profession. At this point, he had largely resolved his original goal of finding out what rank or level ‘consultant’ was and at the same time located the title of a highest-ranking doctor in the TL. According to him, the only issue left (i.e. query intent) was that he was not sure about the collocation of a highest-ranking doctor and anaesthetist in the TL. He cautiously posed a preliminary (literal) translation, ‘麻醉主任医师’ (back translation: anaesthetic senior doctor) in Baidu, as his query to check whether this was a viable collocation in the TL. Snippets in SERP showed that this was a probable collocation but there was also an alternative one, which he seemed to prefer. This was when he posed his final query, ‘麻醉科主任医师’ (back translation: senior doctor of the anaesthetic department) with a query intent to find more evidence to bolster his preference. As his preferred solution could be found in several snippet in SERP, he decided to conclude this web search episode and adopted it as his translation for the ST term. One interesting feature worth pointing out here is that query intent can have very different properties. Some query intents are purely explorative and open-ended in nature and aim to find out what information is available out there, while other query intents are more fixed and rigid, for example merely for validating or verification purposes. With these more fixed and rigid query intents, as shown in Subject P17’s web search episode, translators may have already made up their mind or at least have a strong inkling of what they will find in SERP. In this case, the underlying objective is to help validate their suspicion or even bolster a pre-determined translation solution. This narrows down their web search to a more targeted way of locating evidence to support their inkling.

To sum up, the web search episode shown above in Table 3 has illustrated how an overarching search intent can evolve organically into several micro query intents. This very much epitomises Bates’ berrypicking theory (Bates 1989: 410), as shown in Section 2.1. In other words, each query intent is dynamic in the sense that they can be created ad hoc and informed by the finding of a previous query. Each query then provides some more clues and directions for subsequent queries and query intents. Each of the micro query intents gradually brings the translator incrementally closer to her/his final destination where the overarching search intent is finally fulfilled.

4.3 Search Engine Behaviour and Cognition: Browsing and Clicking

This subsection is dedicated to the clicking and browsing behaviours in search engines. As mentioned in Subsection 3.2, in HCI, while queries represent the initial dialogue of the interaction between translators and computers (via search engines), clicking and browsing behaviour represents the subsequent dialogue. This subsequent dialogue is probably one of the most complex aspects of the web search process, as it epitomises whether an existing dialogue will continue or end, or a brand-new dialogue is initiated, sometimes outside search engines. This subsection focuses on the following.

- Sequences or patterns of browsing and clicking behaviour in translators’ interaction in SERP.
- Reasons and implication of translators’ decision not to click on any hyperlinks in SERP.
- Determining factors involved in translators’ clicking and browsing behaviour.

4.3.1 Sequences and Patterns of Browsing and Clicking Behaviour in SERP

In my previous study (Shih 2021), a diagram of the sequence of translators' clicking and browsing behaviour in search engines is mapped out (see Figure 6). It shows a general pattern or sequence of translators' visual attention (i.e. scanning or reading action) and their active dialogues (i.e. clicking action) with search engines after a query is posed. Typically, translators start with scanning action in SERP, characterised by their rapid and vertical visual attention. This is when their first judgement of relevance takes place, which determines whether any snippets in hyperlinks are worth reading or not. If not, the sequence will end and moves back to a new query. If yes, translators commence their reading action of SERP, characterised by slower and horizontal visual attention. The second judgement of relevance takes place at this point. If a snippet or hyperlink is judged to be relevant, translators then click on the relevant hyperlink to investigate further. If not, again, the sequence ends and moves back to a new query. When a hyperlink is clicked or when an external webpage is opened, translators can choose to scan and/or read. This is when the third judgement of relevance takes place. If the judgement of relevance is positive, the whole search sequence comes to an end satisfactorily; if it is negative, it could lead back to the second judgement of relevance again where another hyperlink could be judged relevant and clicked, or it could lead back a new query. To sum up, there are 3 points of judgement throughout the sequence of clicking and browsing behaviour. Each of these judgements represents a crossroad that determines whether translators should continue to invest their time and efforts by clicking or browsing further or not.

Figure 6. The sequence of translators' browsing and clicking behaviour in search engines

4.3.1a To Click or Not to Click, That Is the Question

Here, I would like to focus on one particular feature or pattern of translators' search engine behaviour, which is 'query abandonment' (White 2016: 21-37; cf Shih 2019). As mentioned previously, in IR studies, query abandonment refers to the circumstance where a searcher chooses not to click on any links in SERP. As the word, 'abandonment' literally suggests, this is an indication of negative and unsatisfactory search engine usage, as it is generally considered to be evidence that a searcher is not happy with the search results and therefore chooses not to interact with the SERP (see Khabsa et al 2016; Wu & Kelly 2014). Nevertheless, this is not the case for translators, as translators' query abandonment often represents a satisfactory end to the whole search episode. This somewhat aligns with 'good abandonment' phenomena in IR research (see Li et al 2009, Khabsa et al 2016) where a searcher decides that information provided in SERP itself is sufficient, although it remains a thorny issue in IR studies in terms of how a search engine algorithm is able to predict or even distinguish a 'good' abandonment from a bad one.

As found in my previous study (Shih 2021), not clicking any hyperlinks in SERP or 'good abandonment' is very much a default behaviour rather than an exception in translators' web search process. Empirical data presented in the present Element firmly confirm this exact finding. This is true irrespective of translators' length of experience or whether they are professionals or students. In other words, in interacting with search engines, translators frequently choose to not to click on any hyperlinks. Referring back to Figure 6, this unique phenomenon is displayed in the long line on the left between the second judgement of relevance to the end of the diagram. In other words, unlike stereotypical search engine episodes widely reported in IR studies, when translators decide not to click on any hyperlinks, especially after they read and invest their time and visual attention to snippets, it is often an indication that they have already found the information they need satisfactorily,

or their query intents have already been fulfilled by snippets alone. Table 4 shows a typical example of this in Subject P09's web search episode.

As seen in Table 4, Subject P09 (a professional translator) chose not to click on any hyperlinks in SERP but spent her time reading snippets in detail for five different queries. She revealed later in her RTA that her query intent was mostly to locate a suitable TL equivalent for the ST terms. This was also the reason why she used a very consistent pattern of queries in Google: 'ST term, 中文, 医学' (Back translation: ST term, Chinese, Medicine). She conceded that using this query pattern normally generated many useful snippets in both English and Chinese in SERP. Therefore, she was able to take full advantage of these snippets by comparing and contrasting bilingual information and ultimately located a suitable TL equivalent. There was no need to invest her time and effort in clicking on hyperlinks at all. In other words, SERPs were used as if they were dictionary entries.

This phenomenon shows that translators' behaviour of 'query abandonment', or 'good abandonment' is incongruent with that of stereotypical web searchers. This is because unlike translators, most web searchers probably do not regularly pose bilingual queries, nor use search engines as if they were bilingual dictionaries. In other words, this type of bilingual usage of search engines is largely unique to translators. Yet, the trouble is that by not clicking on any hyperlinks repeatedly and persistently after posing queries, translators may have unknowingly put forward a message or dialogue to the computer (via search engine algorithm) that search results in SERP are unsatisfactory. In other words, a form of unintended miscommunication may have taken place between search engines and translators, partly due to a general assumption that when a searcher poses a query, a natural progression is to click on a hyperlink. It is no wonder that translators can sometimes find it difficult to locate useful information in search engines. In a wider context outside translation studies, this reveals a perennial difficulty of search engine algorithms, which is well beyond the scope of this Element; that is, it is extremely challenging for computer engineers to build a search engine (algorithm) that can cater for every single type of searchers, including translators.

In addition to 'query abandonment', over the years, a great deal of literature can be found dedicated to studying typical behaviours of search engine users. The most prominent of these is probably that most searchers typically only browse and click on the first few hyperlinks listed on the top of SERP (See Joachims et al 2007; Granka et al 2004). This is the reason why advertisements and sponsored links are always positioned near the top of SERP. This also contributes to a series of SERP designs and layout features in commercial search engines. As mentioned briefly before, there is a relatively new feature in Google called, 'knowledge box' or 'Knowledge graph' (Ceri et al 2013). 'Knowledge box' is known to be 'integrated in the search [engine] interface and provides basic information about the search topic' (Ludolph, Allam & Schulz 2016). As the name suggests, 'knowledge box' is 'framed' in a box and normally positioned at the top right corner of the SERP side by side with other high-ranking hyperlinks (to the left). Google's 'knowledge box' often directly cites topical information about a search query from a popular database, such as Wikipedia, displaying a hyperlink acknowledging information source at the bottom of the box (ibid). 'Knowledge box' is sometimes accompanied by an image from the data source as well. Different search engines have different design features and layouts in their SERPs. Figure 7 shows an alternative example in Baidu, the popular Chinese search engine.

Figure 7. A screenshot of web search for 'graft' in Baidu

In this example, the query, 'graft' is posed as a query in Baidu. Unlike Google, Baidu displays a collection of recommended e-resources (in the form of thumbnails) at the top right of the SERP that its algorithm considers to be relevant. In this example, a number of different NMTs, online dictionaries along with a few web-based resources for learning English are displayed as a result.

No doubt, all these new features and layouts in SERP in either Google or Baidu are designed to draw searchers' visual attention. For translators, while it is possible that their visual attention may well be drawn to these featured and framed results, it is also common for them to skip them altogether. In fact, empirical evidence in this Element suggests that contents being displayed especially at the top right of the SERP, such as 'knowledge box' or 'thumbnails', are often ignored by translators. The downside of this is that translators may run the risk of missing potentially vital information. The flip side of this, however, is that they can concentrate on looking for and assessing what appears to be the most important information for them at the time. To a certain extent, the fact that translators choose not to be distracted by novel layouts in SERP probably reflects their experience and knowledge of using search engines. It is also possible that this is merely a reflection of their time efficiency strategy. As

discussed in Section 2, web search typically accounts for up to a third of the entire translation process. From translators' point of view, it is vital for them not to let this process take over the whole translation process. Therefore, having a laser-sharp focus when going through a huge amount of information presented in search engines is a useful and necessary strategy.

4.3.1b Other Typical Clicking and Browsing Behaviour

Apart from this, another typical clicking and browsing behaviour of translators is a constant and rapid switching between different opened webpages and SERPs both in the pre-drafting phase and during the drafting phase. As mentioned in Section 2.3.2, Cui and Zheng (2021b: 68) identified a very similar phenomenon in their study. According to them, this phenomenon is related to the perceived difficulty of the translation task. In other words, the more difficult trainees perceive the translation task to be, the more they exhibit the rapid switching behaviour on the screen due to cognitive overload. Cui and Zheng (ibid) argue that an important pedagogical implication of this finding is that trainee translators should be trained to improve their working memory capacity, presumably to avoid the rapid switching phenomenon. It seems that the switching back and forth between different webpages and SERPs is considered to be a negative feature in web search. While this may be true for student translators in Cui and Zheng's study, evidence in this Element suggests that this is not always the case, as this phenomenon is shared by experienced professional and student translators alike. In fact, the RTA data in this Element (e.g. 'instead of waiting for a webpage to load, I go back to read other snippets') has shown that the rapid switching phenomenon can simply be a reflection of translators' time-efficiency strategy because many translators prefer to fully utilise their time by switching to other webpages or SERPs rather than staying idle to wait for a webpage to be uploaded. But, more significantly, this may also be a manifestation of translators' strategy of using opened webpages or SERP as a form of external memory to supplement their overloaded working memory. This is because when translators try to tackle a complex translation problem via web search, inevitably they are bombarded with many sources of information in various forms. It may be very difficult for them to keep hold of every single piece of information while their working memory is hard at work. By switching back and forth rapidly and repeatedly between these information sources, their visual attention (or sensory input) is able to register them temporarily or keep hold of them a little longer in their working memory so as to assist the complex decision-making process. In other words, the behaviour of rapidly going back and forth to different information sources may not be a liability nor an expression of anxiety but a strategy for translators to ease their overloaded working memory. Therefore, in my opinion, the pedagogical implication should not be so much about training and improving the capacity of translators' working memory, given that working memory will always have its maximum capacity. Instead, the pedagogical implication should be about acknowledging that there are cognitive and behavioural mechanisms that translators can learn to adopt in order to mitigate overloaded working memory in web search. Indeed, rapidly switching back and forth between different information sources represents one of the useful mitigation strategies for doing so.

4.3.2 What Determines Clicking and Browsing Behaviour

As mentioned in Section 4.3.1, the moment that translators make their decision regarding their browsing and clicking behaviour depends on the three points of judgement of relevance. Two aspects will be addressed here. They are: the concept of judgement of relevance and what sources of information translators are actually judging.

First of all, I would like to focus on translators' judgement of relevance. In search engine research, 'relevance of judgement' is a term that is used to refer to the criteria that searchers use to judge how relevant information is in SERP and in external webpages. Also known as 'credibility judgement'

(Kattenbeck & Elswiler 2019), these criteria include ranking, recency, topicality, specificity, scope, (information) quality, etc (see Savolainen & Kari 2006). In other words, searchers are judging information based on their ranking position in SERP, how recently the information is produced and whether the information presented is of high quality, etc. Incidentally, this is very similar to what translation textbooks (see Austermuhl 2014) sometimes dub part of the ‘information literacy’ or ‘instrumental competence’ that translators should possess, given that it is vital for translators to assess the reliability of any information they come across on the Web. While it is no doubt useful to know what the general criteria of judgement of relevance may be, these criteria fall short of illustrating translators’ clicking and browsing behaviour in detail. In other words, what distinguishes this Element from many previous works is that it demonstrates an intricate mechanism of judgement of relevance on a granulated level in the context of translation that is constantly adjusting and altering, pending the ad-hoc context of the preceding or subsequent queries, search results, and other clicking (non-clicking) browsing decisions, etc. Each granulated judgement and decision feeds into a subsequent and ultimately a final one. More importantly, these granulated judgement criteria are found to link to query intents directly. In other words, translators’ cognition and behaviour in search engines are determined by how relevant they judge or ‘interpret’ the information to be to fulfilling their query intent (as shown previously in Subject P17’s RTA in Table 3).

There are two factors here: the judgement of relevance and the information translators are judging. On the surface, the information that translators use to make their judgement of relevance is presumably any content or information presented to them in SERP after their query is posed or content presented in an external website/webpage once a hyperlink is clicked. In terms of the information in SERP, it can be presented in many different shapes and forms, such as ‘knowledge box’, NMT solutions, and suggested queries, etc. How and where these different types of contents are presented in SERP have been covered in Subsection 4.3.1 and will not be repeated here. Instead, further details about the list of hyperlinks and their associated information will be addressed in the following. In most commercial search engines, the list of hyperlinks in SERP comprises of the following information: the title of the hyperlink itself, URL, snippet, and occasionally an image. In addition to this, the query (term) is normally highlighted in red in Baidu or in bold in Google. Highlighting is found to be very useful for translators. This is because when translators frequently pose ST terms/segments as queries, these highlighted terms in snippets serve as ‘visual spotlights’ to guide translators’ visual attention and cognition. There is evidence in this Element to suggest that this highlighting feature becomes a design feature that helps shape translators’ information behaviour in search engines. This is shown in Figure 8 below and partially in Table 4 (presented previously) where Subject P09 is searching TL equivalents for the ST term, ‘CT scan’.

Figure 8. Subject P09’s web search for ‘CT scan’ in Google

In her RTA, Subject P09 articulates, “SERP shows lots of ‘CT’. ‘CT’ is commonly used in Chinese... I did not see 脑电图 (Back translation: EEG). I know that 脑电图 is what CT is normally called in Chinese.” Here, Subject P09’s query intent was not locating a TL equivalent for the query, ‘CT scan’, but rather to verify what she thought she knew, which was, 1) ‘CT’ does not need to be translated; 2) ‘CT scan’ stands for 脑电图 in the TL. Therefore, her judging criteria were guided by these query intents, that is, whether she could find enough information in SERP to support her existing knowledge about ‘CT scan’. Obviously, ‘CT scan’ and ‘EEG’ are two different types of medical imaging tools, and Subject P09 made the error of mixing the two in her long-term memory. This web search episode demonstrates an interesting example of what happens where the external information sought in SERP appears to contradict internal information from one’s long-term memory. After some weighing up,

Subject P09 consequently decided to translate ‘CT scan’ into 脑电图 based on her long-term memory. This resulted in a translation error.

A fascinating part of this example is that the correct TL equivalent for ‘CT scan’ was actually shown in the snippet of the 2nd hyperlink, i.e. ‘电脑断层扫描 (Back translation: Computerised Tomography Scan)’, even though it was not highlighted in red or in blue unlike the term, CT. As a result, this piece of vital information was apparently missed by Subject P09 when she visually scanned through the snippets. There are likely to be two reasons for this. Firstly, when she scanned the snippets (rather quickly), her visual attention only focused on the highlighted terms in snippets. This in itself is likely to be a result of her previous experiences of scanning the highlighted terms being sufficient for her to solve her translation problems. Query Term Highlighting (QTH) in snippets is a common feature in commercial search engines (Zhang 2018). The assumption behind this feature (based on IR research) is that highlighting will serve as a visual aid for searchers to decide which hyperlinks are worth clicking. In other words, highlighting itself is a feature that is designed to make the highlighted segments become more visually salient or ‘eye-catching’. Therefore, it is no surprise that translators’ visual attention is drawn to them. In most cases, this feature in snippets serves translators well, largely because translators often use SERP listings as dictionary entries and ST terms as queries.

Nevertheless, what this example has revealed is that sometimes it can backfire if translators are too drawn to the highlighted words rather than other information in the snippets. The truth is that in pursuing optimisation in web search, it is important to remember that efficiency should never precede effectiveness in translators’ web search, as discussed in Shih’s (2019) study. This finding also shows a possible reason behind a classic scenario which Massey & Ehrensberger-Dow (2011b) have observed in their study as the ‘looking but not seeing’ phenomenon where translators fail to notice or process the most useful information presented to them on the computer screen. The other likely reason for ignoring a correct TL equivalent in snippets in Subject P09’s case was that there was a competing TL equivalent in her long-term memory, and at this point her judgement of relevance might be searching for evidence to confirm or support her existing knowledge. This is often known as ‘confirmation bias’ (Nickerson 1998) in psychology, as most people generally prefer information that supports rather than counts against their existing views or values. In other words, at this point, her real underlying query intent was probably to bolster a TL equivalent she assumed she knew. It is as if her visual attention (as guided by her query intent) automatically ‘censored’ or ‘suppressed’ irrelevant information that did not support her existing knowledge. This again demonstrates the complexity and dynamics between query intent and judgement of relevance from external information (including the highlighting feature in SERP) and internal knowledge.

Dervin’s (1983) sense-marking theory and Kuhlthau’s (1990, 1991) affective factors in information seeking, as mentioned in Subsection 2.1, can also be used to explain this web search episode, as they denote that human beings make sense of or understand the world by constantly referring back and forth between (new) external information and (existing) internal knowledge. This understanding then becomes a basis for them to act upon. In this example, during Subject P09’s web search episode, the judgement of relevance from external information has to compete and interact with internal knowledge. While uncertainty and hesitation can be observed due to incongruence or conflicting information, clearly internal knowledge overrides the external information sought in this instance.

To sum up, the query intent and information encountered in SERP have a complex and intertwining relationship in translators’ cognition and behaviour in using search engines. Drawing back to Figure 6 as shown in Subsection 4.3.1, each of the three points of judgement represents a crossroad or juncture of what to do next. The criteria of this judgement (of relevance) are based on a momentary and sometimes evolving query intent, or in other words, how closely the information comes to fulfilling the query intent at the time. The information being judged though is not just limited to external information presented in SERP or webpages, but crucially also include translators’ own internal knowledge in the long-term memory.

Section 5. Conclusion

This Element reports an investigation of translators' web search process. It focuses on three themes: translators' use of web-based resources along with two aspects of translators' search engine behaviours, including those related to queries and those related to browsing and clicking.

With regard to the first theme (see Section 4.1), the use of web-based resources, it is found that the most frequently used web-based resources are online dictionaries and search engines, echoing similar findings in many previous studies. Unsurprisingly, Google 'tops the chart' as the most used search engine by most translators. However, unlike translators in other language combinations, Chinese translators tend to use Baidu and Google as their search engines of choice. While translators tend to use similar types of web-based resources, their actual resources used evolve over time and can occur on an ad-hoc basis. In fact, it is found that when using search engines, both student and professional translators do not just constantly assess information found in SERP, but also assess new and potentially useful web-based resources so that they can be adopted on the fly or potentially in the future. With regard to the use of NMT, just like previous studies, this Element shows that translators regularly use NMT as a web-based resource. However, this Element also discovers that the use of NMT is a lot more prevalent than previous studies may have suggested. This is because NMT outputs are often incorporated as parts of the search results in search engines and as dictionary entries in online dictionary packages. As a result, translators are using NMT solutions even without actively seeking to use them. This finding also suggests that most translators probably do not post-edit NMT output but treat them as one piece of independent information among many other pieces of information found on the Web for them to 'pick-and-mix' from.

With regard to the second theme (see Section 4.2), query-related cognition and behaviour in search engines, query types uncovered in previous studies have also been largely identified in the present Element. What is noteworthy though is that the single most employed query type is a direct adoption of ST terms/segments to the query box. In other words, most translators habitually copy and paste a ST term/segment into the search box as their query. Apart from a matter of convenience, this is likely due to the fact that modern search engines are keyword-based search engines. In the context of translation, ST terms/segments are effectively keywords for relevant information being sought. ST terms/segments also represent 'information-seeking triggers' that initiate the problem-solving and web search process in translation. Therefore, it is logical to use ST terms/segments as queries directly. While the copy-and-paste query behaviour gains in terms of 'no-fuss' convenience, it may subsequently result in lengthy and laborious processes to decipher relevant information in SERP. Translators can of course choose to strategically invest more time and effort in planning and formulating sophisticated queries so as to narrow down their search results in the hope that such efforts will pay off in the end. It is speculated that perhaps past experiences taught them that (cognitive) investment in refining queries does not always pay off or guarantee success. Therefore, most translators simply copy and paste ST terms/segments directly without much deliberation.

Unlike query types, it is difficult to exhaust a list of query intents. To reiterate, query intent is a term first used by Shih (2021: 76-77), which conceptualises moment-to-moment inference and motivation that lead to a query being posed. The concept of query intent is useful in scrutinising the complex and multi-layered interaction between queries, browsing, and clicking behaviour in web search. Part of the reasons that it is impossible to exhaust the list of query intents is that query intents are highly context-dependent, individualised and ever-evolving according to different contextual factors, such as the outcome of a previous query, incongruence between query results and existing knowledge, and even translators' own past web search experiences, etc. Each of these contextual factors can play a role in contributing to the formation of query intents and consequently dictate web search behaviour.

With regard to the third theme (see Section 4.3), translators' browsing and clicking behaviour, a model of translators' browsing and clicking behaviour is mapped out (See Figure 6), illustrating sequential patterns of translators' web search process in search engines. In this model, there are three points of judgements. Each point determines whether translators should continue to browse, click, post a new query or abandon the whole web search episode. These judgement points are largely guided by translators' query intent, in particular, how well elicited information fulfils relevant query intent. In terms of what translators are judging, it is important to point out that they are not just judging information relevance as presented in SERP, but also how such information fares against their own internal knowledge and past experiences. After all, this is how translators 'make sense' of information available to them and solve their translation problems accordingly. Occasionally, translation errors can occur as a result of direct conflicts between the elicited information in search engines and the knowledge possessed in translators' long-term memory.

One of the most interesting findings presented in this Element is probably the default behaviour that translators rarely click on hyperlinks in SERP. A variety of reasons may be at play, including time-efficiency and the 'satisficing' strategies adopted by translators. The other reason is likely to be the 'Google generation' effect, as briefly mentioned by Gough (2016). The so-called, 'Google generation' [web users] are said to 'skitter over the surface of the web rather than going deep into particular areas.' (See <https://blogs.ucl.ac.uk/digital-education/2010/02/21/what-is-the-google-generation/>)

While the non-clicking behaviour has not gone unnoticed in search engine research outside translation studies, given this phenomenon is known as 'query abandonment' or 'good abandonment', what is unique in the context of translators' web search is that this seems to be the default behaviour rather than the exception. In the wider context of HCI, this default behaviour potentially results in disjointed communication between translators (i.e. human) and search engines (i.e. computer). After all, search engines are designed to be a gateway to the Web. While it is true that translators do use search engines as steppingstones for external web-based resources, they often use them, in fact, predominantly use them as a source of information in its own right. As mentioned previously, it is well beyond the scope of this Element to gauge potential implications of this phenomenon for search engine algorithm and UI design. What this Element has successfully attained though is to contribute to the continuous endeavour in the field of human information behaviour (HIB) in understanding the highly complex and context-dependent information behaviour of translators.

Within the field of translation studies, this Element has two main contributions to make. The first one is that it is one of the first studies to embark on a systematic investigation of translators' use of search engines. It focuses on translators' queries, browsing and clicking behaviour within search engines. Future research directions could 'hone in' on translators' web search behaviour that derives from but occurs outside search engines and how such behaviour may impact translation activities as a whole. Translators working in different contexts, genres, modes and language combinations could also be investigated individually and comparatively. In addition, it will be interesting for future researchers to ascertain in what ways or which parts of translators' web search behaviour are specific or unique to translators rather than other types of web users. The second significant contribution of this Element lies in its qualitative approach to eye tracking research. This Element is unique in the sense that to the best of my knowledge, it is one of the first pieces of research in translation studies that challenges the status quo and demonstrates that a qualitative eye tracking methodology is not only feasible but also effective in answering research questions that a quantitative eye tracking approach cannot address. I believe that two decades after O'Brien first introduced eye tracking into translation studies, there is room for an alternative and equally valid approach to eye tracking research in our field.

We live in an era of increasing dominance and reliance on the Web and web-based technology. There is no exception for translators. Almost every aspect of translators' work is bound to be framed and affected by the wider digital landscape. There is still so much unknown to be learned and discovered.

In many ways, I hope that this Element serves as a beginning, not an end to a quest of continuous learning and discovery about translators and the Web.

ⁱ While CRITT methodology is originally known to be quantitative and statistical, it is important to point out that over time such research orientation can change when the amount of hypothesis-testing data reach a stage of 'saturation'. As shown in Carl and Schaeffer's (2008) study, by integrating enough amount of data in different language combinations and studies, multiple hypotheses can then be generated using a grounded theory method. Hence, a quantitative research paradigm is 'metamorphosised' into a qualitative one.
