



## Fuzzy Set Qualitative Comparative Analysis fsQCA

- QCA identifies configurations that lead to a positive outcome
- ... and fail to produce a negative one
- Complex configurations of causes
- Several paths to an outcome (equifinality)
- Fuzzy set membership:
- A case can satisfy each condition fully, partly or not at all



## AERP emergence in Central and Eastern Europe

- Breakthroughs in 'third generation' elections 1999-2012
- Unit of analysis: individual elections
- Outcome: AERP breakthrough BREAKTHRU:
- Fully in: 30% of votes
- Crossover: 7%



#### **Five causal conditions**

- Increasing unemployment in previous 2 yrs INCUNEMP
  -2.5% / +2.5 / +5.0
- Economic contraction over previous year NOGRO +5% / 0% / -5%
- High perceived level of corruption HICORR
  5.5 / 4.6 / 3.5
- Substantial increase in perceived corruption INCCORR +0.4 / 0 / +0.4
- Successful new parties in recent election HNEWP
  0 / 19 / 30



#### Conclusions

- AERPs more than residual category of hard-tolabel protest parties
- Broad mono-causal explanations (austerity, democratic strain, corruption) for rise of new anti-establishment parties misconceived
- Debate must be reframed in terms of combinations of conditions relating to:
- corruption, economics and party system dynamics



#### **Some counter-intuitive findings**

- AERPs break through more often in good than bad economic times
- Party system stability more favourable for breakthrough than party system fluidity;
- Changes in perceived corruption often matter more than levels of corruption
