# 1 Introduction

The British National (Overseas) visa, or BN(O) visa, is a special visa route introduced by the United Kingdom government to provide a pathway to British citizenship for eligible Hong Kong residents. The visa scheme allows BN(O) visa holders to live, work, and study in the UK for up to five years. After the five-year period, visa holders can then apply for settlement, and subsequently, for British citizenship after living in the UK for an additional year. To be eligible, applicants must hold British National (Overseas) status, which was granted to those who were citizens of Hong Kong during the time when Hong Kong was a colony of the UK before the handover to China in 1997 or be the child of someone with BN(O) status born on or after 1 July 1997. Hong Kongers can also apply for the BN(O) visa as a dependant, if they are spouse, child or dependent of a BN(O) status holder.

This visa route was introduced on 31 January 2021. By the end of March 2023, the BN(O) scheme had received 172,500 applications, resulting in 113,500 individuals relocating to the United Kingdom, alongside an additional 27,276 BN(O) visas granted to individuals already in the country. This significant influx of BN(O) migrants constitutes one of the largest single-country migration waves in UK history and is poised to have substantial social, economic, and potentially political impacts.

A research team from University College London (UCL), King's College London (KCL), and the University of Oxford has secured funding from the Economic and Social Research Council (ESRC) to design and implement a three-year, three-wave panel survey of Hong Kong BN(O) migrants living in the UK. The objectives of the study are: (a) to assess the social and economic integration of BN(O) migrants in the United Kingdom, and (b) to compare the experiences and needs of BN(O) migrants with other migrant groups and UK-born individuals.

In wave 1, the research team, in collaboration with the Home Office (HO), agreed on a sampling strategy involving the HO sending invitation emails to selected BN(O) visa-holders. These emails specifically targeted primary BN(O) visa holders, asking them to complete an online survey. Once their survey is completed, there was an option to invite their household members aged 16 or over to also participate in the survey. All respondents who completed the survey in wave 1 and agreed to be recontacted were invited to wave 2.

Ipsos was commissioned to conduct the survey on behalf of the research team from UCL, KCL, and the University of Oxford. The fieldwork adopted a mixed-mode approach. All participants were invited to complete a Computer Assisted Web Interview (CAWI). However, if preferred, a Computer Assisted Telephone Interviewing (CATI) option was also made available. The wave 2 survey took around 25 minutes to complete online and was available in English and Chinese. Once the survey was completed, respondents received a £20 voucher.

This technical report will provide an overview of the year 2 fieldwork of the Hong Kong BN(O) survey. For details on the initial wave of the survey, please read the Wave 1 technical report [here](#).

## 1.1 Aims of the study

This research project aims to facilitate the formulation and development of policies and services that support the integration of BN(O) migrants into British society.

The key aims of the study included:

- How are BN(O) migrants faring in the UK with regard to their social and economic well-being?

- What are the specific needs and experiences of BN(O) migrants?
- How do the experiences and needs of BN(O) migrants compare with those of other migrant groups or minority ethnic populations in the UK?
- What are the long-term intentions of BN(O) migrants regarding their residency in the UK or potential return to Hong Kong?

## 1.2 Introduction to the Wave 2 survey

In wave 1, 2,172 respondents completed the survey. Of those, 1,733 agreed to be recontacted and provided an email address, subsequently being invited to participate in wave 2. All of these 1,733 respondents were invited to participate in the online survey via an individual link provided in an invitation e-mail sent by Ipsos. Respondents were also provided with the option to reach out to the Ipsos helpline team if they preferred to complete the interview over the telephone. The survey, available in both English and Traditional Chinese, took approximately 25 minutes to complete online, with a longer duration if conducted over the phone.

## 1.3 Study timing overview

Wave 2 fieldwork started on 16<sup>th</sup> June 2025 and ended on 25<sup>th</sup> July 2025. Below is the overall project timeline.

## 2 Sampling

### 2.1 Initial wave 1 sample

To gain access to a sample of British National (Overseas) visa holders in wave 1, the research team liaised with the HO during the project's planning phase. The HO agreed to assist in pulling of a total sample of 10,000 main BN(O) visa applicants. These participants are referred to as main respondents in wave 1.

This main respondent sample was derived from a HO database containing email addresses of main BN(O) visa applicants, not those of dependent applicants. A simple random sampling methodology was employed, ensuring each eligible individual within the sampling frame had a known, non-zero probability of selection. Email addresses associated with six or more applications were excluded prior to selection, as these were likely to belong to legal representatives acting for multiple clients.

In addition to the main respondents, the wave 1 sample also consisted of other adults (aged 16 years and older) whom the main respondents lived with, regardless of their visa status or relationship to the main respondent. These participants are referred as secondary respondents in wave 1. During the wave 1 survey, the main respondent was asked to provide contact details for their household members so that a new invitation can be sent to those eligible secondary respondents.

### 2.2 Wave 2 Sample

Wave 2 sample consists of everyone who consented to be recontacted in wave 1, with the following exception:

1. Those who appeared to have completed the survey as both a secondary respondent and a main respondent. There are three duplications and only their records as secondary respondent were kept.
2. Those without email address was removed

Out of the 1,737 cases that agreed to be recontacted in wave 1, three were removed due to duplication, and one respondent was removed because they did not have an email address.

One wave 1 respondent was later added to the sample after contacting the helpline to express their interest in participating in wave 2, despite not providing recontact consent initially, resulting in 1,734 participants being invited.

## 3 Questionnaire design and implementation

### 3.1 Questionnaire development

The majority of the questions were adapted, where appropriate, from the Understanding Society<sup>1</sup> questionnaires, with a small number sourced from the UK Humanitarian Response Insight Survey<sup>2</sup>. Understanding Society is a valuable resource for researchers, offering a library of questions across a wide range of social and economic topics. Its longitudinal study design allows for analysis of changes in respondents lives and circumstances. Some new questions were also developed to capture specific circumstances of BN(O) respondents and these questions are identified within the questionnaire.

There are slight differences between the wave 1 and wave 2 questionnaires. These differences were mainly introduced to allow for tracking of household, education, and employment changes.

### 3.2 Questionnaire content

The following table provides a summary of the questionnaire's content. The full wave 2 questionnaire can be found in Appendix 7.1.



### 3.3 Questionnaire translation

To ensure accessibility of the project, the questionnaire was made available in Traditional Chinese. Initially, the questionnaire was developed and scripted in English and subsequently translated into Traditional Chinese by the Ipsos translations team. The translated script was reviewed multiple times by the research team and client team to ensure precision and accuracy

Once the participants clicked on the survey link, they could select whether they would like to complete the survey English or Traditional Chinese.

The majority of participants (71%) completed the online questionnaire in Traditional Chinese.

### 3.4 Questionnaire length

The calculation of the online questionnaire length excluded participants who didn't complete the survey in one sitting, resulting in a total of 831 respondents. Overall, the average time taken for online questionnaire was 25.29 minutes, and the median is 23 minutes.

The table below shows the questionnaire length split by language.

One respondent completed the survey on the phone with an interviewer. The interview was completed in two parts and is estimated to 68.82 minutes long.

# 4 Fieldwork

## 4.1 Overview

The fieldwork was primarily online. All participants were invited by an email to complete a Computer Assisted Web Interview (CAWI) from Ipsos. A telephone interview option was also available via the Ipsos helpline.


## 4.2 Ethics

Ipsos adheres to the Market Research Society code of conduct and is General Data Protection Regulation (GDPR) compliant. Ethical approval for wave 2 was provided on 3<sup>rd</sup> April 2025 by the University College London Institute of Education.

## 4.3 Consent

Electronic consent was obtained by participants selecting that they agreed to participate in the survey. Participants completing the survey via telephone provided verbal consent. The first screen of the survey reminded participants that the study is being carried out by Ipsos on behalf of UCL, KCL, and the University of Oxford. Participants were also reminded of the study's purpose. To proceed with the survey, participants had to confirm their consent and verify that they were older than 16 years. This information was read out during telephone interviews, requiring verbal consent from the participants for the interviewer to continue



## 4.4 Accessibility

Ipsos also ensured adherence to all accessibility criteria. Respondents could access the accessibility format by clicking on the green icon displayed on the webpage as per the figure below.

## 4.5 Interviewer briefing

The English telephone interviewer briefing and the Cantonese telephone interviewer briefing were both completed on 4<sup>th</sup> July 2025. A PowerPoint training deck consisting of the following topics were prepared for the interviewers:

- Introduction to the Hong Kong BN(O) Migrants Panel Survey
- Survey processes, reminder strategy and sample management
- Data collection – script/questionnaire overview
- Additional information and important contact information
- Wrap up and questions

The briefing took 30 minutes to complete. All interviewers were requested to complete some test interviews before they were allowed to call any respondents.

## 4.6 Prenotification email

Before the wave 2 fieldwork started, a prenotification email containing research findings from wave 1 and information about the upcoming wave 2 was sent to all wave 2 respondents. This was sent on 27<sup>th</sup> May 2025.

## 4.7 Email invitation

The first invitations were distributed on 16<sup>th</sup> June 2025 to a sample of 1,733<sup>3</sup> participants via email. The content was available in both English and Traditional Chinese.

The invitation to respondents consisted of the following information:

- The names of the various institutions involved in the study
- An overview of the study
- The purpose of the study
- How to participate
- The individualised survey link
- Incentive information
- Why are we contacting them
- Contact information for the study team
- Confirmation that their participation in the survey is voluntary and that their decision to whether to participate or not will not influence on their current or future immigration status, nor that of their dependents.

## 4.8 Reminder strategy


The reminder strategy followed this sequence: an initial email reminder, followed by an SMS reminder, and then another email reminder. SMS reminders were only sent to those with a phone number. Subsequently, we initiated a telephone follow-up period during which individuals with phone numbers were called and encouraged to complete the survey online. If requested, respondents could complete the survey over the phone. More about the telephone reminder strategy will be mentioned in the next section. We also sent 2 additional email reminders to those without a phone number on record.

All email or SMS reminders included a unique survey link or a unique password to access the survey, information regarding the £20 incentive, and a link to the survey webpage for further details. For more information on the response rate after each reminder was sent, please refer to chapter 5. Copies of the materials used are available in the appendix.

### 4.9 Telephone reminder strategy

During the telephone reminder period from 7<sup>th</sup> July 2025 to 25<sup>th</sup> July 2025, up to two reminder phone calls were executed. During each reminder, telephone interviewers encouraged each respondent to complete the survey online by providing the survey link and their unique password. If requested by the respondent, the interviewer could also complete the survey with the respondent over the phone.

If the survey remained incomplete a week after the first reminder call, a second reminder call was made. For each reminder, interviewers made up to seven attempts per respondent at varied times of the day,

including weekends, to maximize the likelihood of making contact and achieving a successful call attempt. A successful call attempt was defined as reaching the respondent to complete the reminder.

Initially, reminders were conducted in English. However, if it was identified during the call that the respondent required communication in Cantonese, the reminder was then managed by a Cantonese-speaking interviewer. Respondents with Chinese names were directly engaged by Chinese-speaking interviewers to ensure effective communication.

#### **4.10 Thank you letter and incentives**

Upon completion of the survey, all participants received an email expressing gratitude for their participation. The emails included instructions for redeeming the £20 incentive voucher, which could be selected from a range of retailers. Contact details for Ipsos and UCL were also provided for any queries or concerns, and respondents were encouraged to notify Ipsos of any changes to their contact information. Consistent with other study materials, the thank you emails were available in both English and Traditional Chinese.

#### **4.11 Queries and complaints**

Throughout the fieldwork period, Ipsos and UCL received a variety of comments and queries from participants. While most communication was in English, some participants submitted queries in Traditional Chinese or provided voice messages in Cantonese. Common themes included requests for general study information, incentive-related queries, and requests to opt out of the study. All comments and queries, including those forwarded by UCL, were addressed and responded to by Ipsos.

## 5 Response rates

1,734 respondents were invited to participate in the wave 2 survey. In total, 1,138 (65.6%) respondents fully completed the survey. In the context of this report, a full complete refers to respondents who have fully engaged with the survey, answering all relevant questions and submitted their responses. Partial completes refer to respondents who started the survey but did not complete or submitted their responses.

This table below provides a breakdown of the response rates.

Table 5.2 provides an overview of survey response rates following the initial invitation and subsequent reminders. A total of 1,734 respondents were initially invited, which resulted in 389 completed surveys, reflecting a 22.4% response rate. The first email reminder, sent to 1,336 individuals, added another 244 completions, achieving an 18.3% response rate. The second reminder was sent via text to 452 individuals and resulted in 100 completes. Following this, the third email reminder contacted 972 respondents, resulting in 146 completed surveys, representing a 15% completion rate. Next, a fourth email reminder was sent to 516 participants and achieved a response rate of 19.6% from 101 completions. The final email reminder was sent to 397 individuals, resulting in 67 completed surveys with a 16.9% response rate. During the telephone reminder phase, call attempts were made to 290 respondents, 91 surveys were completed during this follow-up period.

# 6 Data preparation and delivery

## 6.1 Instrument quality

The survey instrument was programmed in IBM SPSS Data Collection (also known as Dimensions) V7 data collection software. The Computer-Assisted Web Interviewing (CAWI) script enabled a series of checks to be in-built into the questionnaire instrument, controlling the order, appearance and routing presented to the participant, including enforcing questionnaire requirements such as single or multicode options.

Routing specifications also allow for various checks to be implemented throughout the instrument to enhance the quality of the data collected. These specific checks were employed to identify inconsistencies in recorded dates for related events and enforcing formatting rules when collecting contact information.

These rules and checks were used in conjunction with on-screen guidance and access to help screens, aiming to optimise data quality during the data collection phase and minimising the need for manual editing during the subsequent data processing and analysis stages.

## 6.2 Data checks

Ipsos undertook extensive checks on the data. The types of checks undertaken were to ensure that the questionnaire was functioning correctly and to identify any potential issues that were not detected during the testing phase of the scripts. These checks included the following:

1. Routing checks which confirmed that the specific routing was reflected in the data.
2. Data breakoffs were reviewed to identify any patterns of participants discontinuing the survey at specific questions.

The checks revealed an error in the 'jobhours' and 'reasend' questions. These questions should have applied to individuals with 'currjob = 2,' but they were not shown to the respondents meeting these criteria. This affected one respondent, who is now coded as -9 in the dataset, representing "Missing by error or implausible," for these two questions.

## 6.3 Verbatims translation

Participants could complete the survey in either English or Traditional Chinese. Verbatim text in Traditional Chinese was translated by the Ipsos translation team before being coded with the English responses.

## 6.4 'Other specify' coding

Coding is the process of analysing the content of each response based on a system where unique summary 'codes' are applied to specific words or phrases contained in the text of the response. The application of these summary codes and sub-codes to the content of the responses allows systematic analysis of the data. Coding was completed by Ipsos for 'other specify' answers. The answers would be back coded into the existing codes, if it a repeated question from wave 1, it would be coded back to the code frame used in wave 1.

Ipsos used a web-based system called Ascribe to manage the coding of all the text in the responses. Ascribe is a system which has been used on numerous large-scale consultation projects. Responses were uploaded into the Ascribe system, where members of the Ipsos coding team worked systematically through

them and back-coding responses to existing codes in the question. After this, the coded data was appended to the datasets. The final dataset includes a set of variables of the coded data (VAR\_coded) and then a merged variables (VAR\_merged) combining the original and coded variables.

## 6.5 Standard Occupation Coding

The Standard Occupation Coding (SOC) was conducted by Ipsos's coders to assign SOC 2020 and SOC 2010 codes for the respondent's current job (if applicable). Information about their jobs was collected by asking the respondent for their job title, a description of their main responsibility and the industry of the job.

## 6.6 Data outputs

Survey responses are separated into the following data files:

1. Individual dataset: This includes data collected about individual respondents.
2. Household level dataset: This includes data collected from the respondents about each household.
3. Household loop dataset: This includes data collected from the respondents about each household members. The dataset is in a hierarchical format where each row represents one household member. This includes household members that we collected from wave 1 or any new household members this wave.

The names of all variables in this wave start with 'b\_' indicating that this is the data collected during the second wave of the study.

This should help them find suitable employment in Britain. In wave 2 and wave 3 of the Panel Survey, we hope to find out if their employment situation improves over time.

## Who we share your personal data with

Your personal data will be collected and processed primarily by the research team of the HKBN(O) Migrants Panel Survey project. We will share your personal data with the parties set out below for the purposes outlined in section 4: We have partnered with **Ipsos UK**, a survey agency, to assist in the data collection phase of this project. Access to your personal data is strictly limited to personnel within Ipsos who require this information to carry out their roles in the execution of the survey.

The data collected will also be accessible to **members of the project's research team**, which includes academics from King's College London and the University of Oxford. Similar to our arrangement with Ipsos, only team members who need to work directly with the data for research purposes will have access.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third party service providers to use your personal data for their own purposes – we only permit them to process your personal data for specified purposes and in accordance with our instructions. Access to your personal information is limited to individuals who have a legitimate need to see it for the purpose of carrying out their job.

## How long will Ipsos retain your personal data and identifiable responses?

If you withdraw from the study, any data already collected will continue to be used unless you explicitly request that we delete it using the details at the end of this privacy notice. If you request that we delete any personal identifiable information (such as name and contact details), we will delete the data you have provided to us. If you also wish to have your anonymised survey data and all data about you deleted, please make this request within 6 months of taking part in the survey. After that date it will not be possible to remove your anonymised data from the study.

Ipsos will only retain your data in a way that can identify you for as long as is necessary to support the research project and findings. In practice, this means that once Ipsos has satisfactorily reported the research findings to their research partners, Ipsos will securely delete your personal, identifying data from their systems. For this survey, Ipsos will securely delete your personal data from their systems by 31st January 2027.

## Lawful basis for processing

## International transfers

We do not transfer your personal data outside the UK or the European Economic Area (**EEA**).

## Information security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. We have established procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

## Data retention

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

We will keep your personal data according to the [Records Retention Schedule](#).

## Your individual information rights
