

(54) Title: 2-[3H-THIAZOL-2-YLIDINEMETHYL]PYRIDINES AND RELATED COMPOUNDS AND THEIR USE



(57) **Abstract:** The present invention pertains to certain 2-[3H-thiazol-2-ylidinemethyl]pyridine compounds and analogs thereof, which, *inter alia*, inhibit cell proliferation, treat cancer, etc., and more specifically to compounds of the following formula, wherein R^{A1}, R^{A2}, R^{A3}, R^{A4}, R^{B1}, R^{B2}, RNA, RNB, and X- are as defined herein. The present invention also pertains to pharmaceutical compositions comprising such compounds, and the use of such compounds and compositions, both *in vitro* and *in vivo*, to inhibit cell proliferation, and in the treatment of proliferative conditions such as cancer, etc.
